

Beautifully situated with the ocean in the rear of the property and the mountains in front.


Mokuleia Youth Center

Dreams do come true and prayers are answered! For many months the Bishop and young people of the Diocese have hoped and prayed that they might find an appropriate place for a Youth Center and Conference grounds. Every spot on the Island of Oahu had been combed—many with wistful eye and wishful thinking. Just as one place was to be considered for purchase by the Board of Directors, the Mokuleia property, the former McInerny beach home, and used during the war as a recreation center by the army, Was placed on sale. The Church has been able to secure this property for our Conference Center, and it will be ideal for our young people, clergy and organizations. The property includes two and one-half acres on Mokuleia Beach. It has five buildings in a grove of ironwood trees—a main house, the old McInerny home, a guest cottage, a two-car garage and a servant's house and Chapel building. To increase dormitory space an army building will be added.

On July 13th over two hundred Episcopal young people on Oahu attended a picnic at the newly purchased Youth Center. Two charterd buses, plus cars and trucks, took young people from Honolulu to the Center.

The day began with a celebration of the Holy Communion under the pine trees, with Bishop Kennedy as celebrant. After breakfast the young people spent part of the morning clearing and sweeping the sand from the outdoor dancing pavilion and burning leaves. Fences were also repaired. The rest of the day was spent in volleyball, football, ping-pong games, dancing and swimming.



OAHU YOUTH CONFERENCE

A Holy Communion service with the Bish-^{(p} as Celebrant. Over ^{two} hundred young people were in at-^{tendance} at this serv-^{ice} on July 14th. Many of our churches have begun to make reservations for the use of the Center, and we hope that all congregations will feel free to do so. On August 9th the young people of Holy Trinity Church invited the young men and women twenty years of age and older to gather for a picnic and formation of an older young people's group. Mr. Floyd Uchima was in charge of arrangements. About fifty were in attendance. On August 23rd and 24th the Oahu Young People's officers of the various churches met for an outing, and on August 29th through September 1st, the Rev. and Mrs. Edmund L. Souder and St. Mark's young people had an outing.

We are extremely eager to form a Board of Managers for the Camp, so that specific rules can be made for the use of the place, and have asked the clergy to appoint a member for this Board from each congregation on Oahu.

Any volunteer workers who are talented with a paint brush or hammer and saw would be most welcome to help with repairs and additions to the property.

We have no intention of running the place as a money making proposition, but know that certain expenses will be involved in the upkeep of the place, so we shall be compelled to make certain charges for the use of it.


We feel a deep sense of gratitude for the interest and help given us by the young people on our Islands, for they have contributed \$2000 toward the purchase of the property, plus \$1500 toward an ice box, deep freeze, stove, and kitchen equipment. Other gifts have been made by Iolani School, \$2000; Cluett House, \$2000, and Hawaiian Congregation, \$1000. St. Andrew's Priory expects to give \$2000 toward this project and two of our congregations have signified their intention of giving \$1000 or more toward it.

To the young people of the Church of our country, we add our profound thanks, for they will be united in their effort to stand behind this Center when they take their United Youth Offering on October 19th. If only we could express the great feeling of appreciation we have for this interest, but words cannot formulate what is within the hearts of our youth! We do hope everyone who shares in this will know what it means to the youth and the work of our Church in the Islands.

We sincerely hope that people who can make voluntary contributions toward this project will do so through the Bishop's Office.

NOTE OF APPRECIATION

Irdination to the (); iaconate

An impressive service was that held June 30th in St. Andrew's Cathedral, at which time the Rev. High Leonard Somerville Thompson was ordained to the Diaconate by Bishop Kennedy. The Reverend Sydey H. Croft was Presentor and the Litany for Ordinatons was read by The Rev. Wai On Shim. The Ordinaton Sermon was preached by The Rev. Kenneth A. Hay, excerpts of which follow:

"Upon the occasion of the Ordering of Deawns, the Church directs that there shall be a Sermon and that that Sermon declare:

- 1. The Duty and Office of such as come to be admitted Deacons.
- 2. How necessary that Order is to the Church of Christ.
- 3. And how the people ought to esteem them in their office.

Christianity is a historical religion, and its claim to be a historical religion is not the claim that it emerged in history, but that its **God** emerged in the continuism of history, by doing something in history which uniquely revealed Him. Christianity is not the stuff of ideas, it is of the stuff of history, therefore definiteness and detail are of its very nature.

It was natural then that our Lord should have provided an organism and organization which would ensure the continuance of Christianity in the continuism of history, and that definiteness and detail should be of its very nature. . . . It will be as definite and detailed as the God-filled crib and the God-empty tomb.




TWO NEW MEMBERS ADDED TO DIOCESAN FAMILY


ORGAN MEMORIAL FUND GROWS

Sherrill, D.D., with his family, will occupy a smaller house which is a part of the estate. The place belonged to Herbert L. Satterlee. Present plans provide for holding meetings and conferences of various Church organizations and agencies at the Center, and for the entertainment of missionaries and others who will come to confer with the Presiding Bishop. The house is named in memory of the first American Bishop of the Episcopal Church who was Bishop of Connecticut from 1784 to 1796.


Mrs. Y San Mark Called By Death

The entire Diocese has been shocked and saddened by the sudden death of Mrs. Y. Sang Mark, wife of the Rev. Y. Sang Mark, rector of St. Peter's Church, Honolulu, and sister of the Rev. Wai On Shim, rector of St. Elizabeth's Church, Honolulu. She passed away in Queen's Hospital on August 27th, at 8:15 p. m., having suffered a heart attack.

Quiet and unassuming in all that she did, but źealous in her loyalty to her Church, Mrs. Mark was beloved by all as she went about her duties. Coming as she did from a great Church family, daughter of the late Rev. Shim Yin Chin, of St. John's Church, Kula, Maui, and Mrs. Shim, her early childhood was nurtured in Christian training... She came to Hawaii in 1914 with her parents. After her father's death, her mother carried on the work at the mission at Kula.

In addition to her husband, brother, and mother, she is survived by her sister, Mrs. Flora Shim Chang, a great Church worker in St. Peter's Parish, a daughter, Anna, and son Philip.

The sympathy of the entire Diocese is extended to the family of Mrs. Mark. She leaves a profound gap in the Diocesan Family, and we shall miss her greatly.

Dr. Wassell To Head Molokii Hospital Staff

Another chapter is to be added to "The Life o' Dr. Wassell" for Dr. Corydon Wassell, the American raval hero who defied red tape to evacuate wounded service men from Java early in the war, is getting ready to return to the Pacific as a missionary.

He and Mrs. Wassell plan to sail for Honolulu from Los Angeles October 18 on the Matsonia en route to Molokai where he will serve indefinitely without pay as superintendent of the 32-bed Episcopal hospital, the Shingle Memorial Hospital.

Mrs. Wassell, a registered nurse, will be on the hospital staff.

The famed doctor wrote to Bishop Kennedy offering his services, and Bishop Kennedy gave the appointment.

Dr. Wassell attained fame when the late President Roosevelt told the story of his heroic rescue of wounded from the Cruisers Houston and Marblehead off Javain 1942.

During the Java campaign, Dr. Wassell remained behind in the path of advancing Japs to care for ¹² seriously wounded men, whom he later evacuated ^{to} safety.

Dr. Wassell, a former doctor-missionary to China, holds the Navy Cross for his heroism.

The parish hall had been converted into living quarters until the rectory was completed, and will now be used for parish work and a kindergarten school to be started by the Rev. Mr. Linscott. The work at Kealakekua is showing marked gains of late and we rejoice that the parish hall can be used for such important work.

The interior of St. John's rectory, Eleele, Kauai, has been repainted and the front porch enlarged and screened.

A Quonset hut has been purchased by St. Mark's Church, to be used for their parish and school work, which is growing in rapid strides under the direction the the Rev. Edmund L. Souder.

The Reverend and Mrs. Sydney H. Croft are happy in the rapid strides being made in the building of their new rectory. It will be completed before long and they will move into their new home.

So you find in Chrisi's Church a definite and detailed organization of Bishops, Priests, and Deacons, an unbroken chain in the continuism of history, technically called an Apostolic succession, whose farend does not hang locse in history, but is linked to the Author of Life through Jesus Christ.

We esteem the Order of the Church because we first esteem the Divine Crder of God in His Incarnation in history. Honoring Him, we honor it. Honoring it, we honor Him.

Hugh Leonard Somerville:

You are older and more mature than is the general rule of those seeking Orders as Deacons, but that does not give you immunity from being spoken to as a Deacon. Other vocations have beckoned you, but when they had their say, and had received your careful consideration, you heard, and with increasing clearness the call of Christ to the Ministry of His Church. You gave heed to this Call. It meant years of study and of discipline, and it demanded faith and fortitude and determination. You have completed that study, and now at last to your "vocation" is to be added "mission". And you who have been "called" are now to be "sent."

Before we can accept it, there must be added authority to your inward call. So your vocation is now to be sealed unto you by the Church, stamped with her indelible order, authenticated, approved and made official in the face of all men, for their recognition and for the glory and service of God. Your ministerial vocation is to be given ministerial Authority, and after years of waiting, you will receive your reward.

Ycu will have an honored place in society. Your words will receive respectful attention. Your opinion will be sought, even by those wiser than yourself. You will be offered opportunities for leadership, when perhaps there are others standing by, more capable of leading. But it was not for such rewards you were called, nor was it for such rewards that you gave heed to the call, and certainly it is not for any such rewards the Church will commission you. No, you were called and are to be commisioned , to be a servant. That is the great reward. That, and no other. That, and no more. But that reward drew from our Lord's lips the only boast that ever passed them, "The Son of Man came not to be ministered unto, but to minister. I am among you as one that serveth."

The Diaconate is not so much a stepping stone to the Priesthood, as the threshold of wonderful fields of labor. Do not step into it, only to step out of it. Profit by your stay in it. Your security from becoming slack, smug, self-satisfied, self-opinionated, self-assertive, lies in never looking to the world or to man for standards or judgments, but to Christ alone and upon being thoroughly at home upon your knees. You are here to take life-orders from Christ, and from Him alone. You will not find Him $e_{sy.}$ "Whoseever taketh not up his cross, and follow_{th} where I lead, is not worthy of me."

Square your shoulders, then, to receive the stol $_{\text{of}}$ the Church, which is the symbol of the yok $_{\text{of}}$ service.

May God abundantly bless you, and $abundantly_{USE}$ you to His Glory and that of His Holy Churq_for the salvation of men, and the increase of His Kingdom.
