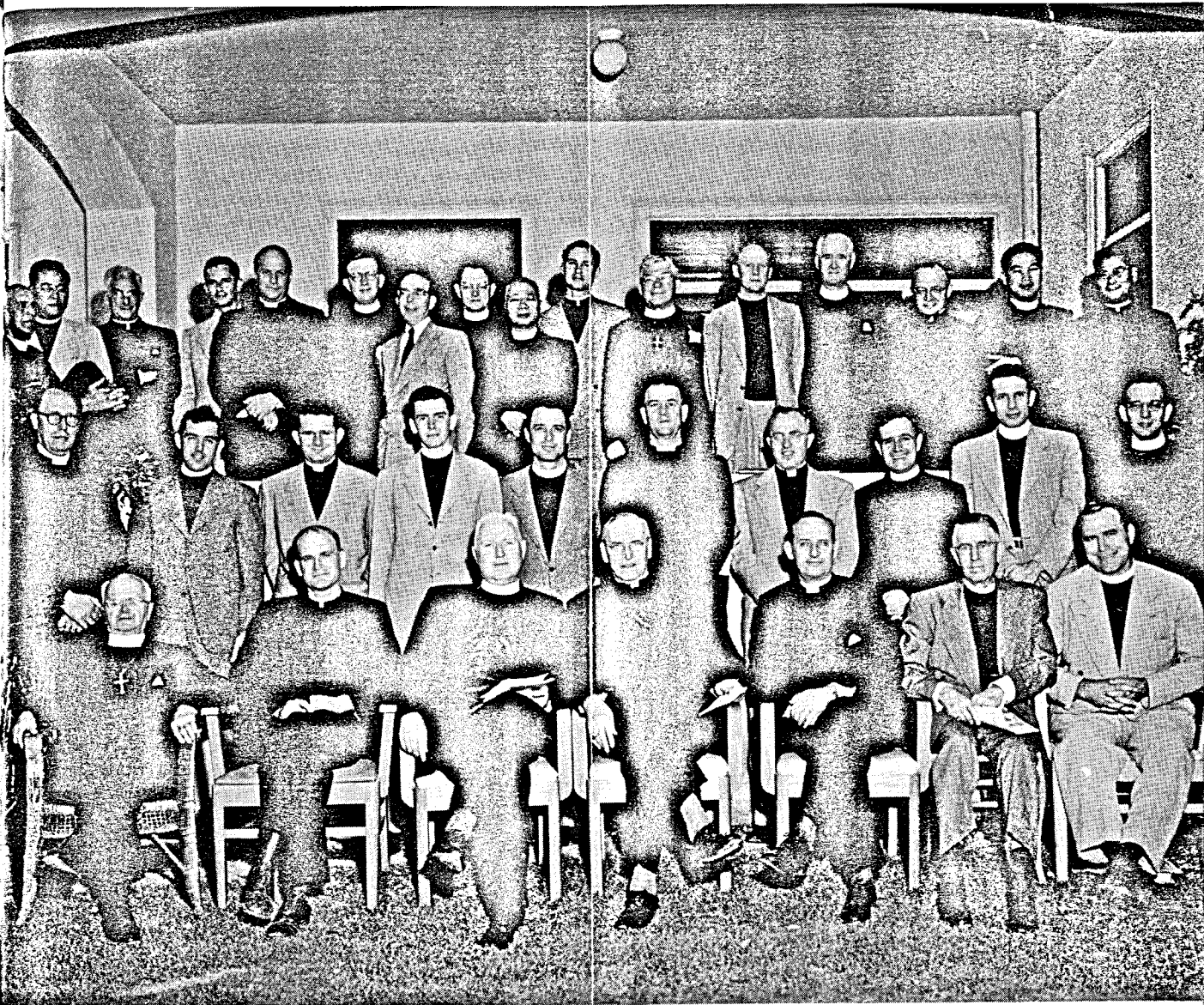

Opening Service

With a hundred percent attendance of the clergy and a larger attendance than ever of delegates to the Convocation, held April 1st, in St. Andrew's Cathedral, at 7:30 p.m., the opening service was most impressive. All the choirs of the Oahu churches, lay readers, clergy and bishops were in the colorful procession of the service. The Bishop gave his Annual Address, emphasizing the changes in the diocese, the growth in work, the building programs that confront us, and the gifts of importance that have come to us during the year. He announced that the Rev. Harold Willmot Smith, after fifteen years of service in this Missionary District, will return to England with his family on May 1st to begin work in his native land. The Bishop also announced that the Rev. Y. Sang Mark, rector of St. Peter's Parish, would be given a leave of absence from his Church until his retirement in April, 1952, his vestry having given him a well-earned vacation before his retirement. The Bishop appointed the Rev. Paul R. Savanack, Headmaster of the Hawaii Episcopal Academy, Kamuela, Hawaii, Archdeacon of the Island of Hawaii. The reports of the departments of Bishop and Council were made by the following: Christian Education — The Rev. John P. Moulton, Field and Publicity — the Rev. Frederick A.

McDonald, Missions and Church Extension — the Ven. Norman R. Alter, Forward in Service — Youth, the Rev. Richard M. Trelease, Jr. and Laymen, Mr. Richard C. Ching.

A cable of greetings from the Rev. Norman B. Godfrey and the Rev. William C. Heffner, our missionaries in Okinawa, was read at this opening service.

Following the service a reception honoring the Rt. Rev. and Mrs. Clinton S. Quin, of the Diocese of Texas, and our guests of honor for Convocation, was held in the Diocesan House. This was in charge of the Woman's Auxiliary of St. Elizabeth's Parish.

The Business of Convocation

Delegates to the Convocation began their annual meeting with a service of Holy Communion at 8:00 a.m., in St. Andrew's Cathedral, with the Bishop as celebrant, and the Rev. Edmund L. Souder, the Rev. Burton L. Linscott, and the Ven. Paul R. Savanack as assistants. Following the service members of the Convocation breakfasted at the parish hall of St. Peter's Parish, the breakfast prepared by the women of the parish.

The Rev. Wai On Shim, St. Elizabeth's Church, Honolulu, was elected Secretary of Convocation and the

Ven. Paul R. Savanack, Archdeacon of Hawaii, was elected Assistant Secretary.

Among the resolutions presented was one that the Rt. Rev. Henry Knox Sherrill, D.D., Presiding Bishop of the Church, be invited to the Convocation in 1952, to help us fittingly observe the 90th Anniversary of the coming of the Anglican Church to Hawaii and the 50th Anniversary of our being under the jurisdiction of the Protestant Episcopal Church in America as the Missionary District of Honolulu.

Mr. Joseph Reed was elected treasurer of the Diocese, Mr. Arthur Smith, Chancellor, Mr. James Tabor, Vice-Chancellor, and Mr. William Soper, Registrar. Members of the Board of Directors for 1952 are: Mr. Herman V. von Holt, Mr. Arthur G. Smith, Mr. Desmond Stanley, Mr. George Gray, Mr. Herbert Keppeler, the Rev. Frederick A. McDonald, and the Rev. Wai On Shim. Lay Members of the Cathedral Chapter elected were: Dr. Joseph Pekelo, Dr. Thomas Jaggar, Mr. William Soper, Mr. K. L. Ching, and Mr. Norman Ault.

Diocesan Banquet

Bishop Quin's address to the 400 guests present at the Annual Diocesan Banquet, held at Central Union Parish Hall, gave them a real spiritual uplift. He said, "The people of the world are confused and need a spiritual undergirding and this power can come only through the true church." In order to obtain this power, he said, "You must throw yourself into the atmosphere of the Church, practice humility, be repentant, and forgive. The ills of the world, personal, as well as national, come about because we hold back and bear grudges. World peace could be ours, if we would use this power rightly." He spoke of the power of family prayers and tithing.

The Reverend Frederick A. McDonald, St. Clement's Church, Honolulu, did an outstanding job as Toastmaster. Mrs. Flora Hayes led a group in Hawaiian music,

which added much to the occasion. Another feature of the program was native dances performed by young women in native costumes: Miss Jane Lyum, Korean sword dance; Mrs. Li Hsa Fo, in a colorful Chinese ceremonial sword dance; Pearl Kano, Japanese dance, and Yasuko Ganiku, Okinawan.

The Bishop's table was decorated by Mrs. William Foster and Mrs. J. P. Martin and the guest tables by St. Dorothy's Circle, St. Clement's Church. All of them were beautifully arranged.

Woman's Auxiliary Annual Meeting

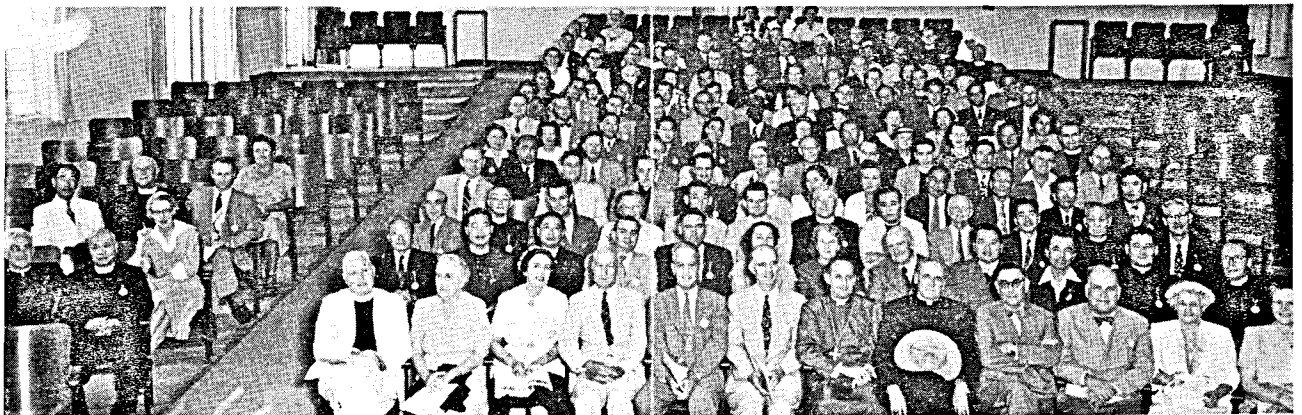

The Clergy Conference on Wednesday, April 4th, ended the Convocation. Bishop Quin spoke to the clergy on the "Work of the Parish Minister as Prophet, Priest, and Pastor." Following this meeting Bishop and Mrs. Kennedy entertained the clergy and their wives at luncheon at the Oahu Country Club.

Plans for a summer clergy conference, to be held at the Hawaii Episcopal Academy, Kamuela, Hawaii, were also made.

Youth Conference

The theme "He in Us, and We in Him" was the topic discussed by the following clergy at the Youth Conference, held at Mokuleia Youth Center, Saturday, March 31st. The Rev. Messrs: Frederick A. da; Vice President, Edwin Yamauchi; Recording Secretary, Louise Godfrey; Corresponding Secretary, Millie Lucas; Treasurer, Annette Lum. The Rev. Richard M. Trelease, Jr., Director of Diocesan Youth Work, was in charge of the Conference.

Aids Oriental Work

Bishop Quin made a very generous gift toward the Oriental work in the Diocese, being very impressed with the work being done by our Oriental clergy.

Two of the Bishop's Distinguished Service Crosses were made at the banquet by the Bishop. One went to the Rev. Hollis H. A. Corey in honor of his devotion and service as a missionary priest since 1908, having served in Labrador, Japan and Hawaii during that period. He has been on the staff of the Diocese for the past year, assisting at St. Luke's Mission, Honolulu. He will retire in June of this year. In Hawaii he has served as Vicar of Holy Apostles' Church, Hilo, Hawaii and Epiphany Mission, Honolulu. He has for many years been chairman of the Board of Examining Chaplains. A distinguished and beloved presbyter of the Missionary District of Honolulu, he was awarded the cross with this tribute from the Bishop: Because of his valuable contribution of high standards in respect to ministerial life and purpose, and has shown himself to be an honest, devout, sincere, and faithful servant of the Lord Jesus Christ.

The Rev. Y. Sang Mark, though not present to receive his cross, was awarded the cross with this citation: For faithful and devoted service as priest and Canon of the Missionary District of Honolulu for twenty-two years, who by reason of his keen sense of vocation as Vicar of

St. Peter's Mission for nineteen years, developed it into a self-supporting parish in 1947. During this time he served the Church in the Hawaiian Islands by being a member of important committees in the Diocese, especially as secretary of the Council of Advice. I wish to commend him as a devoted and faithful servant of our Lord and His Church.

Several To Go On Furlough

The Reverend Burton L. Linscott, Epiphany Mission, Honolulu, and his family will go on furlough May 13th. The Rev. John R. Caton, St. Mary's Mission, Honolulu, will leave for the mainland on May 15th. Both of these clergy plan to attend the College of Preachers, Washington Cathedral, Washington, D. C., the latter part of May. The Rev. and Mrs. George Davison plan to leave for the mainland on June 3rd. The Rev. and Mrs. John P. Moulton, Iolani School, will leave in early June with their family for their furlough. The Rev. Henri B. Pickens, Christ Church, Kealahou, Hawaii, will start for his furlough with his family on June 15th. The Rev. Hollis H. A. Corey and Mrs. Corey will leave for the mainland in June. He is retiring, so they will not return to Honolulu. Mr. Joseph Reed, Diocesan Treasurer, and his family will leave for their furlough in early June.

Ground Breaking Service

St. Stephen's Mission had a service for the breaking of ground on Sunday, April 1st, with the Reverend Claude F. Du Teil, Vicar, in charge of the service. The contract has been let and work has begun on the erection of their new church building.

Visit the Islands

Following Convocation Bishop and Mrs. Quin visited the Island of Kauai, the Island of Maui and the Island of Hawaii. On Sunday, April 8th, Bishop Quin preached at St. James' Church, Kamuela, at eleven o'clock. In the afternoon the women on the Island of Hawaii met at Kamuela for the privilege of hearing Mrs. Quin. About 55 were in attendance. The clergy and men had a meeting at the same time with Bishop Quin. There were over forty in attendance. At the church service in the morning over 125 were in attendance.

We are grateful indeed for the stimulating and spiritual note in the messages of the Quins. They did much to help us while in Hawaii.

Bishop Littell is Ill

We have received news of the sudden illness of Bishop Littell from Mrs. Littell, who wrote us April 7th. He was in Ardmore, Pennsylvania at the time he was stricken, visiting his daughter. He was taken to the Episcopal Hospital, Front Street and Lehigh Avenue, Philadelphia. Mrs. Littell wrote, "The doctors believe that barring further complications a recovery can be made." We know that his many friends in Hawaii will keep him in their prayers, and that he will be remembered at all our altars. We join in wishing him a speedy recovery.

Doing Work On Midway

Mr. Alex Glade has been licensed as a Lay Reader to assist with the Church's work on the Island of Midway. The following excerpts are from a letter he recently wrote to the Bishop:

Humbly I write and ask your blessing on the work that I am doing here at Midway. Maybe I was presumptuous, but the opportunity arose where I could fill in a niche that was empty, so I took over the Protestant services for this small station. The enlisted man who had led the services previously, was given leave, and, as I had shown interest in leading the congregation and trying to establish a choir (you remember Wahiawa was always the singingest group you ever saw) he asked me if I would take over while he was gone. Of course I gladly did. Now it seems problematical if he returns, so I naturally have taken over until such time as the Navy sees fit to give us a regular chaplain. On Easter Sunday we had 66 present in our congregation, and it just about filled all available space in our little quonset hut chapel. Mary White (Mrs. Robert) in her usual role of benefactress, provided us with gorgeous flowers to decorate our altar.

We hope to have Chaplain Harrison with us next Wednesday evening for service. It is always a highlight in our little "parish" when we can welcome a chaplain in our midst to give us the benefit of his presence, and, if possible, to allow us to make our Communion with God.

We are indeed grateful for the help Mr. Glade is giving in this important service on Midway.

WhitSunday Offering

Whitsunday, May 13th, has been set aside by the Diocese for the special offering for the Episcopate Endowment. This is of particular importance to us, for it is only through the raising of this fund that we may hope to achieve the status of an independent Diocese. It is necessary that we have at least \$250,000 to achieve this goal. We now have \$45,516 in this fund, which is far short of our goal. We commend this offering to your generous giving.

Chaplain General Visits Here

The Reverend Vivan A. Peterson, D. D., St. James' Church, Cleveland, Ohio, Chaplain General of the Sisters of the Transfiguration, arrived in Honolulu on April 2nd, for an official visitation to the Sisters of St. Andrew's Priory, conducting their services and retreat. He also installed the new Associates of the Sisters of the Transfiguration, at a special service. We have enjoyed having him in our Missionary Diocese.

Summer Camp

Registrations are now being received in the Bishop's Office for our summer camps. This is becoming one of our most popular projects, and it has necessitated a longer period for the outings, so that as many children as possible can be accommodated. Boys and girls ages 8, 9, and 10 years will be given their camping outings June 17 to June 29th and from July 1 to July 13th. Boys and girls of the ages 11, 12, and 13 will have their camp from July 15 to July 27th.

Under the direction of the Bishop, plans have gone forward for the camp. The Reverend Richard M. Trelease, Jr. will be in charge of the camping program, assisted by the Rev. Messrs: Claude F. Du Teil, William Gosh, Lawrence Ozaki, and James Nakamura. Miss Mary Whitten will again assist in the direction of the camp, which gives it assurance of success. The Rev. and Mrs. Claude F. Du Teil, both well versed in camp life, will be at the camp the entire period, and the other clergy will be assigned to assist with certain periods. Miss Margaret Monteiro will again be in charge of handcrafts and Mrs. Edmund L. Souder will be the registered nurse in charge. The Junior Counselors have not yet been determined.

This should be an outstanding camp year for our young people, for the program has been improved for the children. Those wishing their children to attend should make an early application, for we can take only a limited number.

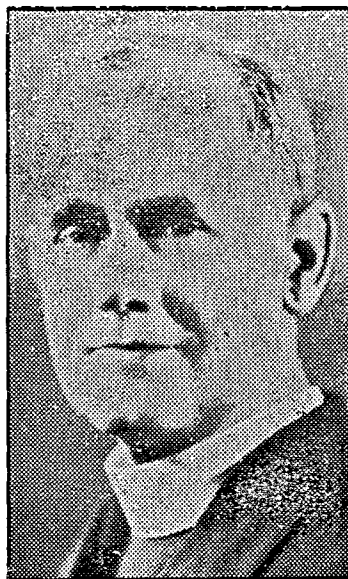
Gift to Diocesan House

IN MEMORIAM

On Easter Eve the Very Rev. William Ault passed into the life eternal. He was 80 years of age at the time of his death. He passed away at Queen's Hospital, where he had been for several weeks.

He was born in 1871 in Titbury-on-Trent, Staffordshire, England, and came here after his graduation from St. Boniface College in 1897, to serve as Vicar at the Church of Holy Innocents, Lahaina, Maui, under Bishop Alfred Willis. He also served at the Church of the Good Shepherd, Wailuku. In 1901 he married Elizabeth May Caroline Hayselden, member of a kamaaina family.

The following Resolution was made regarding him at the 49th Annual Convocation of the Missionary District of Honolulu, and was sent to his widow and members of his family, as well as written into the minutes of the Convocation:

WHEREAS the Very Reverend William Ault, retired Dean of St. Andrew's Cathedral, was priest in the Missionary District of Honolulu from 1899 to his demise on the 24th day of March, 1951; AND WHEREAS he devoted himself in the Church's work on the Island of Maui, T. H., during the trying time of its infancy; and later, as Rector and Dean of St. Andrew's Cathedral, proved himself as one of the outstanding spiritual leaders of the Community; AND WHEREAS his strong devotion to the Church and his abiding faith in the Lord Jesus Christ has sustained many faltering hearts and has brought many souls to the knowledge and love of God; AND WHEREAS even in the years of his retirement he has maintained keen interest in the work of the Church in these Islands and in the world at large;

THEREFORE, be it RESOLVED that this 49th Annual Convocation of the Missionary District of Honolulu now convening on the 2nd day of April, 1951, go on record to recognize his priestly influences upon the people of the Church and of the community at large, and

FURTHER BE IT RESOLVED that the Secretary of this Convocation be instructed that this record be kept in the annals of said convocation.

He is surved by his widow, three sons: Ralph, William, and Norman, all of Honolulu, a daughter, Mrs. G. R. Ewart III, of Honolulu and Mrs. Mary Ault Tobin, of Nebraska. He had seven grandchildren.

The entire diocese joins in expressing sympathy to his family. His presence will be greatly missed. May he go from strength to strength in His service, and may perpetual light shine upon him.

Mite Box Offering Service

The stirring service of the presentation of the Mite Box Offering for all the churches on Oahu was held on Sunday, April 8th, at 3:00 p.m. in St. Andrew's Cathedral. The offering this year, thus far, is \$4117.94, but there are many churches on our other islands to be heard from.

Army and Navy Chaplains Present Classes

Chaplain Kenneth Perkins, U. S. Navy, and serving with the United States Marines at Pearl Harbor, presented a class of twelve for confirmation at the Makalapa Naval Chapel, Sunday, April 8th. On the same day Chaplain Gregory Lock, at Fort Shafter, and with the United States Army, presented a class of eleven to the Bishop for the laying on of hands.

Four Types of Church Members

News From Okinawa

As we contemplated, no easy road lay before our two missionaries who now find themselves in Okinawa, trying to do an important work for the Church in Okinawa. Word has come back from both the Reverend Norman B. Godfrey and the Rev. William Heffner of their first impressions, their up and down moments, and their hopes for the future. Excerpts from their letters are:

"Tokyo was a happy experience which will long be in our thoughts. We slept on the floor at the seminary, the paper walls allowing us outdoor weather—it snowed a fortnight before we landed. There was no heat, no hot water to shave with, but takusan (much) rice. When we got hot water it was in a bathtub, which was also used for washing clothes. Once we beat the rest and once we came in about 40 times save one. They that run a race in a hot bath run all. But compared to Tokyo this is caveman style. I have moved into the back yard at Chaplain Fenwick's hut to get out of the damp cold and away from the fleas. They say Okinawa has improved greatly since the war. It must have been hell when the Bishop was here in 1946.

Our plane arrived here about one p.m. on Wednesday, March 21st. Conditions here are bad. Housing is non-existent, except for the army. Without a car one just doesn't get around. At the present time we are able to get around only by the help of the army and airforce chaplains, who have befriended us. While there has been no word as to the arrival of the suburban from Yokohama, a ship is due in from there next Thursday. We are keeping our fingers crossed, hoping against hope that it is on that ship (a later letter revealed it was *not* on that ship).

Dr. and Mrs. Harry Taylor, in our Church hospital in Anking, China, Mr. and Mrs. Walter Allen, in the Hankow Diocese, and the Rev. and Mrs. Gilbert Baker, from the Central Theological School, Shanghai, were recent visitors in Honolulu, stopping only for the day as their ship was in harbor. It provided their China friends in Honolulu an opportunity to have a visit with them and learn more of what was happening to their loved ones in China. We are told that Miss Blanche Myers, our former Diocesan Treasurer, is now planning to leave China.

Gift to St. Elizabeth's Church

The Rev. Wai On Shim announces that a gift of \$500 has been given to St. Elizabeth's Church, Honolulu, by the family of Mr. Clement Pang, former Senior Warden, who was drowned over a year ago. The Vestry announces that this will be used for a permanent fixture in their new Church building.

Saint Margaret's House

The fourth consecutive Vocational Conference for students who are considering Church work as a profession was held April 27, 28, 29 at Saint Margaret's House in Berkeley. Young women from the central section of the Eighth Province attended the sessions and were welcomed by Dean Katharine Grammer and by the faculty and students of Saint Margaret's House.

Bishop Campbell of Los Angeles made the principal address on The Need for a Christian Approach to your Vocation.

Each year in rotation, the Conference focuses attention on one of the three fields of services open to women workers: Rural work, college work, or parish work.

Dean Grammer disclosed the alarming lack of trained women in the Episcopal Church today. Saint Margaret's in Berkeley, Windham House in New York, and Saint Mary's in Philadelphia will have a total of approximately 20 students this year qualified to fill more than 300 positions for women Church workers, according to a recent nation-wide survey. This discrepancy presents an urgent challenge which must be recognized through the parishes of our Church and in our schools and colleges.

New York—Presiding Bishop Henry Knox Sherrill and Mr. Harvey S. Firestone, Jr., announce the appointment of the Rev. Clarence R. Haden, Jr., as Executive Director of the Presiding Bishop's Committee on Laymen's Work, succeeding the Rev. Arnold M. Lewis, now Dean of the Cathedral in Jacksonville, Florida.

Mr. Haden has been rector of St. Philip's Church, Durham, North Carolina, since 1945.

The roads here are fierce and chew up the tires at a great rate. Otis Bell, the Methodist man here, had a flat when we were out with him the other day. He has been here one year and has already used up six tires. In one month he had fifty flats.

In our own minds, it has already become obvious that we shall have to start our work in Naha. There are some sixty thousand people there with only three churches—the native Church, the Seventh Day Adventist, and one Roman Catholic. On the whole Island there are only nine missionaries.

It is absolutely impossible to rent anything. In order to live and work we must start to build just as soon as we can buy land, get plans, and let a contract. The location of the site is something which we shall have to work on when the station wagon comes. Many things have to be taken into consideration, including the possible shift of population back to the old Naha, which was destroyed. The military plan sometime to release that land back to the people. The need for central headquarters for the Okinawa Seiko Kwai is imperative. It will be right in the heart of the native community. Once we have that, we can unpack our gear, and have a place where we can have instruction classes and also a place to sleep and eat.

Right now we are at Kadena, north of Naha. When

the car comes, we have a small room at Chinen, which we have been promised. That is also some distance from Naha, but the best we can get until we build. On our first night here, after the lights went out, we fought mosquitoes. By hiding under the sheet, it was possible to sleep a little bit. About half way through the night (I had thrown off the sheet) I was rudely awakened by a big, fat rat which crawled right over my face. Well, that began the battle of the rats. For the rest of the night they ran all over both Norm and me. When I felt one coming up my leg, I gave it a kick with my knee, and it landed in Norm's cot, quite by accident. He gave it a kick, and it landed back on my cot. Well, it was really a terrible nightmare, and probably a fitting initiation.

We shall need your permission to build, as well as an appropriation to buy the land and let a contract. We've been told that a seven room house can be built for around \$4000. That figure has not been checked yet, but it gives you an idea. We would use that, for Church, office and home. One of the rooms could be turned into a chapel, another could be used as an office, and another for meetings with those under instruction. That of course can be worked out in detail later. But the first item on our list is housing.

We hated to leave Hawaii, but were strengthened by the show of affection and love as the ship sailed with so many there to see us off and wish us well. Our hearts are, and always shall be, partly with you all there. When

the dark clouds come, and they have already cast their shadows at times, the memory of all the friends in Hawaii will strengthen us and give us the courage to go on.

Both of our missionaries expressed great gratitude to Bishop Viall, in Tokyo, to Chaplain John Linsley, and Chaplain Lawrence Fenwick for their assistance in getting them started. They have been cordially received by the other missionaries on the Island, and by the Roman Catholic priest and Chaplain.

Distinguished World Churchman To Visit Hawaii

"In setting itself up as a permanent organization, the World Council of Churches has made one of Protestantism's most important achievements since the Reformation." Such was the editorial comment in "Life" magazine three years ago at the time of the formation of this new world church movement, one of whose leaders is to pass through Hawaii. Dr. Henry Smith Leiper, Associate General Secretary of the World Council of Churches, will be in the Islands from Thursday, May 10th, until Monday, May 14th, when he will leave for New Zealand and Australia where he has been invited by the National Council of Churches of these two countries to undertake a speaking tour on the development of world Christian community through the ecumenical movement. He is stopping over in Hawaii by invitation of the Honolulu Council of Churches, local expression of the movement which he represents.

Dr. Leiper, whose office is in New York, will speak at the Annual Meeting of the Honolulu Council of Churches on May 11th, while on the evening of May 13th, Pentecost Sunday, he will be the guest preacher at a special ecumenical service which will be held in St. Andrew's Cathedral at which the newly elected officers of the local Council will be formally installed. Dr. Leiper will also visit Kauai, Maui, and Hawaii where local groups are cooperating with the Honolulu Council of Churches in arranging meetings which he will address.

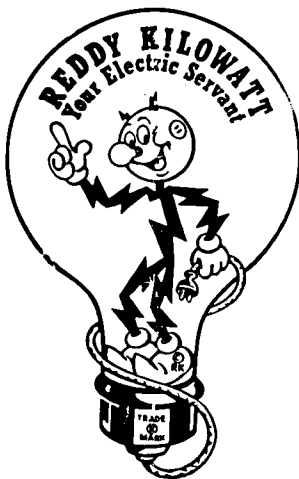
