New Appointments in the Diocese

It is interesting to note that he was confirmed in St. Andrew's Cathedral in December, 1944. Having served in the Pacific area for three years during World War II, he felt that this was the field in which he wished to serve. He is a native of Columbus, Ohio.

Dr. Stokes has commended him very highly and rejoices that he can return to the field he once enjoyed serving.

58th General Convention of the Episcopal Church to Come to Hawaii

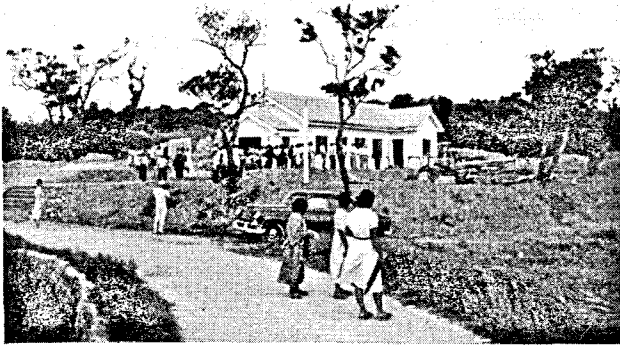
Perhaps no more thrilling news has come to the Church in Hawaii than that of June 17th, when our Presiding Bishop, the Most Reverend Henry Knox Sherrill, announced that the 1955 General Convention of the Church will be held in Honolulu. It is a breath-taking challenge for everyone of our faith in Hawaii, because it is going to mean a tremendous job for everyone, exciting as it may be to have such a responsibility given to us.

In making his announcement, Bishop Sherrill said:

"Under the Provision of the Constitution of the Protestant Episcopal Church, Article 1, Section 7, I have accepted the invitation of the Right Reverend Harry S. Kennedy and the Missionary District of Honolulu to hold the General Convention in Honolulu, September 4-16, 1955.

"Due to all the circumstances, it is planned that this will be a greatly simplified Convention. Obviously the great number of visitors usually present will not be able to attend. Without extra gatherings and exhibits the task of the Convention will be confined to the essential official business of the Church.

"Two questions will arise because of distance and expense. Modern transportation facilities will be able to solve the former. In regard to the latter, it is hoped that



All Saints Church, as viewed from the road.

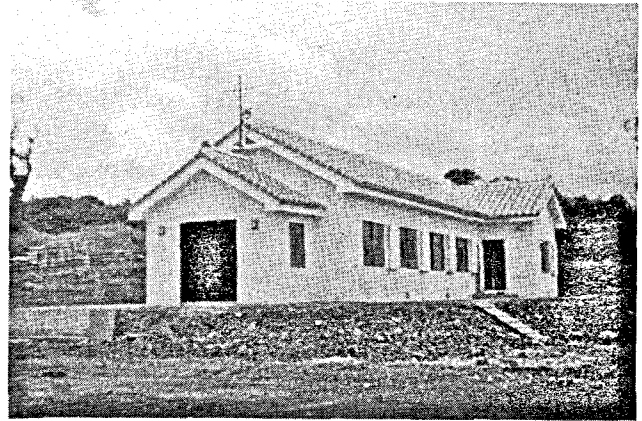
a central fund may be obtained to assist those official delegates who otherwise would not be able to attend. We have met several times previously on the West Coast. The significant fact is that this will mark the *first* time that the General Convention has met in a Missionary District and in this case an overseas Missionary District. It is my conviction that this Convention will give tremendous impetus to our missionary work at home and aboard."

The Presiding Bishop said in his June 8th statement, when he made the decision not to hold the Convention in Houston, that it was "the most difficult and painful" decision he had ever been called upon to make, but that he believed in "a time of crisis . . . the witness of our Church must be so clear that it need not be explained."

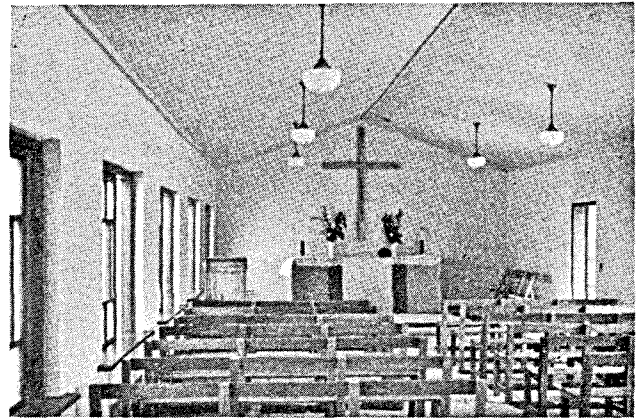
The Right Reverend Clinton S. Quin, Bishop of Texas, and well known to our people in Hawaii, since he was our Convocation guest in 1951, announced to his press in Houston when he learned of the Presiding Bishop's decision, "I am so glad that they found a place where there is no sin," which is typical of his good humor. He wrote a very gracious letter to Bishop Kennedy, stating that he was looking forward with keen anticipation to being with us in 1955. We, in return, will look forward to seeing him and his gracious wife at that time.

Each Diocese sends eight deputies (four clerical and four lay) and one bishop to Convention; each Missionary District one clerical and one lay delegate and five Woman's Auxiliary delegates to the Woman's Auxiliary Triennial which usually meets at the same time and place as Convention.

We have the great honor to entertain General Convention, but also the great responsibility of planning to be hosts to some 3000 mainland churchmen. There are 178 Bishops, of whom about 150 could be expected to attend, over 600 deputies (clergy and laity) and over 500 delegates to the Woman's Auxiliary. Each group requires a separate meeting place.

All Saints Church, Okinawa, Dedicated

Sunday, June 6th, Whitsunday, the Rev. Canon William Heffner conducted the service of dedication for our new church at Shimabukuro, All Saints Church. He was assisted by the Rev. Stephen E. T. Kim and the Rev. Luke Teruo Kimoto.

The new church, which has a seating capacity of 120 people, replaces the home of one of the members of All Saints, which the congregation has been using for the past two years.

A boys class of All Saints Church, Detroit, Michigan, helped assist with the erection of the church, as did our Church. In addition, the Okinawans themselves raised over two hundred dollars. The Episcopal women on Okinawa, through their Ascension Guild, gave pews from money raised through bake sales. Captain Benjamin Nauss, of the United States Army, whose hobby is woodworking, made and gave the cross. American churchmen of the Island, through their offerings on Sundays, gave three hundred dollars toward the completion of the Church.

Civic Auditorium Will Be Used For Convention

The Civic Auditorium in Honolulu, seating 6000, will be used for the Opening Service, the United Thank Offering Service, and joint sessions of all three houses of Convention.

We expect our guests to visit all of our Islands and we hope that special services may be planned on each Island.

We have been informed by the Visitors Bureau that the largest convention to be held in Hawaii had 600 guests. It gives us some idea of the task that lies before us. But the great joy of it all has been the wonderful response of our own people and those in the community. We have only fourteen months in which to prepare for this, where ordinarily a host Diocese has three years. We want our fellow Churchmen from all over the world to share the warmth of our Hawaiian hospitality. We look to each one of you, when called upon, to say, "What wilt thou have me to do?"

Hostel Started

Work on the new hostel has been started. It is being erected above the Diocesan Offices and will be ready for occupancy the latter part of August. This hostel was the idea of the Presiding Bishop, and he was instrumental in getting the funds from National Council to build it. It will be a very wonderful addition to the Diocese, and we are most grateful to have it.

To Go to Okinawa

The Reverend Harry S. Finkenstaedt will leave on July 6th for Okinawa to assist the Rev. Canon William Heffner with his work in our missions.

The Rev. Mr. Finkenstaedt has been at St. Matthew's Mission, Waimanalo. He will be succeeded by the Reverend Mellick Belshaw, who will arrive August 10th to take up his duties there.

We feel that this will mean much to Canon Heffner to have the assistance of the Rev. Mr. Finkenstaedt and we send him forth with our Aloha and blessing.

Accepts Call to Wilmington, Delaware

The Very Reverend Richard M. Trelease, Jr., Dean of St. Andrew's Cathedral, has accepted the call to St. Andrew's Church, Wilmington, Delaware. He and his family will leave Honolulu on July 20th, in order that they may have a vacation before starting his work on September 1st. They will visit relatives in Kansas City, Missouri, enroute to Delaware.

It is with a profound sense of loss that we send them forth to their new work, yet we wish them every joy and blessing in whatever lies ahead. Dean Trelease, his wife, Jean, and his sons Kolu (Richard III) and Christopher are very much beloved by the Diocesan Family.

Dean Trelease has made a great contribution to the work of the Church in Hawaii. He came to Hawaii as

Curate of St. Andrew's Cathedral in 1945, where he served for two years. He then became Vicar of St. Christopher's Mission, Kailua. During his three and a half years there he built the new church and brought the mission to parish status. On December 1, 1950, he was called as Rector of St. Andrew's Cathedral. In April, 1953 he was made Dean of the Cathedral by Bishop Kennedy.

He has been head of our Diocesan Youth Work for many years and has done a fine work. He has taken three groups of young people to our General Conventions of the Church — one to Philadelphia, one to San Francisco, and the last one to Boston.

As head of the Department of Youth he has also been in charge of the summer camp program at Mokuleia and Diocesan Youth Conferences. Our first camp was for two weeks with an enrollment of thirty youngsters. We now have four periods of camp, each one running two weeks, with a capacity enrollment of 48 each period.

Dean Trelease has been an officer of the Honolulu Council of Churches, has taken an active part in community affairs, and has served on several Diocesan committees.

We send him and his family forth with our very affectionate Aloha.

Elected President of Oahu Clericus

At the last meeting of the Oahu Clericus the Reverend Paul R. Savanack, Rector of St. Peter's Parish, Honolulu, was elected President. He succeeds the Reverend C. Fletcher Howe, who served as President for two years. An expression of gratitude was extended to the Rev. Mr. Howe for his devoted service in this capacity.

Receives Bishop's Distinguished Service Cross

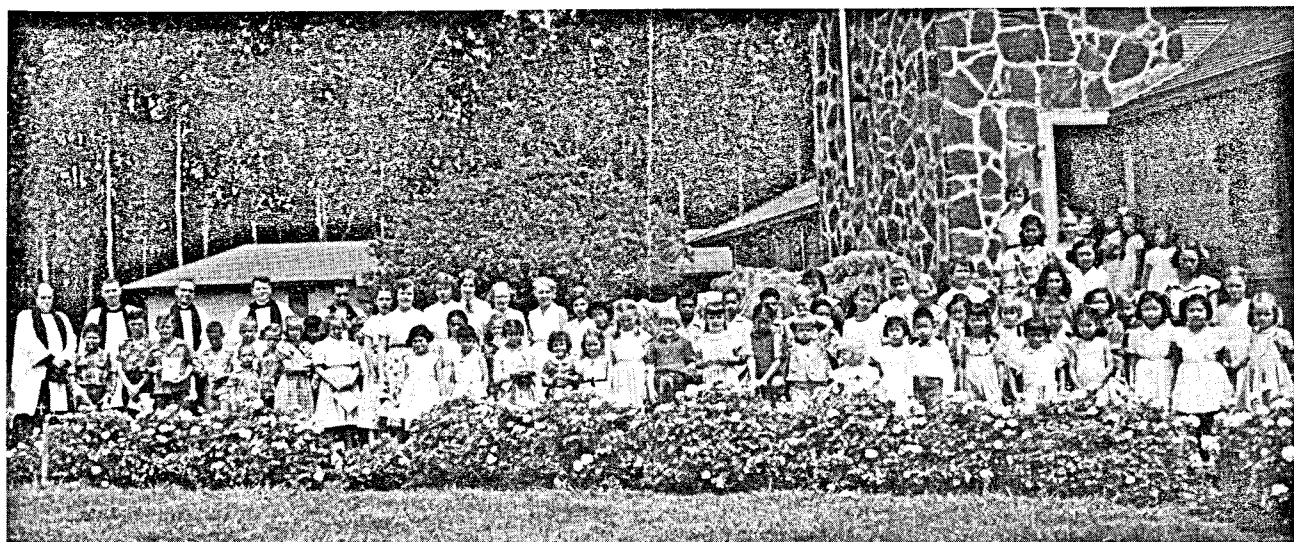
The Very Reverend Richard M. The Most Reverend Michael H. Yashiro, Presiding Bishop of Japan; the Right Reverend A. K. Warren, of Christ Church, New Zealand; the Right Reverend John Stoward Moyes, Bishop of Armidale, N.S.W. Nishi, Dean of the Central Theological Seminary, Tokyo, were in Honolulu for brief stays as they traveled to Minnesota, where the Anglican Congress will convene on August 4th. Many others traveling from the Far East to the Congress are expected in July, but we do not have the exact times of their arrival. We expect many to return to Honolulu following the Congress.

August Conference for Sunday School Superintendents

Elected Bishop Coadjutor Of Massachusetts

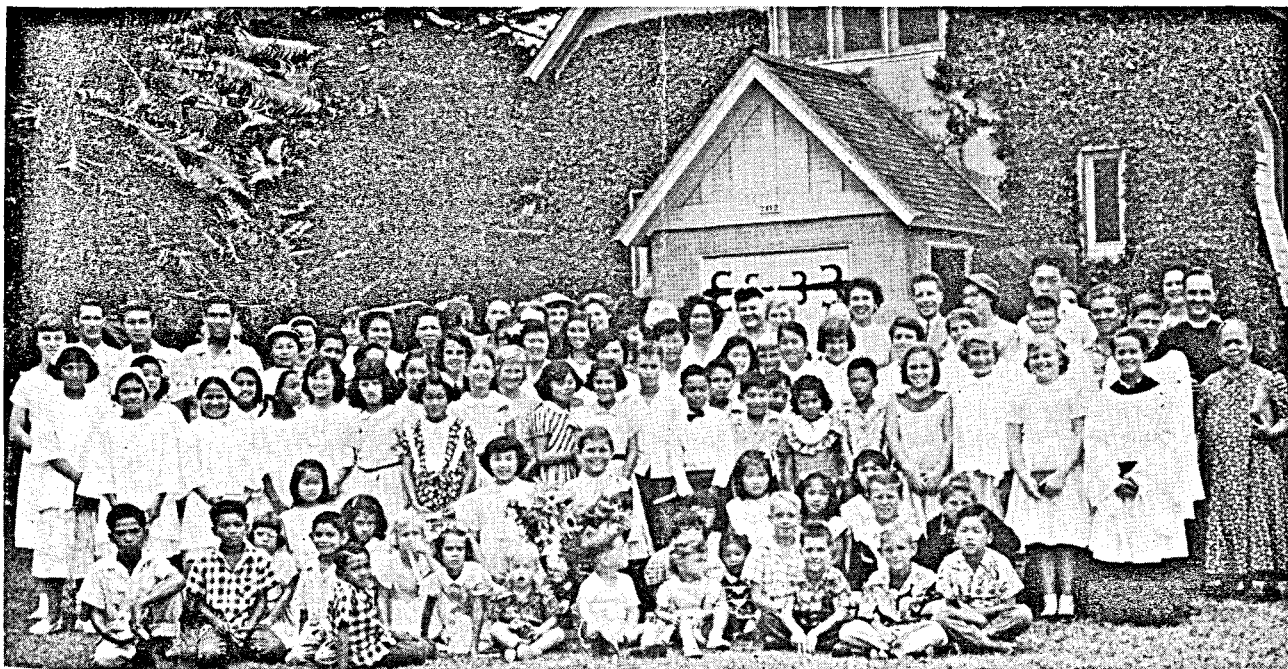

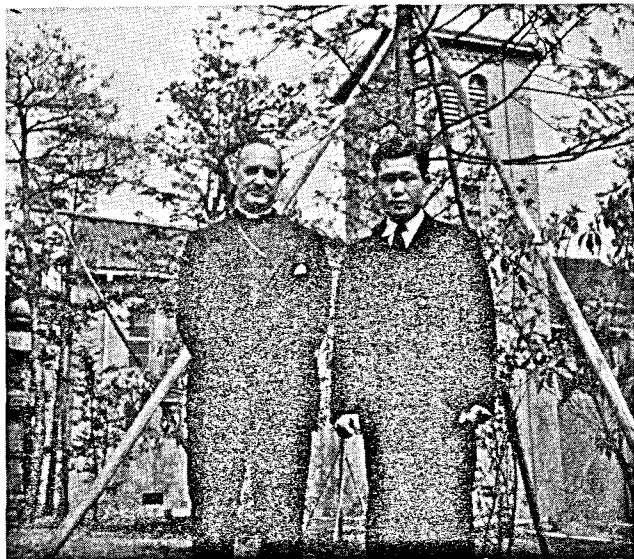

What is General Convention . . .

When the 58th General Convention of the Protestant Episcopal Church in the United States of America meets September 4th-16th, 1955, it will be the first time it will have met outside Continental United States. Except for the name, there will be slight resemblance between the first General Convention, whose forty-two members leisurely assembled in Philadelphia in 1785, and the great gathering anticipated in Honolulu.

Powers of Convention

What is the General Convention? It is primarily an ecclesiastical synod, meeting every three years, the official legislature of the American portion of the Anglican Communion. Its functions and procedures are carefully outlined in the Church's laws, or the Constitution and Canons. It alone has the right to alter or revise THE BOOK OF COMMON PRAYER; it alone may amend the Constitution; it alone may change the Canons.

One unique mark of the General Convention is that it is a bicameral legislature, in structure somewhat resembling the American Congress. Neither chamber may legislate by itself; hence each adopts resolutions beginning, **RESOLVED**, the House . . . concurring . . . This necessitates a constant interchange of official messages between Houses.

House of Bishops

The first Convention consisted solely of priests and laymen. The House of Bishops came into being four years later and included only Bishop Seabury and Bishop White. The Presiding Bishop is ex-officio chairman of the House. The Reverend John Fitzgerald, D.D., rector of Christ

Church, Bay Ridge, Brooklyn, New York, has been secretary for the past fifteen years.

Each bishop has his own desk, arranged in order of consecration, so that senior bishops are seated in the front of the House. One of the responsibilities of this House is to elect missionary bishops, subject to confirmation by the House of Deputies.

House of Deputies

The House of Deputies is a much larger chamber, with a potential membership of 658. It is equally divided between clerical and lay deputies. The former must be priests. The latter must be adult, male communicants of some parish within the diocese they represent. Each diocese is entitled to four clerical and four lay deputies. Each missionary district is entitled to one each.

Joint Sessions

During each General Convention there are several Joint Sessions of the two Houses, with the Presiding Bishop as Chairman. These are intended for the reception of notable guests and for the receipt of important reports, such as that of the National Council. No legislative measures are transacted in these sessions. The election of members to National Council, trustees of the General Theological Seminary, a Registrar, an Historiographer, and a Recorder of Ordination will be another duty of Convention.

Triennial Meeting of the Woman's Auxiliary

The Triennial Meeting of the Woman's Auxiliary will also meet at this time. There are five women delegates for each diocese and missionary district, plus one additional delegate from each diocese and missionary district having a racial minority group of certain size. The outstanding Woman's Auxiliary event will be the presentation of the United Thank Offering at the Holy Communion Service at which the Presiding Bishop will be celebrant, assisted by the Church's missionary bishops.

The program of the Triennial Meeting is primarily educational and inspirational, but in addition to this the distribution of the United Thank Offering is determined, the election of eight members-at-large for the National Executive Board is held, and nominations for four women to serve on the National Council for the ensuing triennium is made.

Prayer for General Convention

O God, whose love reachest to the ends of the world, bless, we pray Thee, the clergy and laity of this Diocese in the planning and preparation for the coming to these Islands of the 58th General Convention of Thy Church. Guide us and strengthen us in all that we may do that Thy Church may be strengthened to fulfill Thy will on earth, that all men may come to know Thy Son as their Lord and Saviour. All this we ask in the name of Thy Son, Jesus Christ our Lord. Amen.

Pearl Harbor Episcopal Church Chaple

Canterbury Club Activities

English Bishop Recalls 1950 Korea Death March

Bishop Cecil Cooper of the English Church Mission in Korea stopped briefly in Honolulu on June 30th, enroute to the Anglican Congress.

Survivor of the Death March of October, 1950 in North Korea, Bishop Cooper has served in Korea since 1908, with the exception of five years spent in England during the Japanese War and three years spent as a prisoner of war of the Communists during the Korean conflict.

Recalling the days of the Death March, Bishop Cooper said that 800 persons, of whom 750 were American soldiers, started out on the nine day trek across 150 miles of the most northerly tip of the Yalu River. On the way 100 persons were either shot or died.

The Bishop said that in the beginning food, medical

and housing conditions were very bad. The prisoners were crowded in Korean houses in the coldest part of that country, and more than 450 American soldiers died that winter.

The following April the American soldiers were separated from their group of about 40 church leaders, White Russian families, Turk traders, hotel managers, mining experts, and members of the British and French legations. In April of 1953 Bishop Cooper returned to England by way of Siberia and Moscow. After five months in his home country he returned to Korea.

Tragically, the Bishop says, many of the people in Korea have the feeling that war may begin again. He, however, does not believe that the Chinese wish to press another fight. He says that American money is responsible for much of the reconstruction of Korea.

Discussing Indochina, Bishop Cooper said that the Koreans feel very strongly about it. They feel that the country is in the same situation as themselves — that they have the same problems and the same aims. They want to prevent the extension of Communism. The Iron Curtain is down there and the countries must hold together.

He went on to say that since the Korean War there is a pronounced movement toward Christianity in Korea. Twenty to 30 per cent of the people are attracted to some Christian group and even if their motive is not pure, there is a great opportunity for work in Korea. Before the War the Christian population was five to six per cent of the total population.

"After our two years in the grass roofed house (the residence of one of the congregation) you can well imagine the joy that was ours in having this fine new church. Bishop, I want to thank you for all that you did to make this dream a reality."

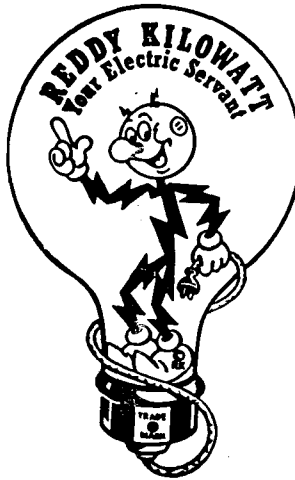
