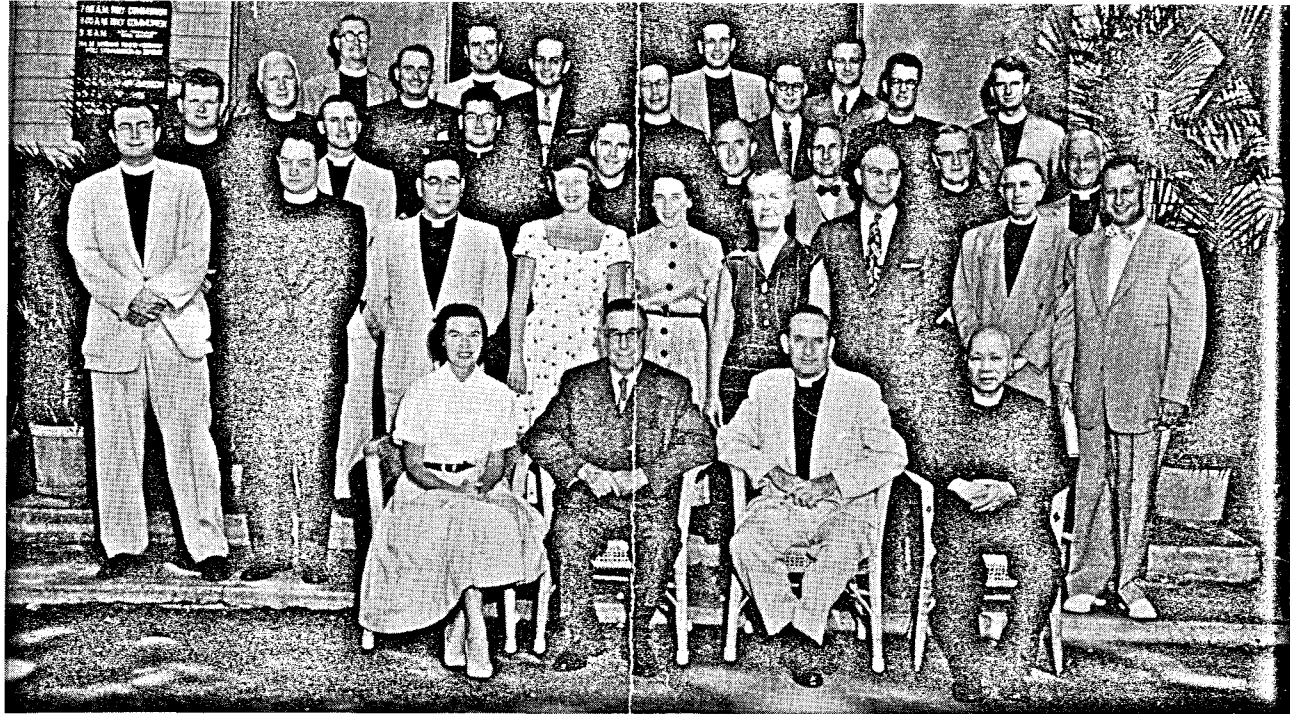

Missionary Mass Meeting

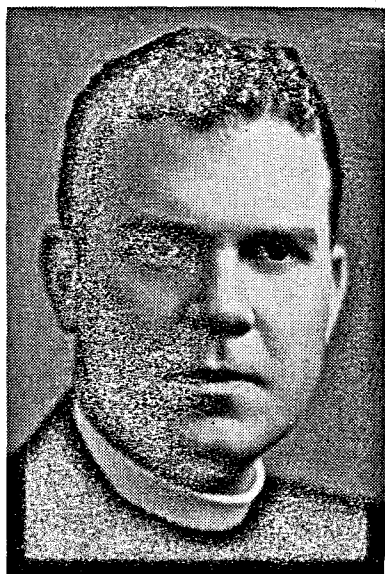

Accepts Call as Dean of St. Andrew's Cathedral

The Rev. James Stanley Cox, M.A., B.D., Rector of Emmanuel Church, Baltimore, Maryland, has accepted the call to become Dean of St. Andrew's Cathedral, Honolulu, as of January 16, 1955.

The Rev. Mr. Cox was born in Camilla, Georgia, November 27, 1909. He received his Bachelor of Arts Degree from George Washington University and his Master of Arts Degree from Duke University. In 1934 he received his Bachelor of Divinity Degree from Virginia Theological Seminary, Alexandria, Virginia. He was ordained to the Priesthood in 1934 by the Rt. Rev. Henry St. George Tucker.

In 1934 he married Anna Goldsborough Harrison of Baltimore and Leesburg, Virginia. They have four children: Anna Harrison Cox, who made her debut at the Bachelor's Cotillion in 1952, and who is now a Junior at Goucher College; James Stanley Cox, Jr., a Freshman at Princeton University; Brice Goldsborough Cox, who attends Groton School in Massachusetts; and Stephen Edward Cox, an infant.

The Rev. Mr. Cox's first charge was Ascension Church, Silver Spring, Maryland. Thereafter he served successively Emmanuel Church, Chatham, Virginia; Holy Comforter, Burlington, North Carolina and St. Paul's Church, Winston-Salem, North Carolina. In 1943 and 1949 he served as Deputy to the General Convention of the Episcopal Church. He has been at Emmanuel Church, Baltimore since 1950.

In addition to his parochial duties in Baltimore, he is a member of the Board of Trustees of The Church Home and of The Church Mission of Help. He is Chairman of

the Adult Division of the Department of Christian Education for the Diocese of Maryland, and Dean of the Convocation of Baltimore.

In 1950 Mr. Cox was invited to preach at Oxford University, England.

The new Rector of St. Andrew's Cathedral has two brothers, both of them clergymen. One, the Rev. Robert Eugene Cox, is Associate Professor of Greek and Liturgics at the Virginia Theological Seminary; the other, the Rev. Thomas Lawson Cox, is Rector of the American Church in Geneva, Switzerland.

The Rev. Mr. Cox has been active in many clubs and civic organizations in Baltimore. He is a member of the Bachelor's Cotillion, St. George's Society, the London and Baltimore Branches of the English Speaking Union, the Newcomer Society, the Maryland Historical Society and others.

Mrs. Cox, like her husband, is a Southerner. She is descended on her father's side from a distinguished Virginia family. On her mother's side she is a member of the Goldsborough family of Maryland. She is a direct descendant of John Henry, the first Governor of Maryland. She is a member of the Junior League of Baltimore, the Baltimore Assembly and the Maryland Institute. She was educated at the Cathedral School for Girls in Washington, D.C., Gunston Hall Junior College in Washington, and the Maryland Institute of Art in Baltimore.

Consecration Service for St. Mark's Church

Sunday, November 28, 1954, will be an important day in the life of the congregation at St. Mark's Church. The Bishop will consecrate the Church building at 9 a.m.

Of particular interest to the members is the fact that the Rev. and Mrs. Edmund L. Souder will be present for this service. The congregation is bringing them back from Los Angeles, California, for this occasion, since the present Church was built under their leadership and through their devotion. The Rev. Mr. Souder will be preacher at this service. The Rev. Joseph Turnbull, present Vicar, will assist with the service of Consecration.

We congratulate this congregation on the erasing of their debt on this beautiful structure, which was completed in 1951 and dedicated on St. Andrew's Day of that year. The men of this Church helped make the bricks with which it was built. It was because of this that the United Thank Offering appropriated \$8,000 toward its completion.

Another bit of interesting news from St. Mark's Church is the fact that the Sisters of St. John the Baptist Morristown, New Jersey, are sending this mission a bell that they had in one of their missions. The bell weighs 600 pounds and will be rung for the first time on Thanksgiving Day at the Holy Communion service.

Election for Triennial

Mrs. Theodore O. Wedel, Washington, D.C., has been elected presiding officer of the Triennial of the Woman's Auxiliary, to be held in Honolulu, September 4 to 15, 1955. Mrs. Wedel's election took place at the recent quarterly meeting of the National Executive Board of the WA in Greenwich, Conn. Also elected was Mrs. Percy V. Pennybacker, Jr., of Austin, Texas, who will serve as assistant presiding officer.

Both Mrs. Wedel and Mrs. Pennybacker have been active in the national life of the Church, each having served as chairman of the National Executive Board of the Woman's Auxiliary. Both have also contributed to inter-church cooperation in the United States through membership in the board of United Church Women. This summer Mrs. Wedel and Mrs. Pennybacker participated in the Second Assembly of the World Council of Churches in Evanston, Ill. Mrs. Wedel, who has been actively engaged in the field of Christian education for many years, was a consultant to the Assembly, and Mrs. Pennybacker was one of the 14 official delegates from the Church.

As presiding officer, Mrs. Wedel will preside at sessions of the Triennial Meeting, at which 500 women will gather to guide the WA in its next three years of activity.

Her husband is the Rev. Canon Theodore O. Wedel, warden of the college of Preachers in Washington, D.C. As a resident of Washington, D.C., Mrs. Wedel has been prominent in capital affairs. She was a member of the Consumer Advisory Committee to the President's Council of Economic Advisors, a member of the Women's Joint Congressional Committee, a member of the Washington Board of Welfare, and vice chairman of the Citizen's Committee for the Washington International Center.

In Memoriam

The entire Diocese shared the sorrow of Mrs. Hollis H. A. Corey and her family in the passing of the Rev. Hollis H. A. Corey, who died at Daytona Beach, Florida, on October 20, 1954. The Rev. Mr. Corey was a retired clergyman from our Missionary District, having left Honolulu three years ago. He was former Vicar of Epiphany Church, Honolulu. He started his work in the Hawaiian Islands at Holy Apostles Church, Hilo.

The Rev. Mr. Corey was born at Kingscroft, Quebec, Canada. During his ministry he served as a missionary to Labrador, then returned to Canada to take charge of two different missions. He and his wife went to Japan in 1919 and came to Honolulu in 1929. He was Chaplain and instructor of Religious Education at Iolani School, then went to Hilo.

After retirement he assisted with St. Luke's Korean Mission, and served his former mission in Quebec and Labrador after his retirement to Florida, doing this work during summer months.

During this past summer he visited his daughter, Mrs. Mary Coffey, and son-in-law, who is studying for the ministry at the Church Divinity School of the Pacific, Berkeley, California. He fell and injured his knee. Upon his return to Daytona Beach, he underwent surgery on the injured knee, and never came out of the operation. He was buried from St. Mary's Church on Friday, October 22nd, with Bishop Conkling, retired Bishop of Chicago, and several clergy taking the service.

We remember him with great affection in this Missionary District, and give thanks to God for the contribution he made to the life and work of our Mission field. In 1951 the Bishop awarded him the Distinguished Service Cross for outstanding service to the Church in Hawaii.

The entire Diocese joins in sending our deep sympathy to his family, assuring them of our prayers and affection. He is survived by his widow, a son, David, living in New York City, and his daughter and two grandsons in Berkeley, California.

Tenders Resignation

Mrs. E. Tanner Brown, recently appointed hostess at our Army and Navy Center and Diocesan House, has tendered her resignation to the Bishop because of ill health. It is with deep regret that she has found it necessary to give up her work as hostess. She and her husband, the Rev. E. Tanner Brown, D.D., retired, left for the mainland on November 17th aboard the President Wilson, for California, where they will live.

We send them forth with our deep Aloha. It was a very happy experience to have them serving with us in this Missionary District again. We sincerely hope that Mrs. Brown will regain her strength after her return to the mainland.

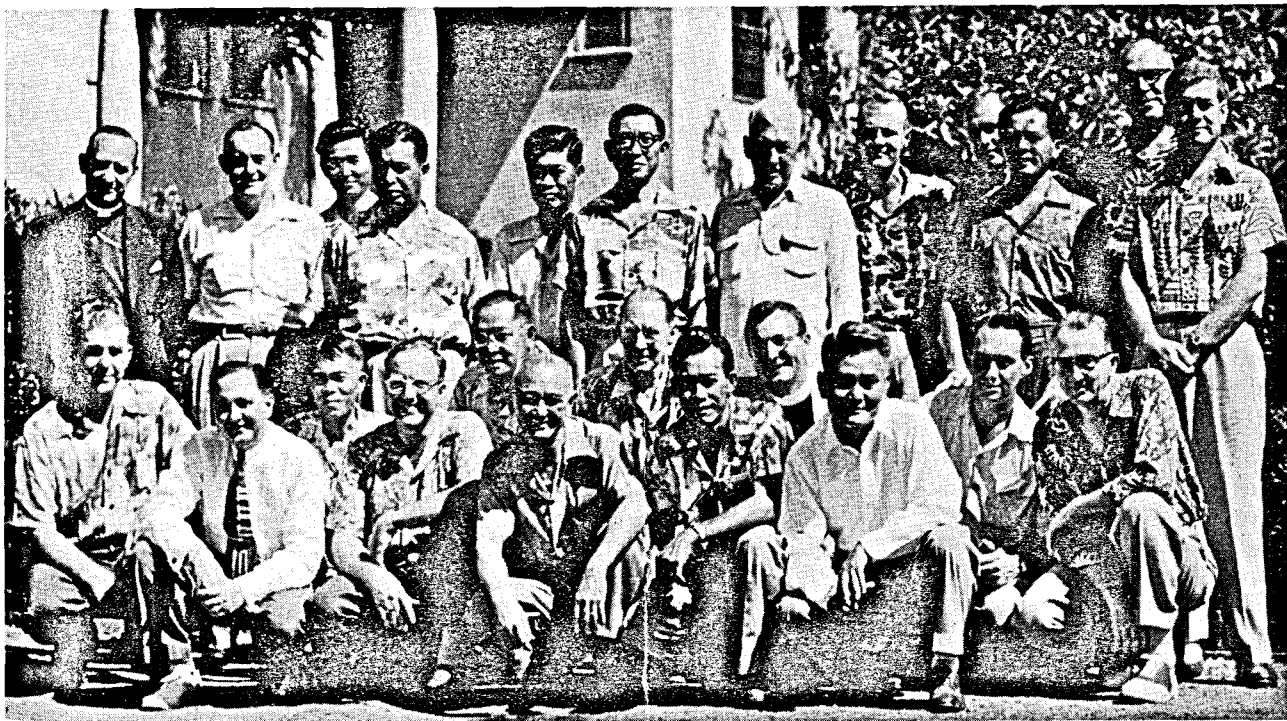

Changes at Cathedral

The City and County of Honolulu have taken off ten feet from the corner of the St. Andrew's Cathedral property to widen Emma Street at the entrance from Beretania. The work is progressing rapidly so that soon we can begin our own improvements of the Cathedral grounds.

Taking this ten feet from the grounds has effected our property at Cluett House and St. Peter's Church, as well, for this improvement extends beyond St. Peter's Church.

The floor in the Cathedral has given way in several places, so the Board of Directors and Cathedral Chapter felt that it was wise to proceed with one of the proposed plans for the improvements to the Cathedral — to place a cement floor in the Nave and Apse with cork tile in the aisles. The Chancel and Sanctuary will not be touched at this time, because this will be raised, when final improvements are begun. It was felt that the floor was unsafe with its constant usage. The new floor will be a tremendous improvement to the Cathedral.

To be Consecrated on December 4th

The Rev. Anson Phelps Stokes, Jr., Coadjutor-elect of the diocese of Massachusetts, and former Rector of St. Andrew's Cathedral, Honolulu, will be consecrated December 4th at Trinity Church, Boston, at 10:30 a.m. The Most Reverend Henry Knox Sherrill, Presiding Bishop, will be consecrator. Bishop Nash, of Massachusetts will be one of the co-consecrators.

The offering at the consecration service will go to the Rev. Philip P. Parmar, Bishop-elect of Bhagalpur, India, for his discretionary fund. The Rev. Mr. Parmar will be consecrated as the second bishop of the diocese of Bhagalpur, December 12th, in St. Paul's Cathedral, Calcutta, India. He was a recent delegate to the Anglican Congress in Minneapolis, representing the Church in India, Pakistan, Burma, and Ceylon.

The "Order for the Adoption of Children" was used for the first time on Maui late last month. Jane Gabriele Thomas, a German-born little lass, was adopted formally into the family of Mr. and Mrs. Richard Thomas, of the Wailuku congregation. Rector Claude Du Teil officiated. The service, to be found in the Book of Occasional Offices, provides for the child to be given from a sponsor to the mother, and has the father bestow the family name upon the youngster. A crowd of friends and churchmen overflowed the service, which was followed by the Baptismal service for little Miss Thomas and for young James Marion Talbott, also of Good Shepherd, and son of Mr. and Mrs. George Talbott.

General Maitland to be Ordained

Brig. Gen. Lester J. Maitland, commander of Michigan's state air force and a pioneer of the U.S. air force, announced that he plans to become an Episcopal minister within the next year.

General Maitland, who was the first to pilot an airplane across the Pacific to Honolulu, who once held the world's air speed record and whose World War II decorations include the Distinguished Flying Cross and Air Medal, said:

"I have a conviction that I can do more good in the ministry than in any other way. I have had to serve mammon, now I wish to serve God."

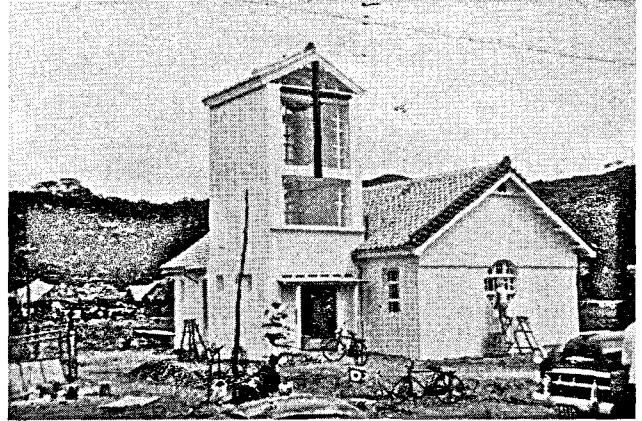
His revelation of his plans surprised even his home city, Lansing. He said he had long held the ambition to be an Episcopal minister, had determined on that career last year, and had studied quietly for it.

The 56-year-old flier, who also is director of civil defense in Michigan, said he has been studying since last February with the Rev. George Selway, rector of St. Paul's church in Lansing, and was accepted as a postulant in May by Bishop Herman R. Page of Northern Michigan.

A native of Milwaukee, Wis., the general joined the U.S. signal corps air service in 1917 on this country's entry into World War I and retired from the air force late in 1944 with the rank of lieutenant colonel.

Gen. Maitland was closely associated for four years (1921-5) with "Billy" Mitchell, who played a prominent role in founding the U.S. army air force. In 1923, he set what was then an amazing speed record of 244 m.p.h. for planes. He was awarded the Distinguished Flying Cross in 1927 for making the first non-stop flight from California to Hawaii.

The future minister was commander of Clark Field at Manila when the Japanese attacked the Philippines in 1941. He now also serves as personal pilot to Michigan's Gov. G. Mennen Williams.

News from the Far Pacific

The Rev. Canon William C. Heffner, in charge of our mission work on Okinawa, has been in Japan the past few weeks to visit our people who are studying in the seminary and kindergarten schools in preparation for their return to Okinawa to assist with our work there, and to get new priests to assist with the fast growing congregations. Bishop Yashiro and Bishop Nosse of Japan have promised a young man from each of their dioceses for next summer, following their graduation from seminary. He also visited the Rev. William Hio, who is studying the Japanese language before going to Okinawa to assist with the work.

The Rev. Theodore T. Y. Yeh, in Taipei, Taiwan (Formosa), has written that he has purchased property for his congregation so that they may work toward the building of their own Church. The people of this congregation are struggling hard with their meager funds to pay for this piece of property, since it will mean so much to them to have a church of their own in which they can worship.

Ordained to the Priesthood

Sunday, November 14th, the Most Rev. Michael Hinsuke Yashiro, Bishop of Kobe, and Presiding Bishop of the Nippon Seikokwai, ordained the Rev. Luke Teruo Kimoto to the Sacred Order of Priests at the Chapel of the House of Prayer, the Leper Colony, Airaku-en, Okinawa. He was assisted by the Rev. Canon William C. Heffner, the Rev. Harry S. Finkendaedt, and the Rev. Mr. Francis Shirai.

The Rev. Mr. Kimoto has dedicated his life to work with the Leper Colony. We join in prayer that his ministry may be rich with blessings.

Mrs. Elizabeth Mary Caoline Ault, widow of Dean William Ault of St. Andrew's Cathedral, and mother of the Reverend Norman C. Ault, St. John's Church, Kula, Maui, passed away on November 15th after an extended illness. She was a member of a kamaaina (old) family of the Islands.

Bishop Kennedy conducted the burial service at Parke Memorial Chapel, assisted by the Reverend J. Robert Jones. The clergy on Oahu were also in procession.

Mrs. Ault was born in Kohala, Hawaii. Her husband came from England to serve as a missionary at Wailuku, Maui, where he married Mrs. Ault. He died in 1951. They are survived by three sons, the Rev. Norman C. Ault, Mr. Ralph Ault, and Mr. Kenneth Ault, the latter two of Honolulu, and two daughters, Mrs. Marguerite E. Ewart III and Mrs. Mary Ault Tobin, and six grandchildren.

Mrs. Ault and her husband were instrumental in building the Memorial Building on the Cathedral grounds, and played a great part in the life of the Church in Hawaii. Her devout faith, fortitude in pain, cheerfulness in the face of death, gentle spirit, and thoughtful kindness to all with whom she associated will ever remain an inspiration to all of us. She will be greatly missed, but the good work she leaves behind her will live forever in the hearts of those who loved her.

The men of Holy Trinity Church have recently painted the floors and parish hall so that it looks most attractive. It is always a wonderful contribution to a church when the men join in such a task, and an enjoyable occasion for them because of the fellowship derived from such a project.

Don't be Afraid to Use your Minister

"In Case of Death"

If the minister is not already on hand at the time of a death in your family, call him immediately. He will come as a comforter, as a bulwark of your faith, and as a human being who understands your grief. He comes, too, as a representative of all the people who wish to give you their sympathy.

Don't let the funeral director make all the arrangements, set a time for the service, call the newspaper, and then, finally, tell the minister that he will be expected to officiate at such and such a time on such and such a day. If, in the confusion of your grief, you allow that to happen, you will have immeasurably lessened the minister's value to you at a time when you need him most.

The minister will come to see you as soon as he possibly can after he receives your call — and don't think you have to be a member of his church to call him. Later, before arrangements are made for the funeral, he will want to talk with you at length in order to plan services that will reflect the lives and personalities of the persons most affected. He can suggest ways in which the funeral service can be made easier and more meaningful.

He will call on you again after some of the confusion subsides. And his strong, wise counsel will help you face the long days ahead.

Another word about the troublesome subject of fees. As a rule the minister who conducts a funeral service does not wish to be paid a fee, but local custom should guide you in this matter. Don't depend entirely on the word of the funeral director, either, unless you are sure that he is quite familiar with the pastor's desires. If in doubt, wait a few days and then ask the minister what the custom is as tactfully as possible or send him a note of thanks with a check that he can use as he wishes.

To the town and seek Thee there.

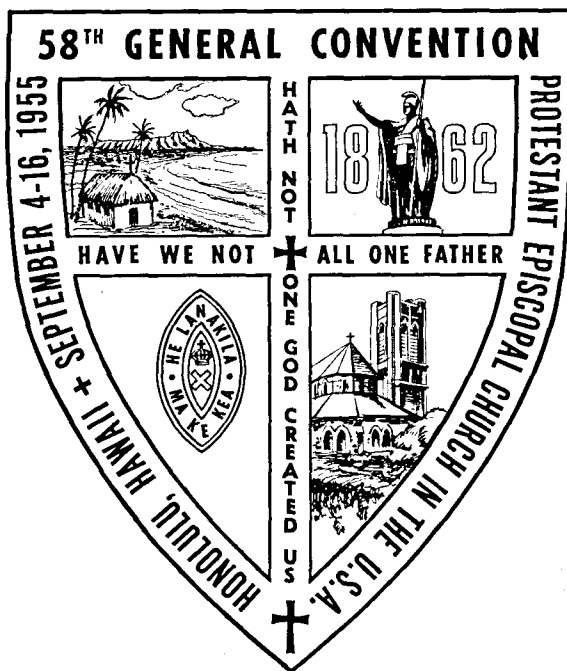
So I come down from the mountain-top

The Seal of the 58th General Convention in Honolulu

The upper left section pictures Diamond Head Crater, an extinct volcano, landmark of Hawaii; in the foreground, an early grass chapel of the native Hawaiians.

The upper right section has the statue of King Kamehameha IV, who was responsible for bringing the Church of England to the Islands in 1862.

In the lower left section is the seal of the Missionary District of Honolulu, the Cross and Crown, with the Hawaiian words: HE LANAKILA MA KE KEA, meaning "Victory through the Cross."

The lower right section pictures St. Andrew's Cathedral, Honolulu, link between the Church of England and the American Church. Jurisdiction was transferred in 1902.

The Cross, in the center of the Shield bears the text used in Hawaii depicting the life of our multi-racial population, "HAVE WE NOT ALL ONE FATHER? HATH NOT ONE GOD CREATED US?", Malachi, 1:10.

First To Australia

The Presiding Bishop, the Most Rev. Henry Knox Sherrill, has accepted an invitation extended by the Most Rev. Howard West Kilvinton Mowll, Archbishop of Sydney, to address the General Synod of the Church of England in Australia at its quinquennial meeting in October 1955.

Bishop and Mrs. Sherrill will leave for Australia immediately after the close of the 1955 General Convention in Honolulu next September.

Archbishop Mowll and Mrs. Mowll hope to attend our General Convention in Honolulu, as do other bishops in the Far Pacific. It is his hope that many of our dignitaries attending General Convention will be able to go on to Australia for the General Synod. Archbishop Mowll feels the holding of General Convention in Honolulu will do much toward moulding a firm link between the American Church and the Church of England.

Bishop Sherrill's visit to Australia will be the first by a Presiding Bishop of the American Church.

Iolani School Presented With School Flag

A very beautiful school flag has been presented to Iolani School by Mrs. Charles Regan in memory of her husband, who was on the faculty of the school for several years before his death. It is the first time the School has had such a flag.

It was presented at the chapel service on All Saints Day, at which time Canon Frederick McDonald, Headmaster, had special prayers.

The Iolani colors are in the seal of the school. The black stands for sobriety of purpose, the white for purity of intention, and the red for valor. This flag is a very beautiful addition to the School.

St. Luke's Korean Mission Honor New Vicar

The Reverend Paul Kim, who has just taken over the work of St. Luke's Korean Mission as Vicar, was honored by the members of his congregation at a reception, held in the Diocesan House on Sunday, November 21st, from 4 to 5 p. m.

The Rev. Mr. Kim is now trying to get his wife and two children to Honolulu from Korea. Both of the children are potential students for the University of Hawaii.

Caesar Gets His

From time immemorial governments have levied taxes upon their subjects and have collected them. There isn't a nation on the face of the earth today where common people are not burdened with a great deal of *Unnecessary* taxation. It is impossible to buy anything anywhere without paying a hidden tax. We are told that out of every federal tax dollar 80 per cent goes to pay for wars, past, present or anticipated. We have no option in the matter. We must pay our taxes, or else . . . What we do for our government under *Compulsion*, we ought to do for Christ and the Church because of our *Love*.

"It Sure Does"

At the outset of World War II, some of our young soldiers landed in Hawaii and went to church. It was a cosmopolitan church, carrying out the spirit of Christ regarding brotherhood, and one of the pastors officiating on that communion Sunday was an American of Japanese descent. A soldier was heard to murmur, "We go half way around the world to fight the Japs, and we kneel here to be served communion by one of them. It sure does beat hell!" Later the pastor in charge wrote an article entitled, "It Sure Does." The spirit of Christ as expressed in that service is the only answer that drives the devil of derisive hatred out of human relationship.

Aims of Church School

- To form in the child early concepts of God as the ever powerful, ever loving creator of all things.
- To teach the child that he is a part of God's world.
- To teach the child to speak to God through prayer.
- To teach respect of the Church as a special place of worship.
- To lay the foundation for our form of worship.
- To teach the child to regard the Bible and Prayer Book as Special books.
- To teach the basic rules of good Churchmanship.

Too Busy to Pray

The excuse so many people offer for not praying is the most unconvincing argument of all: *They are too busy to pray*. Too busy to pray! We are never too busy to have

a second cup of coffee in the morning nor to have a smoke after our evening meal. We are never too busy to follow the latest adventures of Dick Tracy in the comics or *I Love Lucy* on television. We are never too busy that we fail to read the daily newspaper or the new novel from the book club. But we are too busy to pray! So busy in our hustle and bustle with trivial things that we can't give a few minutes to the Lord of the universe. So busy with meat and drink that we can't talk to the eternal.

Why Confirmation?

The rite of confirmation in the Episcopal Church is sometimes confusing to our non-Episcopal friends. "Why is it necessary?" they ask.

It is necessary, we believe, because this Sacrament came to us from Christ's Apostles. In the early Church the Apostles administered Confirmation and transmitted this authority and practice to their accredited successors, the Bishops of the Church.

Known generally as "laying on of hands," Confirmation is today the ceremony in which the person confirmed, after instruction in the faith and practice of the church, reaffirms and takes upon himself the obligations of Christian fellowship.

We believe firmly in the effectiveness of the laying on of hands of the Bishop, who as an ordained and consecrated Apostolic successor, prays that the strengthening help of God's Holy Spirit will descend upon the confirmed. You will find Scriptural authority for the rite in verses 12 to 18, Chapter 8, Acts of the Apostles.

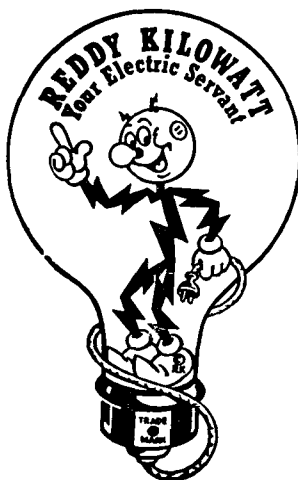

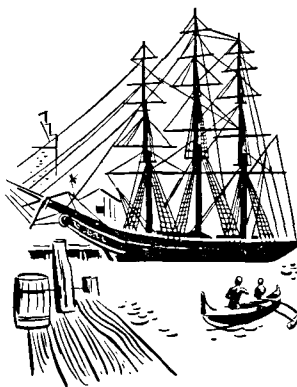
