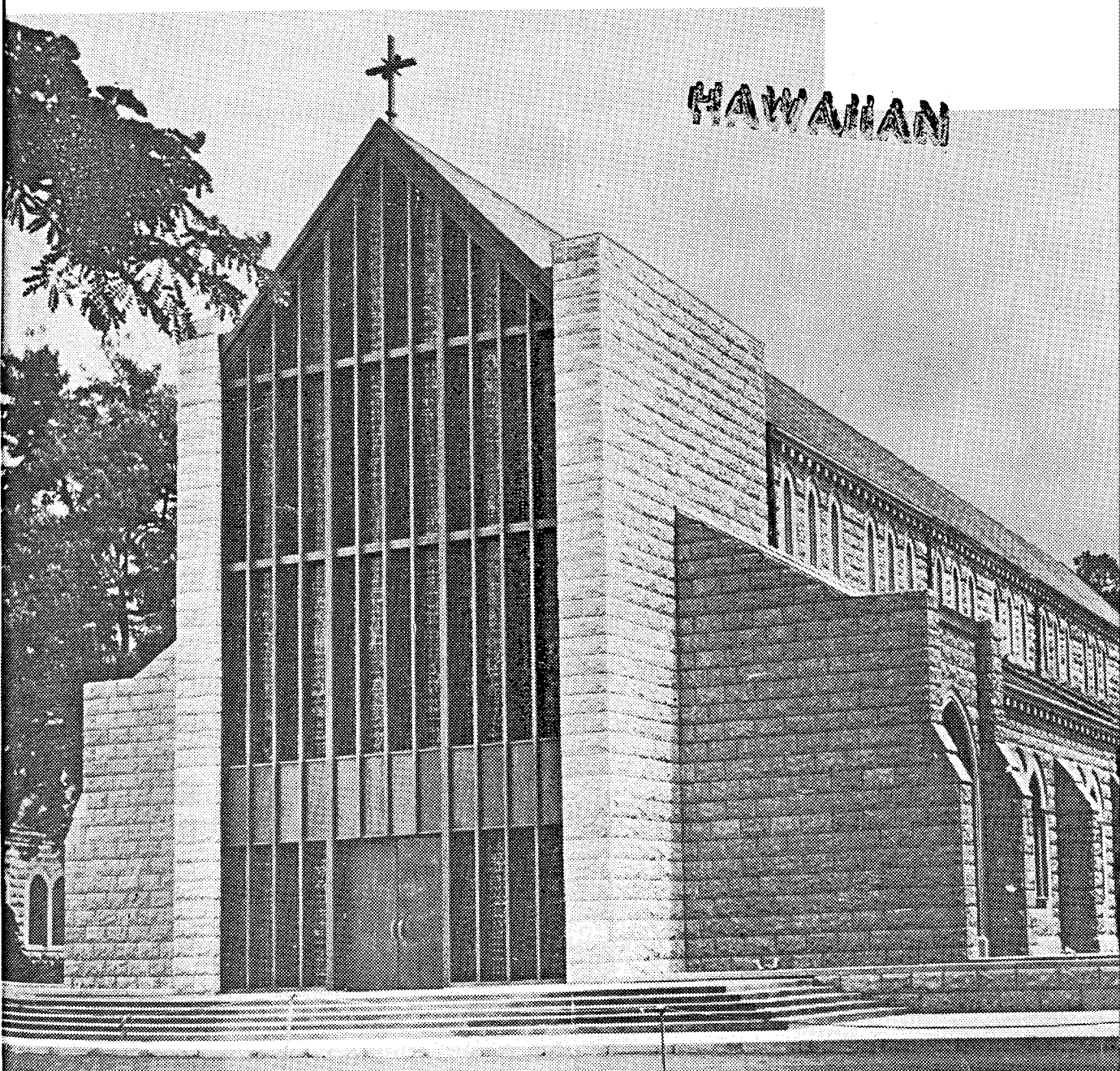

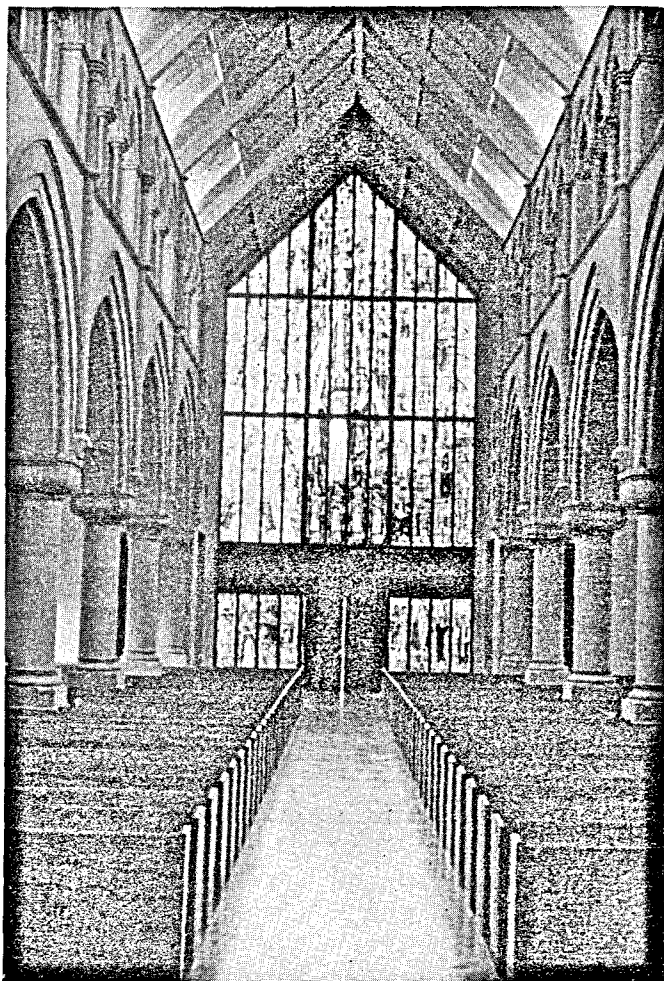

St. Andrew's Cathedral Completed

St. Andrew's Cathedral was packed to overflowing on Sunday afternoon, September 21st, when the dedication service for the completed Cathedral took place, at 4 p.m. The Bishop had the service of dedication and was the preacher. He was assisted by the Very Rev. James S. Cox, Dean, and Canons Norman C. Ault, Charles T. Crane, Frederick A. McDonald and Wai On Shim. Clergy on the Island of Oahu were in the procession. All of the Cathedral choirs sang for the occasion, directed by Mrs. David M. Thorndike, Organist and Choir Director.

Dean Cox extended greetings and appreciations to those who made this long-wished for occasion a reality. The Bishop expressed appreciation to all who shared in making this possible, but especially did he commend Dean Cox for his great share in bringing this project to a happy conclusion. He was untiring

in his zeal to see everything was in order during the months of construction.

The Building Committee was chairmaned by Mrs. Walter Dillingham. The Campaign Committee for the raising of the funds for the extension was headed by Mr. Harold Dahlquist and Mrs. Mary K. Robinson.

Architect for the completed Cathedral was Carleton Monroe Winslow, A.I.A., of Beverly Hills, California; General Contractor, Hawaiian Dredging & Construction Company, Masonry, Valdastris, Ltd., and designer of the Great West Window the Wallis-Wiley Studio, Pasadena, California.

The west end of St. Andrew's Cathedral is a lustrously shining wall of stained glass. It measures approximately fifty feet in height and twenty in width, and is one of the largest windows ever made in the United States. Designed by John Wallis in 1956, it harmonizes with the other portions of the Cathedral building, a rare American example of early French Gothic architecture. The technique used in the window is the same as that in the windows of the cathedrals of Chartres and Bourges, and results in a brilliant mosaic of glass with a minimum of drawings in enamel. All of the glass is handblown and was carefully selected from the work of glassmakers in France, Germany, Belgium, England and the United States. It is the gift of Mrs. Walter Dillingham "To the Glory of God and in loving memory of Elizabeth Mitchell Adams (her mother) December 9, 1861—October 16, 1938.

The bronze doors are the gift of Mrs. C. Montague Cooke, Jr., "To the Glory of God and in loving memory of C. Montague Cooke, Jr., December 2, 1874—October 29, 1948."

Following the service a reception was held on the Cathedral lawn, honoring the Bishop, who had just returned from Lambeth Conference, and Dean and Mrs. Cox, who had been on a three-months' furlough to the mainland.

Delegates off to General Convention

The Bishop left on September 22nd for General Convention. Enroute he spoke to the Diocesan Woman's Auxiliary in Chicago, Illinois, and at the Church of the Advent, Birmingham, Alabama. Mrs. Kennedy, who had been visiting her family in Greeley, Colorado, during the weeks the Bishop was in Honolulu following Lambeth Conference and his departure to General Convention, met the Bishop and her son, Paul, who is a jet pilot stationed in Birmingham, in Birmingham. The Bishop preached at the Church of the Advent on Sunday, September 28th. He then went on to Miami Beach, Florida, on September 29th for the meeting of the Overseas Bishops,

prior to the opening of General Convention.

Mrs. George Goss, Mrs. Gordon Halstead, Mrs. Harold Shim, of Kula, Maui, and Mrs. William Jarrett left for the mainland the week of September 22nd. Mr. and Mrs. Arthur G. Smith left on September 13th for a stay in San Francisco before traveling on to Miami Beach. Mr. Smith is our Lay Delegate. Mr. and Mrs. James Kau left the week of the 28th. Mr. Kau is our Alternate Lay Delegate. Canon Paul R. Savanack left the 3rd of September to visit his family in Ohio before going on the Florida. He is our Clerical Delegate.

General Convention opened on October 5th and will close on the 17. Following the Convention the Bishop will be on a speaking tour of the Diocese of West Texas.

Expression of Appreciation

The Bishop and Diocese wish to express deep gratitude to the Very Rev. Paul Roberts, retired Dean of St. John's Cathedral, Denver, Colorado, and Mrs. Roberts for the great contribution made to the work in our Islands for the eleven months they were in our midst. They made a myraid of friends who greatly miss them.

During the time that they were in Hawaii, Dean Roberts gave his services to St. Christopher's Church, Kailua, for three months, when this congregation was without a Rector; to The Church of the Good Shepherd, Wailuku, Maui, for three months during the interim there without a Rector, and to St. Andrew's Cathedral for three months, while the Dean was on furlough.

It was a delight and inspiration to have them in our midst. We reluctantly bid them Aloha. They are now assisting at Trinity Cathedral in Phoenix, Arizona, where they are without a dean.

Holy Nativity Dedication Service

The beautiful new parish hall at the Church of the Holy Nativity will be dedicated by the Bishop on November 23rd at 10 a.m. The Reverend John J. Morrett and the Rev. Richard L. Aiken will assist.

This will be a great occasion for the church in Aina Haina. A class of confirmation will also be presented at that time.

This new parish hall is a wonderful achievement for the Church of the Holy Nativity and will mean much to the community and Diocese, as well. We hope as many as possible can be present for this service.

Bishop Block Dies Suddenly

"The Bishop sat, as he had sat so often before, in his episcopal chair before a group of candidates for Holy Orders, asking the prescribed questions. Suddenly he broke off the questioning and turned to Bishop Shires, his newly retired suffragan. With what was almost literally his last breath, he said, "Bishop, will you continue, sir?"

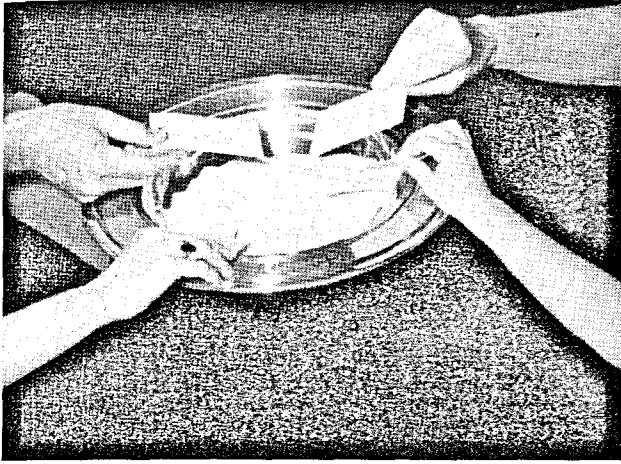
In a moment the Rt. Rev. Karl Morgan Block, Bishop of California, was dead. Few in the Church realized it, for the Bishop remained seated erect in his chair, and it was not a new thing for the Bishop to have to ask for help in completing a service. During months of illness, he had been subject to attacks which made speaking impossible.

But the Rev. Canon Richard Byfield, standing close to his chief, saw the twitching of hands, saw a marked change in the color of the Bishop's face. A priest-physician made a hasty examination and instructed those nearby to move the Bishop to the sacristy. Bishop Shires went on to finish the service in ignorance of the death of the diocesan—as were the three ordinands."

Bishop Block's death on September 20th came as a great shock to not only his Grace Cathedral staff and congregation, but to his diocese and his many friends in Hawaii. We extend our great sympathy to the Diocese of California. The Church at large has lost a great Christian leader.

The Rt. Rev. James Pike, recently consecrated Co-adjutor of California, became the Diocesan upon Bishop Block's death.

The Living Church goes on to say, "It was the closing scene he himself would have chosen. At the height of the characteristic action reserved to the episcopate, garbed in full vestments, pectoral cross and ring, his crozier near at hand, the last rites of the Church he loved being spoken over him—this he would have seen as 'decent and in order'. And he always insisted upon that."

The Rev. Lawrence Ozaki Called by Death

A profound sense of sorrow has come to the Diocese in the passing of the Reverend Lawrence Hiroshi Ozaki, Vicar of Holy Trinity Church, Honolulu, on Monday, September 29th, at St. Francis Hospital, Honolulu. Death came after a very short illness. He underwent surgery the day before his death and was on the operating table seven hours.

His presence will be greatly missed in his Church and community. He was a beloved priest and devout Christian. Many community leaders outside of our communion extended sympathy to his family and the Diocese because of his Christ-like service to his fellow men.

Born in Hiroshima, Japan, he came to the Islands when a young man to enter the Hilo Palmer College. He was a graduate of Defiance College, Defiance, Ohio, and Auburn Theological Seminary. He was ordained Deacon in 1942 by Bishop Littell and Priest in 1943 by Bishop Keeler.

He has served as Vicar of Holy Trinity Mission, Honolulu, since 1942. This Mission was founded by his father-in-law, the Reverend Philip T. Fukao.

He is survived by his wife, Grace, and three children, Miriam Kiyoko, Myra Yasuko and John Hitoshi, his father-in-law, as well as his mother, Mrs. Fujiyo Ozaki, and three brothers.

In February 1955 he was awarded the Bishop's Distinguished Service Cross of the Diocese.

During his ministry at Holy Trinity Church he built a new church and had greatly improved his property on School Street. He also purchased a new

Seminarians in Tragic Accident

Friday, October 10th, two of our seminarians at the Church Divinity School of the Pacific, Berkeley, California, met with a serious accident. They were on their motorcycles enroute to the football field when a fire truck struck them. Norgren Bradley Allen, a Middler at the Seminary, was killed instantly. William Hamilton Aulenbach, Jr., also a Middler, was seriously injured, having suffered a compound fracture of the leg, a bad cut on the thigh and minor injuries. He is improving.

Bradley Allen is survived by his wife, Annette, and three small children. Another child is expected in February. He is also survived by his parents Mr. and Mrs. Howard Allen, of Whiterocks, Utah.

William Aulenbach is the son of the Rev. and Mrs. William Aulenbach, of Christ Church and St. Michael's, Germantown, Pennsylvania.

Bruce Kennedy, a classmate of the young men called his father in Miami Beach to inform him of the accident.

Bradley Allen had been a member of the Bishop's Sunday School when in Denver, Colorado. Both he and Bill were stationed at the Kancohe Marine Base before entering seminary, and assisted the Rev. William R. Grosh at Calvary Church. They were both Candidates for Holy Orders from Calvary Church.

Our prayers and deep sympathy are with Mrs. Allen at this time.

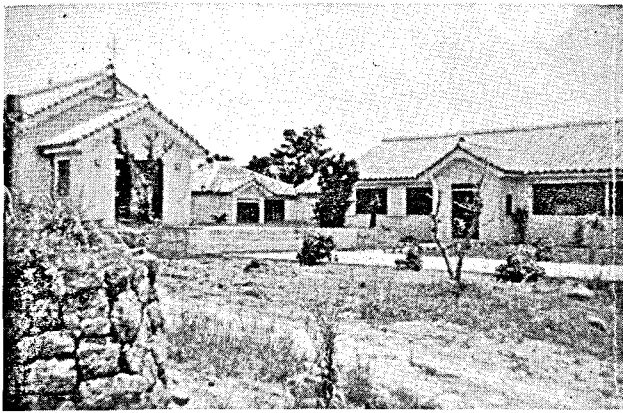
St. George's Church Consecrated

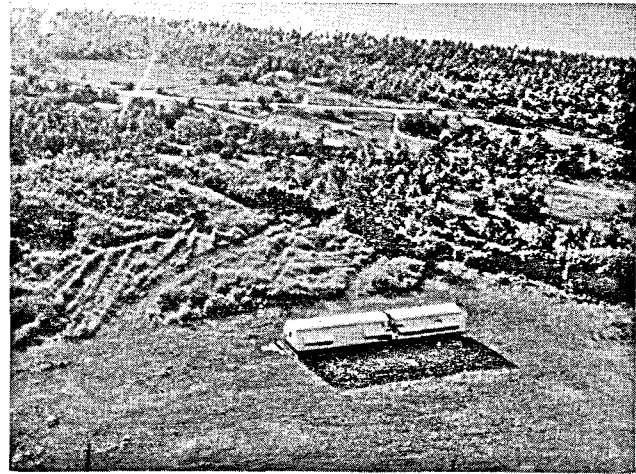
Members of the congregation are now looking forward to the time when they can build a new parish house, which is very much needed.

Episcopal Young Churchmen on Guam

"Know your Island" is the theme that young people have adopted on Guam. Organized in June, the E.Y.C. on Guam has grown steadily.

Meetings are held semi-monthly in the Vicarage. Beginning with a supper prepared by the parents and served by the young people, the group then holds a regular meeting to discuss their program and projects.

The program at the moment is an emphasis upon knowing the island and its people. During the week on which the community celebrated the liberation of Guam from the enemy, the young people saw the official U.S. Navy films on the retaking of Saipan and Guam. Through this film each member developed a greater appreciation of the tremendous strives taken by the community to rebuild after the capital city and neighboring villages were literally destroyed from the ravages of the battle.

The group has adopted three service projects: caring for the infants in the nursery during church hours; starting "slips" etc., to landscape the new church site; and maintaining the grounds about the Vicarage.

We hope that some of the young people in the Hawaiian islands will write to us. Remember that we are three thousand miles away from you and although we would like to participate in Diocesan doings we can't because of distances. The only way we can share with you is from your letters. Write and tell us about your programs.

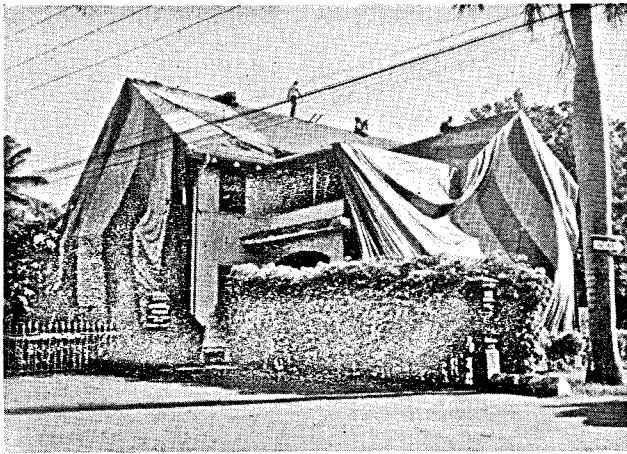
Funds raised by the group will be directed towards furnishing the parish hall of the mission.
