Convocation Highlights

Opening Service

The Opening Service of Convocation was one of the most colorful in our history. The Cathedral was packed to overflowing to hear the guest speaker, The Right Reverend Anson P. Stokes, Jr., Bishop of Massachusetts, and former Canon of St. Andrew's Cathedral. His address was simulating and inspiring.

The procession of bishops, clergy and the choirs on Oahu, was impressive. All the Islands had colorful banners carried by Acolytes, including Guam. The Reverend Grosvenor M. Needham, our missionary in charge of the work there, and Mrs. Needham were here for the Convocation.

Delegates Elected To General Convention

Clerical Delegates elected to General Convention, to be held in Detroit, Michigan, in September, were the Reverend John J. Morrett, Delegate, and the Reverend Claude F. Du Teil, Alternate. Mr. Arthur G. Smith, our Chancellor, was elected Lay Delegate and Mr. Andrew Seki, Alternate.

Epiphany Church, Honolulu, petitioned for parish status at this Convocation. The Reverend Burton L. Linscott is Rector. Emmanuel Mission, Maunawili, with the Reverend Iver J. Torgerson, Vicar, was recognized as an organized mission of the Diocese. All Saints Church, Kapaa, Kauai and St. George's Church, Pearl Harbor announced that they are assuming full responsibility for the salaries and pensions of their Vicars. All of these announcements are of great importance to our program of more self-support.

Endorse Episcopal Centeninal Advance Program

The Convocation went on record as heartily endorsing the plan of the Episcopal Centennial Advance Program, to raise \$375,000. This program is to help achieve self-support, obtain capital funds for buildings, conference centers, girls' school, and to assist our Church Divinity School of the Pacific, where we now have twelve of our island young men preparing for the ministry.

Episcopal Churchwomen Of Hawaii

An over-flowing Tenney Memorial Hall of Episcopal Churchwomen of Hawaii started their 59th Annual Meeting on a note of enthusiasm. They were called to action to support efforts to become a self-supporting, rather than a missionary, diocese.

The Reverend John J. Morrett, Clerical Chairman for the Episcopal Centennial Advance Program, cited the Church's needs and said that Episcopalians must pay their own diocesan costs and care for their local missions.

The women voted to accept the Bishop's Specials and pledged \$3,033 for the Bishop's Discretionary Fund, \$1,160 for the Seminarian Fund, \$1,230 for Emmanuel Mission, and \$800 for camp equipment at Kamuela, Hawaii.

The Nominating Committee, headed by Mrs. Earl

Goris, presented the following for the Diocesan Executive Board: Mrs. Gordon Halstead, second vice-president; Mrs. Harold Shim, vice-president for Maui; Mrs. Takeichi Higa, vice-president for West Hawaii; Mrs. Charles Afong, Altar Guild Secretary; Mrs. James E. Kau, Church Periodical Club Secretary; Mrs. Eric Wakefield, United Thank Offering Secretary; Mrs. G. H. Ward and Mrs. Charles Birnie, Nominating Committee Members. All were elected. Five delegates who are to be sent to the Triennial Meeting of the Women in Detroit, are: Mrs. Victor Punua, from Kauai; Mrs. William K. Jarrett, Mrs. Willard Buscher, Mrs. Thomas Brodhead, and Mrs. James E. Kau, from Oahu. Alternates for the Triennial are: Mrs. Eric Wakefield, Mrs. Joseph T. Lucas, Mrs. Carl Pischel, and Mrs. Tim Chong Young, from Oahu.


These gatherings give the women on Oahu the unique opportunity to share the fellowship of their fellow church-women and to participate in the Chain of Prayer which continues throughout the morning.

The highlight of the evening was the tale of the early days of St. John's-by-the-Sea told by Keona Joe Kona. He was among the Hawaiian swimmers who dismantled the old Libby Warehouse—soon to be church—and floated it around the shore to the first location of St. John's. A dozen or so of the members present at the dinner were there also for the opening service. The crucifer on that day in 1930 is now a member of the Bishop's committee and the carpenter to whom St. John's owes all the fine work in its new pavilion.

Holy Apostles Has New Site


Time and progress have changed the downtown Hilo area into a commercial and business district, which has caused the Church to sell the site of the Church of the Holy Apostles on Waianuenue Street to the Texas Oil Company for the construction of a service station.

We have been fortunate in being able to purchase two acres of government land adjoining the Hilo campus of the University of Hawaii. Immediate plans call for moving St. James' Hall to the new site to be used for services until a new Church building can be erected. Future plans call for the construction of a new Church, educational building and vicarage. The lovely old koa wood panel and altar, including memorials, have been moved from the old Church building and together with the stained glass windows, will be a part of the new Church.

The Venerable Gerald P. Loweth, vicar, held the first service in the new location on Ash Wednesday.

Special Convocation Guest Challenges Us

If any delegate at the Special Convocation had any qualms about the possibility of raising the \$375,000 for the Episcopal Centennial Advance Program, he had all doubts dispelled by a tremendously dedicated layman—himself a one time Chairman of an Advance Program—who came to us from Los Angeles, at his own expense, to tell our people that they could do the job.



St. Augustine's, Kohala, Hawaii new Vicarage

Rectory Blessed

The new vicarage, built mainly by members of the Kohala Missions, Hawaii, and more particularly by the Vicar, the Reverend Masao Fujita, was blessed on Sunday, January 15th.

Budgeted at \$8,000, the vicarage is an open beam type of home with two bedrooms. Construction began on October 22, 1960. All work, except the foundation, plumbing and electrical wiring was done by the congregation. They celebrated the occasion with an open house and luncheon, which was held in the parish house.

Chester A. Rude, the "Voice of experience"—a nationally-known banker and outstanding Episcopal layman, declared, "I can't believe from what I know of the people in Hawaii that you can't do what other dioceses have done. Your biggest step has been taken—the decision to carry on this program."

Mr. Rude pointed out that he had been involved not only in the Episcopal Advance Fund of Los Angeles, which was oversubscribed, but also in others equally successful.

"Do the capital needs of the Diocese mean as much to our daily lives as do our luxuries?" He asked, "What financial sacrifices are we making for our Church? What do we spend on luxuries? Are we giving our kids a dime for Sunday School and \$1 or \$2 for a show?"

Last year he said \$29 billion was spent for pleasure—\$2 billion for the Church. He then gave some examples for comparison: "a \$100 pledge is \$3.33 per month for 36 months—a coke a day; a \$270 pledge, \$9 per month, is a pack of cigarettes a day (\$7 billion was spent last year for this item); \$720 is \$20 per month, a highball a day.


"Each generation," he said, "has one opportunity to do something special for their Churches. Let's match our money spent for luxuries and see our Church move forward!"
