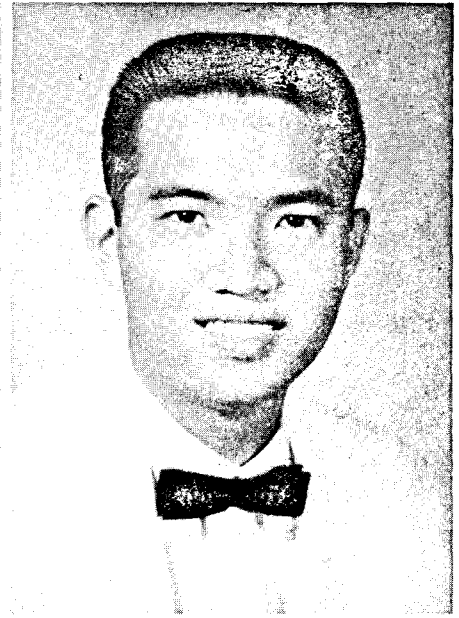

Improvements at Seabury Hall

A 20'x60' swimming pool, an anonymous gift of a member on Maui, has been built.

A 200 person capacity St. Paul's Chapel, the gift of Mrs. C. Montague Cooke, Jr., is now in erection. We hope to have this completed by Christmas. Most of the interior furnishings are gifts of Mrs. Cooke's family. The pews are a gift from Mrs. George Sumner in memory of her husband. Mr. and Mrs. William Fraser are giving the organ and the hymn books are given in memory of Reynolds Brodie McGrew.

Two new classrooms have been added. Cedar Home, the Headmaster's residence, will soon be completed and the former home will be converted into duplex apartments for the faculty.

The son and two daughters of Dr. and Mrs. Will Baldwin are giving a tennis court, honoring their parents, which is near completion.

The downstairs of the dormitory is now ready for occupancy.

Diocesan Offices Moved

September will see the Bishop and his staff in their new location on Queen Emma Square, to be known as the Diocesan Compound. The former offices will be used by St. Andrew's Priory School. The new offices will be far more convenient for everyone concerned.

Three apartments have been built on the second floor of the former Cluett Apartments.

To St. John's-by-the-Sea

The Reverend Richard A. Kirchhoffer, Jr., former Vicar of St. Timothy's Church, Aiea, is now Vicar of St. John's-by-the-Sea Mission, Kahaluu, having taken over his duties as of August 1st. The Rev. Victor H. Krulak, Jr., former Vicar, is now assisting at St. Peter's Church, Honolulu.

Aloha to Mrs. Aaron

Mrs. Thomas Aaron, who for the past eleven years has been hostess at the Army and Navy Center and Diocesan House, resigned as of June first to move into an apartment with her older daughter.

We wish to express appreciation for the years she gave to the Center and wish her well in her retirement.

Furloughs, Clerical Changes

The Reverend Albert Collins, Vicar of the Kohala Missions, left with Mrs. Collins for furlough on August 16th. During his absence the Rev. Thomas K. Kunichika, Chaplain for the Hawaii Preparatory Academy, Kamuela, held services for him. He also took services at St. James' Mission, Kamuela, for the Rev. James S. Nakamura, who is recovering from an automobile accident. Upon Mr. Collins' return he will become assistant to Archdeacon William Grosh, of Holy Apostles Church, Hilo. He and Archdeacon Grosh will have St. Columba's Paauiilo, and St. James', Papaaloo in addition. They have been ministered to by the Rev. Mr. Nakamura, who will now be in charge of the Kohala Missions in addition to St. James', Kamuela. The Collinses will live in Hilo. This is the fourth of the "Team Ministries" started by the Bishop.

The Reverend Iver J. Torgerson, Jr., Vicar of St. John's Church, Kula, Maui, and Mrs. Torgerson left for furlough. While on the Mainland the Rev. Mr. Torgerson will attend the College of Preachers, in Washington, D. C. He will also attend an Institute for Advanced Pastoral Studies at Bloomfield Hills, Michigan.

To St. Timothy's Church, Aiea

The Reverend Fred G. Minuth, who has been Associate Rector of Holy Nativity Church, Aina Haina, and in charge of the youth work and day school, is to be the Vicar of St. Timothy's Church, Aiea. We know that he will find this a most rewarding ministry. He, his wife and three children will be in residence in October.

Philippine Independent Church to Add a Priest

The members of the Philippine Independent Church on the Island of Maui have formed a congregation that meets at Good Shepherd Church, Wailuku. They have requested that an Ilocano speaking priest be brought from the Philippines to minister to them.

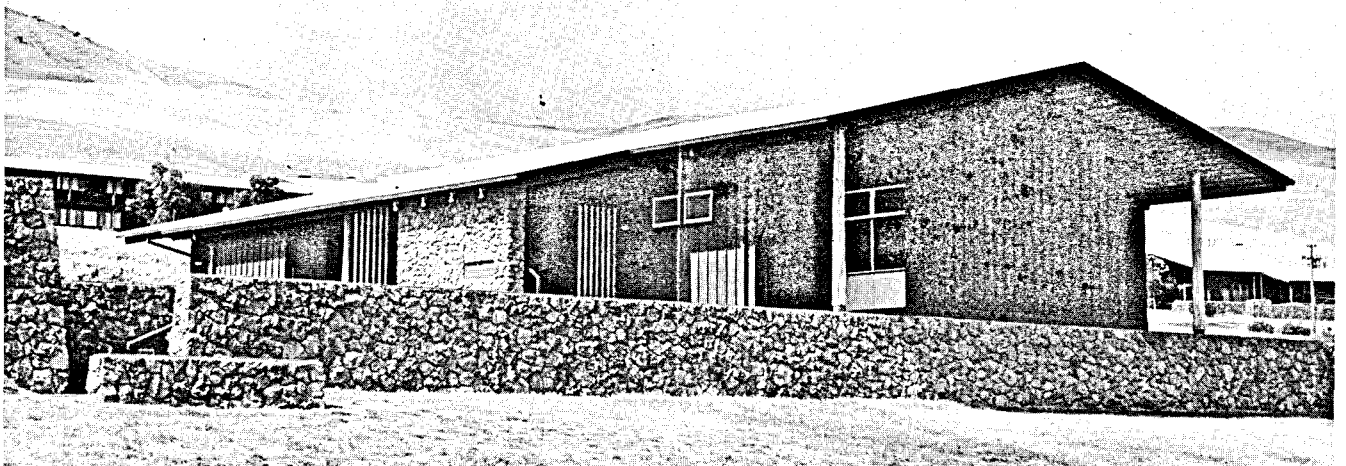

Members of Good Shepherd Church are undertaking the responsibility of his salary, living quarters, car, etc., as their share in MRI.

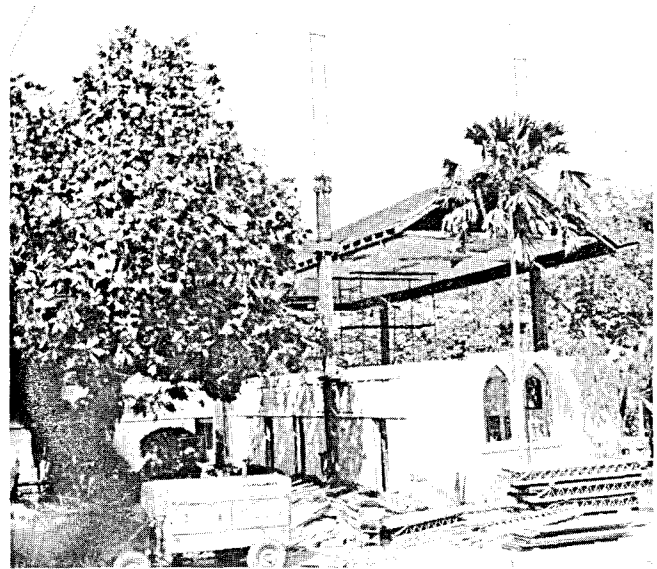
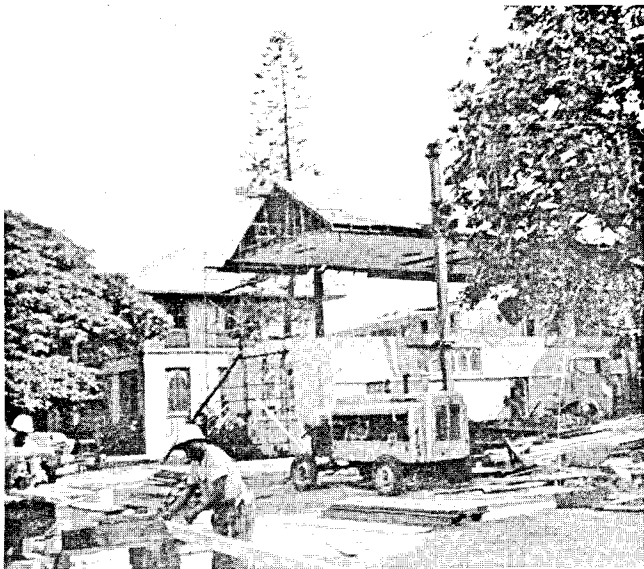

The Reverend Furman C. Stough, formerly of Grace Church, Sheffield, Alabama, stopped in Honolulu for three days in late July enroute with his wife and two attractive daughters, Leslie and Mary Leisa, for All Souls' Church, Naha, Okinawa, where he is to be the Vicar.

Mr. Joseph Sams, his wife and two small children also stopped in Honolulu for three days before traveling to Okinawa to take up his duties as program director of the Service Center for the military personnel on Okinawa, at Naha. He has had considerable training and experience with this type of work.

We feel sure that these two families will strengthen the work on Okinawa and rejoice that they are a part of our Diocesan Family.

We wish to bid the Reverend Frank Toia and his family Aloha as they leave Okinawa to take up work in Central America. He has been in Okinawa for the past three years, serving at All Souls' Church.

MRI 6-Step Start at Renewal

The Church must be seen as one of "God's agents of change." A commission appointed to lead Episcopalians in this said that one or more of the steps may be taken immediately, either by individuals or groups:

- Episcopalians should begin their renewal by prayer for mission, perhaps following a systematic plan for

intercession such as that provided by the Anglican Cycle of Prayer.

- Churchmen should seek to open correspondence with Christians in other lands.
- Those who travel abroad "should enter appreciatively into the experience of the churches in these countries" and ways should be developed "to use the abilities and experience of lay people who live, work or travel abroad, both in their overseas situations and in their reports to their home parishes."
- Every aspect of Christian education in the parish should be structure to "place first in importance our commitment to Christ and obedience to His mission."
- Companion relationships between parishes or dioceses at home and abroad must be seen as tools to "help all concerned to deepen their personal understanding of interdependence one with another, and must open doors to wider appreciation of the diversity of cultures represented in the respective companions."
- Churchmen should "search out for ways of becoming involved in responsible agencies and programs not officially connected with the Church, but designed no less to relieve human suffering and improve the conditions and opportunities for human lives."

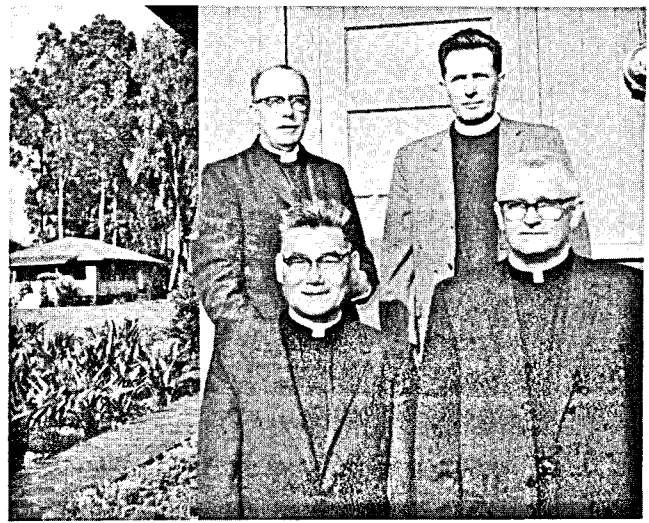
Wrote the commission members: "Church people are not asked to impress the world, much less themselves, by building up the Church's status as an institution and by seeking for it favor and privilege.

Rather, we are to enter fully with our Lord into the pain and travail of human life in all its sorts and conditions, to spend and be spent in His service."

KILLED IN CRASH ON HAWAII

Mrs. Magdalene Nakamura, wife of the Rev. James S. Nakamura, Vicar of St. James' Church, Kamuela, was killed instantly on August 11 in a head-on collision at the crest of a hill. The Rev. Mr. Nakamura was critically injured, having multiple fractures and a punctured lung. His daughters, Lillian 18 and Audrey 12, were also injured. Also injured was an employee of the County Board of Water Supply.

The Nakamuras were on their way to Hilo and the man who collided with them on his way to Kamuela. They were on the Saddle Road where a dip and hill combine to make the spot extremely hazardous. The accident took place at about 8:26 a.m.

Services for Mrs. Nakamura will be held after the Rev. Mr. Nakamura is released from the hospital at St. James' Church, Kamuela.

During a visit with the Bishop of Rome, President Eisenhower asked the Pope how many people worked in the Vatican. The Pontiff replied, "About half of them."

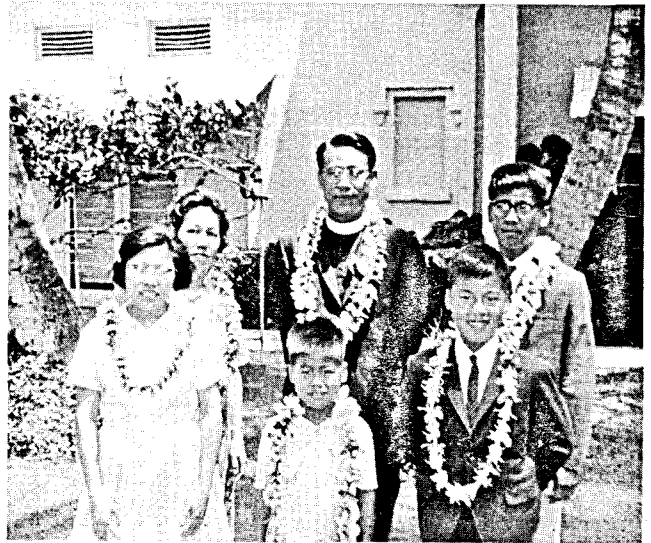
BY WILL AND DEED

Dominick, the widow of Gayer Dominick, remembered Holy Nativity Church and the Diocese. Mrs. Martha E. R.
