

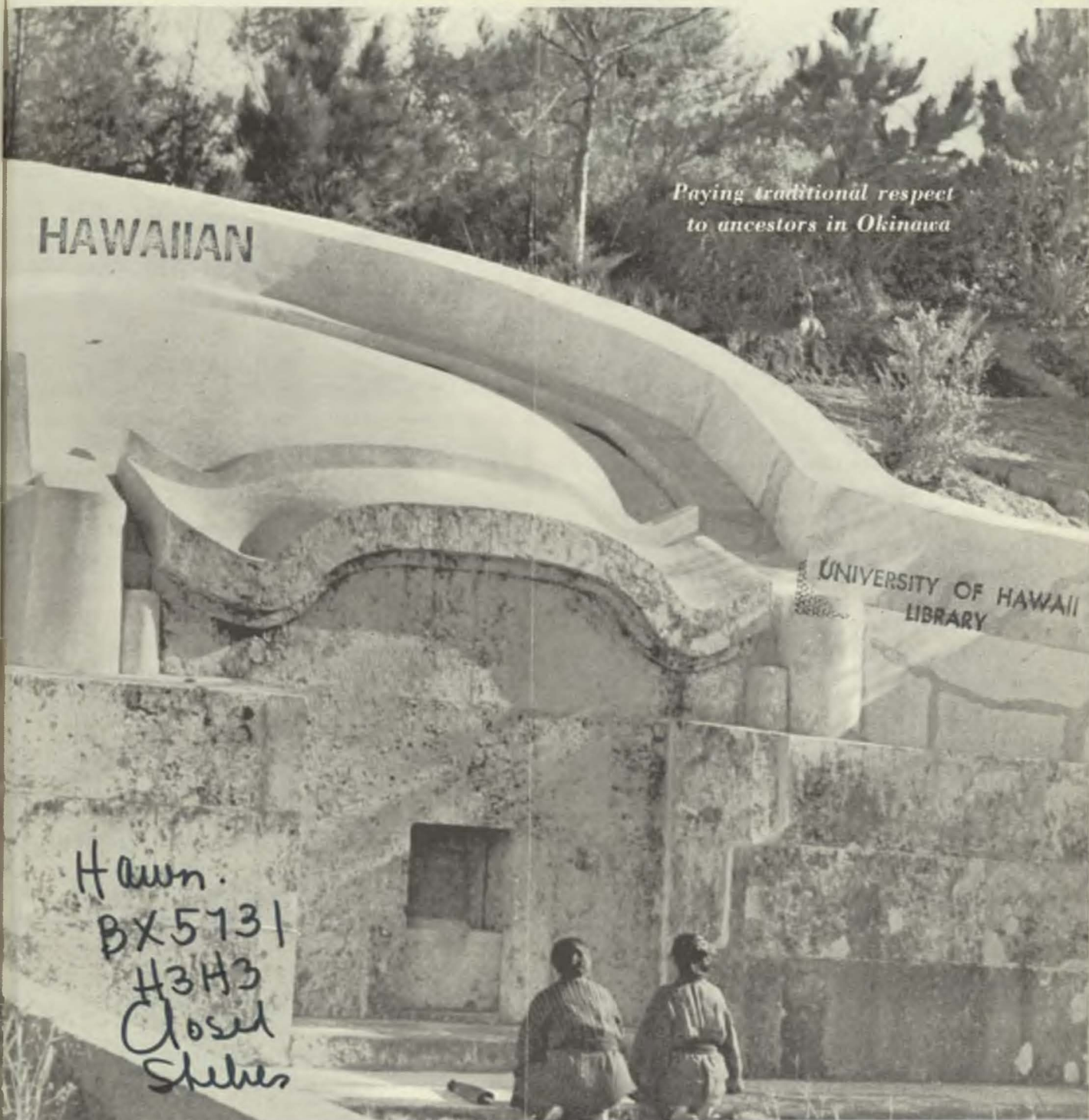

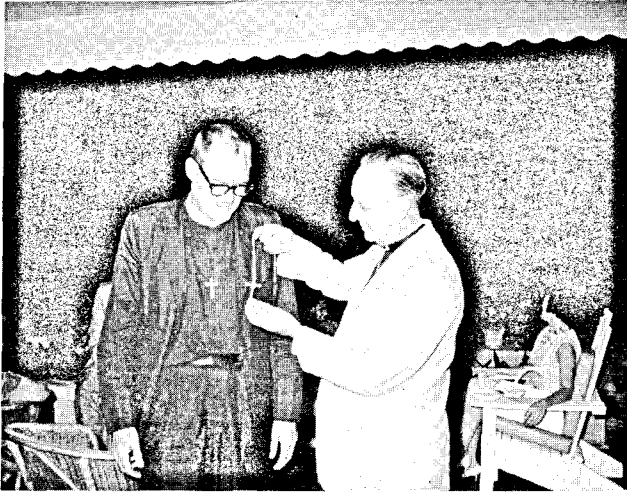

## Distinguished Service Crosses Awarded

The Bishop presented Distinguished Service Crosses to the Reverend Grosvenor M. Needham and Mrs. Marjorie B. Robertson on June 3rd and June 9th respectively.

The Rev. Mr. Needham stopped overnight in Honolulu with his wife and son on their way to Chicago, where he will serve in his former diocese. He has given loyal and devoted service to the Island of Guam for the past six years. Under his leadership a very fine day school has been built at Agana, filling a great need.

The Bishop and Mrs. Kennedy had a dinner honoring the Needhams and Canon and Mrs. James Long, who has resigned as Canon of St. Andrew's Cathedral to become Canon to the Ordinary to the Bishop of Olympia. He was presented a seal of the Diocese for his faithful service to the Cathedral for the past three years.

The Hawaii Preparatory Academy had a dinner honoring Mrs. Robertson, who is retiring as Assistant Administrator. She has done an outstanding work at the Academy and has contributed greatly to its present high standing. Bishop and Mrs. Kennedy were present for the occasion of Mrs. Robertson's retirement dinner, at which time the Bishop gave her this most deserving recognition.

We congratulate these good people for their deserved awards and express appreciation for the contribution they made to this Missionary Diocese during their years of service. Our Aloha goes with them as they begin a new way of life.

## Urban Strategy Official Visits Hawaii

The Reverend George Lee, Associate Secretary of the Joint Urban Program of our Executive Council, New York City, an expert in this field, arrived in Honolulu on June 2nd for a week of conferences on Urban Strategy.

During his stay he met with the Bishop and Council, with a group of clergy involved in Urban concerns, with the St. Andrew's Cathedral Committee on Urban Strategy, with the leaders of the ecumenical community, and with the heads of the departments of the State and City governments.

In order to get a complete picture of the Diocesan planning, he spent much time at the East-West Center, the University of Hawaii and Hawaii-Kai, and made a trip to Hilo.

He has been able to gather considerable data which he will study on his return to New York and make suggestions and recommendations for the Church's planning processes.

His visit has been most helpful and we look forward to his complete report.

## To Arrive in Mid-July for Service in Guam

The Reverend Jordan B. Peck, Jr., will arrive in mid-July to take up his post at St. John's Church, Agana, Guam, succeeding the Reverend Grosvenor M. Needham. Former Rector of St. Paul's-in-the-Pines, Fayetteville, North Carolina, he will arrive with his wife, Maryly, a Chemical Engineer, a son Jordan B. Peck, III, age 13, Blake VanLear 10 years, James Tarleton, 7 years, and Virginia Ellaine, 6 years.

He graduated from the Church Divinity School of the Pacific, Berkeley, California, in 1963, Sewanee Military Academy, Vanderbilt University in 1951, and University of Florida College of Law in 1956.

He is a Major in the Marine Corps Reserve, and has just completed a Chaplain's Course at Newport, Rhode Island.

We know that the Pecks will give the people on Guam a very fruitful ministry, both at St. John's-the-Divine Church and at the very fine day school that has been established by the Church.

## COMPANIONSHIP—M.R.I. Notes

### PERSON TO PERSON

St. Christopher's Church, Kailua, and the Churches on Maui are involved in M.R.I. projects that will bring into closer understanding the people of Okinawa and the people of Hawaii.

Mrs. Robert Merle, a former parishioner of St. Christopher's, is now living in Okinawa with her husband, who is stationed there. One of the real needs of the Okinawan people is instruction in English. When she heard about St. Christopher's interest in the student work at the University of the Ryukyus, Mrs. Merle got in touch with the Rev. Edmond L. Browning, who asked her if she would like to teach English classes. So she has been put to work teaching English to the members of the Canterbury Club.

The Rev. Claude F. Du Teil, Rector of the windward Oahu parish, wrote the Church in Okinawa asking for some simple games, puzzles, and the like, which are written in Japanese. These will be used by the Women of St. Christopher's in their work with the Japanese-speaking patients at the State hospital in Kaneohe. Also, we hope that the Okinawan Church can supply Prayer Books and tracts in Japanese for Japanese-born wives of some of the members of the parish.

So we can see that St. Christopher's is both giving and receiving, and we have another answer to the question, "What can Okinawa do for us?"

### GIVING AND RECEIVING

The Children of the missions of Okinawa sent their mite box offering collected during Lent for use in Hawaii. This is a wonderful step forward in our MRI companionship and shows the real concern of our fellow Christians in Okinawa for our work here. Rather than designating the money at this time, the MRI committee has turned the task of considering how it can best be used to the E. Y. C. Conference to be held beginning August 15 at Seabury Hall.

Under the leadership of the Rev. Canon E. B. Connell of St. Andrew's Cathedral, our teen-agers will get into the practical aspects of MRI as they consider their (and our) mission and how it can best be accomplished. The availability of and necessity to use this generous and precious offering will give a practical tone to the conference as the youth of the diocese grapple with the problem of what the Church really needs to be doing.

The Rt. Rev. Charles P. Gilson, who is in charge of our work on Okinawa, requested various items of camping

equipment for the summer program of the youth of Okinawa. Rather than wait, the Diocese here released \$600.00 to purchase silverware, tents, and cots anticipating that our youth would like to take this on as a project next Fall. These items have been shipped to Okinawa. The conference will also discuss this giving aspect of MRI and will discuss ways and means of having the E. Y. C.'s of Hawaii assume this need.

The conference will be designed for E. Y. C. leaders and should be a very practical and stimulating exercise in the consideration of Christian stewardship and of Mutual Responsibility and Interdependence in the body of Christ.

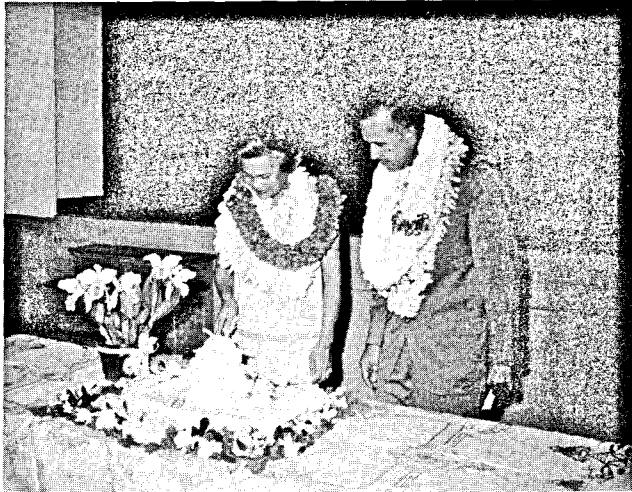

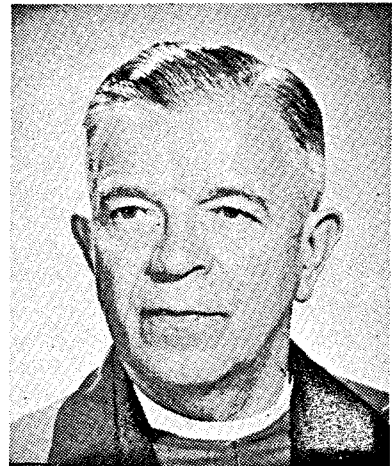
## Bishop Pike's Successor to Be Elected

“Dear Rector and Congregation:

It is our pleasure to know you on the basis of the MRI spirit. From now on, if we are able to continue our fellowship, we will be able to understand each other better and to pray for each other. Then, we will go forward in life together in mutual faith. Our church is on the main island of Okinawa. It is located in the central part. The area is the headquarters of the US military forces so there are many American soldiers around.

There are more women than men in the congregation. Within the same premises (of the church), there is the monastery of the Order of St. George. There is also the nursery school. The church building is presently under construction. When it is completed, it promises to be a fine church.

We are discussing what we are to do with the money which we received from Hawaii. We plan to form a committee to decide what to do with the money.

Please send us the organizations responsible for the money gift, the names of the leaders of them, as we would like to include them in our prayer list.

In another mailing, we are sending products of our high school students.

## “On Christian Obedience”

(House of Bishops, 1964)

Christian teaching holds that civil authority is given by God to provide order in human society, and that just human law is a reflection of immutable divine law which man did not devise. Under all normal circumstances, therefore, Christians obey the civil law, seeing in it the will of God. Yet it must be recognized that laws exist which deny these eternal and immutable laws. In such circumstances, the Church and its members, faithful to Scripture, reserve the right to obey God rather than man.

Thus, the Church recognizes the right of any person to urge the repeal of unjust laws by all lawful means, including participation in *peaceful* demonstrations. If and when the means of legal recourses have been exhausted, or are demonstrably inadequate, the Church recognizes the right of all persons for reasons of informed conscience to disobey such laws so long as such persons

- (a) accept the legal penalty for their actions
- (b) carry their protest out in a non-violent manner, and
- (c) exercise severe restraint in using this privilege of conscience, because of the danger of lawlessness attendant thereon.

Before Christians participate in such actions, they should seek the will of God in prayer and the counsel of their fellow Christians.
