

### 100 Years of Service to the Girls of Hawaii

Rich in its historical background is the founding of St. Andrew's Priory School for Girls. King Kamehameha IV and his gracious Queen Emma petitioned Queen Victoria of England, to send a bishop of the Church of England to the Sandwich Islands. Thus the first Anglican Bishop of Honolulu Thomas Nettleship Staley, arrived in Hawaii with his family and some missionaries on October 11, 1862. The King made the first Hawaiian translation of the Book of Common Prayer and gave the land where St. Andrew's Cathedral and the Priory now stand.


The next year, at the request of Bishop Staley, to Mother Sellon in England, the Society of the Most Holy Trinity sent three nuns to Hawaii to establish a girls' school at Lahaina, Maui.

After the death of King Kamehameha and the four year old prince, Queen Emma desired to provide more religious educational facilities for Hawaiian girls, especially an Anglican boarding school under the jurisdiction of nuns, in Honolulu.


She went to England in 1865 and was received warmly by Queen Victoria. She then called on Mother Sellon at Ascot Priory, and the Reverend Mother promised that a second contingent of Sisters would be sent to Honolulu. Five of them arrived in the spring of 1867, led by Mother Sellon herself.

Mother Sellon had \$7,000 in funds from the Society of the Most Holy Trinity, with which she built frame dormitories, a refectory, chapel and school room on a portion of the Cathedral property. Several days after the school was

dedicated she returned to England accompanied by two of her company.


The Sisters who had labored at Lahaina were recalled to Honolulu, and the Priory began on Ascension Day, 1867, under the supervision of Sister Bertha, Sister Phoebe, Sister Clara, Sister Beatrice and Sister Albertina. Queen Emma called them "the mothers of my people," and told Bishop Staley, "How can I tell you, dear Bishop, what these dear Sisters mean to me, my greatest comfort in the world." Sister Albertina and Sister Beatrice continued their work at the Priory for 12 years, aided by Island friends and a bequest to the Priory from Queen Emma.

In 1902 the Islands were annexed by the United States and the Anglican Church was transferred to the Episcopal Church in America. The latter assumed responsibility of the Priory and provided support for the two Anglican Sisters. Sister Beatrice died in 1921 and Sister Albertina in 1930.

The community of the Transfiguration has been in

charge of the Priory since 1915. The school today has 600 day students as compared to the 11 boarding students when it had its beginning. Five Sisters are in charge of the School, with the Bishop as the head.

Many young women have gone on to higher fields since its establishment, and many more will find St. Andrew's Priory an inspiration in Christian and scholastic training.


### **To Far East**

He spent some time in Okinawa visiting our missions and ordaining to the Perpetuate Diaconate Epaphras Keiya Aoki and Barnabas Yusuke Tokuda, members of the Leper Colony at Airakuen.

The faculty duplex has been completed and is now occupied by faculty members.



Hoku Loa Church at Puako, Hawaii, will be restored as an historical site by the Lutheran, United Church of Christ and Episcopal churches. The property was a grant to the Congregational Church under the Reverend Lorenzo Lyons, a missionary who arrived with the fifth company. The church was dedicated in 1859 and abandoned in 1915 due to the closing of the sugar plantation and population moving elsewhere.

# Stewardship Is a Trust From God

Stewardship is not another name for the Every Member Canvass. It is a basic tenet of the Christian faith. The Lambeth Conference had this to say about stewardship:

"Stewardship is the regarding of ourselves and our possessions as a trust from God to be utilized in His service according to His will. A parish without a sense of stewardship has within it seeds of decay.

"A man who refuses to be a steward of his time, talents and money is unworthy of being in the Father's House. Therefore, it is primary that all clergy and lay leaders practice and teach stewardship as an integral part of life and worship. Not only do we have full Biblical warrant for practicing stewardship; we have further the scriptural injunction to give a tenth of our possessions for God's work.

"Tithing, however, is not an end in itself. Sacrificial giving of our natural resources begins only when all of our parochial and diocesan obligations have been met. It is only when we give with no possibility of receiving material return that we can be said to be giving sacrificially."

Thus spake Lambeth. It is strong medicine.

Both men are graduates of The Church Divinity School of the Pacific, Berkeley, California, where they were ordained to the Diaconate last March.


A reception honored the new priests immediately following the service.

If we look well into the beginnings of the feast of All Hallow's Eve, for that is its old name, it is a wise decision upon their part!

All Hallows' Eve is the evening before All Hallows' (Saints') Day, the day on which the Church celebrates the attainment to perfection of those who have lived well, and have gone to their eternal peace. It was an ancient superstition that on the evening preceding this great feast, the legions of Hell set forth upon the earth to wreck their vengeance upon all whom they could influence or waylay, with the intent of keeping those souls from eternal bliss.
