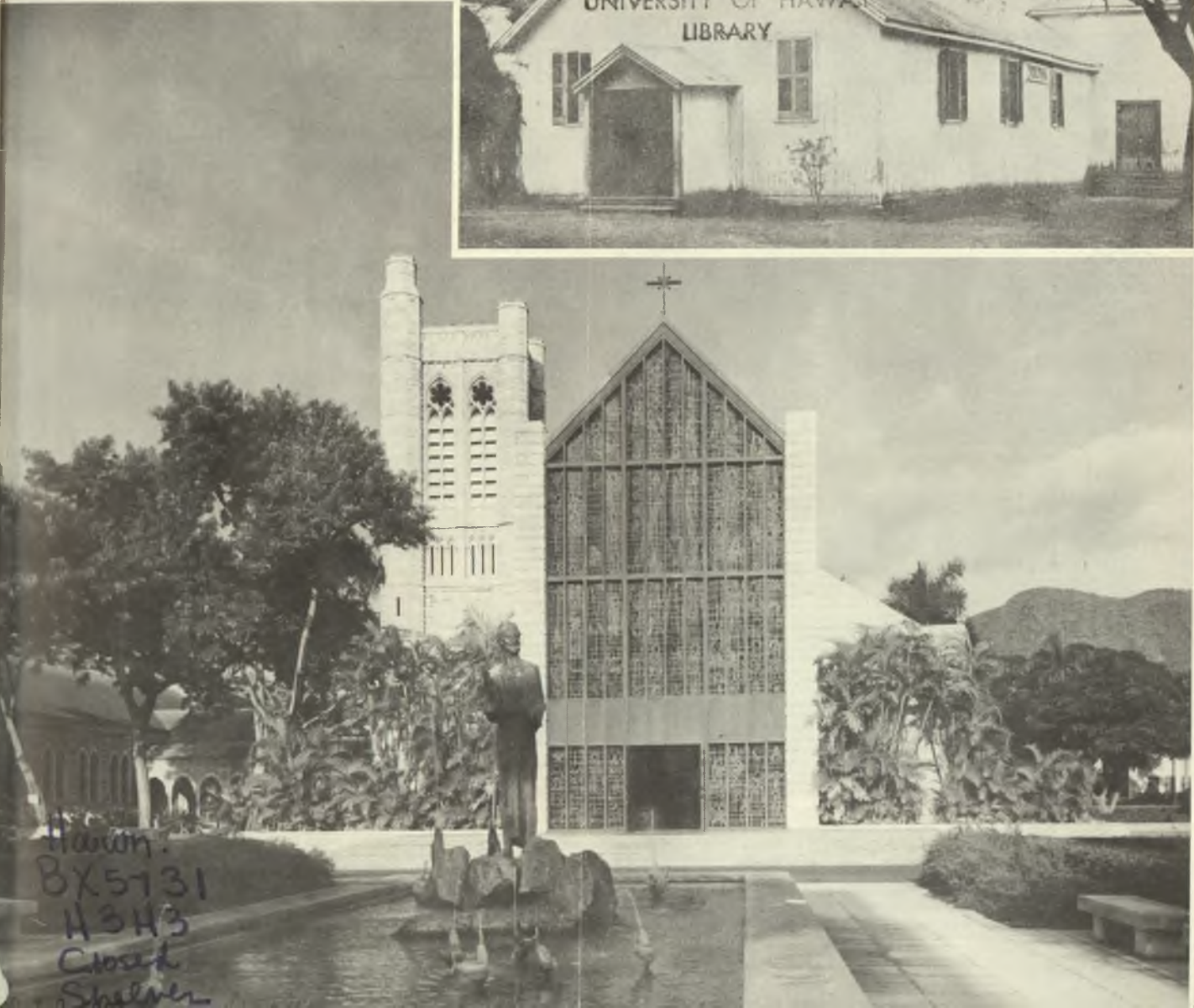

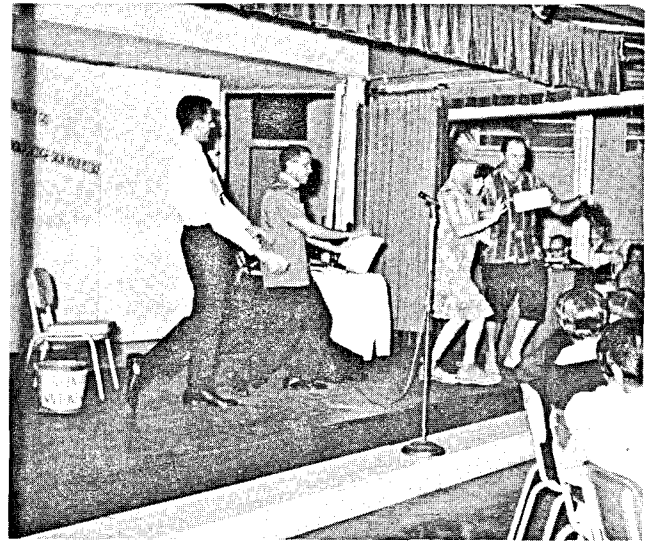

Centennial Service for the Laying of the Cornerstone of St. Andrew's Cathedral

On March 5, 1867, following a communion service at 11:00 a.m., King Kamehameha V laid the cornerstone of St. Andrew's Cathedral. On the 100th anniversary of this important event a special service will be held at the same hour. Bishop Kennedy will preach the sermon and several of our distinguished Episcopal judges, Chief Justice William S. Richardson and Judge Samuel P. King, will read the lessons. At the conclusion of the service there will be a formal procession to the cornerstone for a special ceremony. Numerous Hawaiian societies have been invited to send special representatives and there will be delegates from Iolani School and St. Andrew's Priory.

An interesting feature of the observance will be displays of historic articles in Davies Hall. Some of these will be Queen Emma's Baptismal record, which notes her as the first member of the Cathedral congregation. The baptismal ewer presented by Queen Victoria of England and now in the possession of the Daughters of Hawaii will be on display. To add a human touch to the event the Cathedral would like to locate and identify the oldest baptized member, the oldest living member and the oldest couple in the Cathedral. Diocesan Banquet

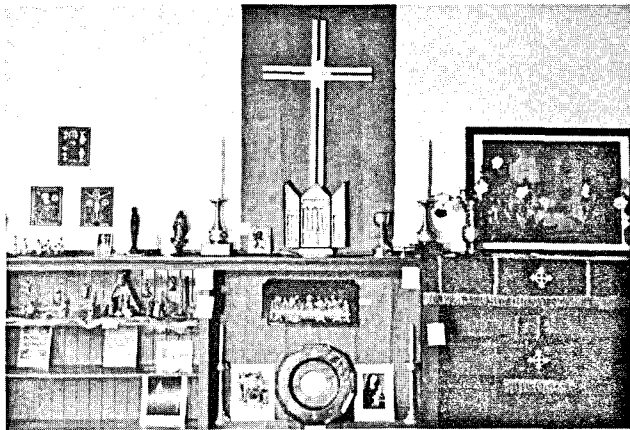

MRI On A Large Scale

Presiding Bishop John E. Hines announced recently a gift in response to MRI, of \$350,000, from the Diocese of Massachusetts towards the establishment of a pension fund for the Anglican Church in Japan (the Nippon Sei Kokai). This represents the largest single project gift ever made by one Anglican church to another. The Right Reverend Anson P. Stokes, Jr., is the Bishop of Massachusetts. The late Bishop William Lawrence of Massachusetts, was the leader of the development of the Episcopal Church Pension Fund.

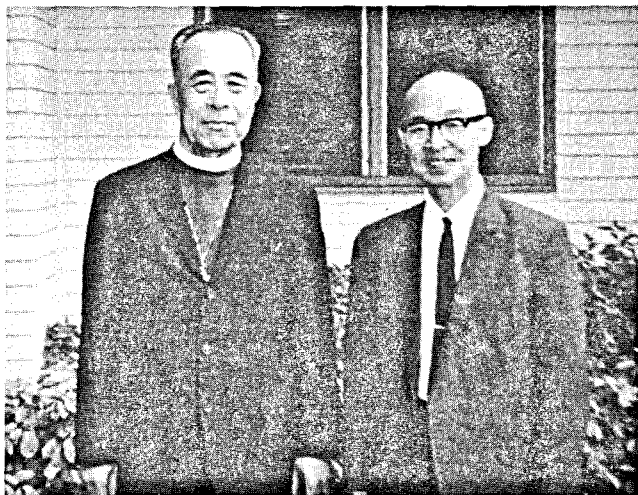

1967's General Convention In Seattle

The major goals and tasks facing the Episcopal Church's General Convention to be held in Seattle, Washington, September 17th-27th, as outlined by Clifford P. Morehouse, President of the House of Deputies, are:

To set our household of the faith in order.

To make the everlasting truths of the Catholic faith pertinent and significant to today's society.

To interpret the Church to the world and the world to the Church in terms of Mutual Responsibility and Interdependence in the Body of Christ.

To bind up the wounds in the Body of Christ, that they may be healed by the Holy Spirit.

To declare the Good News of Christianity to all men.

He said specific discussion and action originating from the goals of the General Convention will center around the areas of theological education, the Church Pension's Fund for its clergy and the Partnership Plan of stewardship.

Gift To Seabury Hall

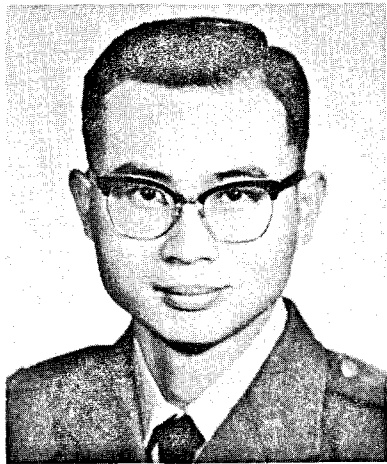

"A Promise We Must Keep"

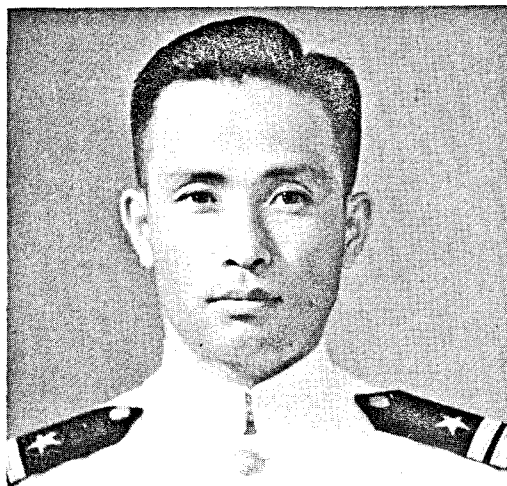
We Episcopalians made a promise through our General Convention in 1964. It was a promise to respond to the call of the Primate and Metropolitan of the Anglican Communion and accept the bonds of Mutual Responsibility and Interdependence, tying us with our fellow Anglicans and with all mankind.

One aspect of the promise was our commitment to accept voluntary projects totalling \$6,000,000 in this triennium, over and above the normal Church budgets, to meet critical needs of our sister Churches abroad.

Partnership projects may be obtained from the Overseas Department of the Episcopal Church, in New York City.

Elected Suffragan Of Long Island

The Venerable Richard B. Martin was recently elected Suffragan Bishop of Long Island. Archdeacon Martin is only the second Negro to be elected Suffragan Bishop in the United States. He became Archdeacon of Brooklyn on January, 1965.

St. Christopher's Has Lots of Rock

Drums, tambourines and amplified guitars were heard recently at St. Christopher's Episcopal Church in Kailua.

A rock 'n' roll group, known as the Yags, and a folk group, which bills itself simply as Fred, took part in the 8:30 and 10:30 a.m. services.

"These services were conceived by young people of the church, with adult help," said the Reverend Hollis Maxson, assistant rector. "But the congregation included people of all ages.

"The idea was to allow the young people to express themselves and to participate in a service," he said.

He said the experiment, which met with a favorable reaction, may be repeated on a quarterly basis.

"It's the first time we have done anything like this, but I understand that the young people of Holy Nativity Episcopal Church have put on similar services," The Reverend Mr. Maxson said.

He said the theme was geared to a folk song by Bob Dylan entitled "The Times, They Are A'Changing." The number was played as an anthem.

Sermons at the services were preached by Dayna Minton and Elizabeth Vogt, high school sophomores.

Delegates to General Convention elected were: Clerical, Claude F. Du Teil, the Venerable William R. Grosh, Alternate. Lay Delegate, Hugh Shearer; Alternate, Richard C. Ching.

An important revision to the Canons was made in the resolution that Canon XXI, of the Missionary District of Honolulu, concerning Bishop and Council, Sections 1 and 2, be amended to read:

SECTION 1—The Bishop shall appoint annually in addition to two ex-officio members (Chancellor and Treasurer) not more than 15 members to constitute with the Bishop a Council with such departments as the Bishop shall deem necessary.

SECTION 2—The Bishop and Council shall plan and direct the mission of the Church in the Missionary District, and each Department shall perform such duties as may be assigned either by the Bishop or Convocation or both: such assignments to be of the nature indicated by the name of the Department.

Distinguished Service Crosses

The Bishop awarded Distinguished Service Crosses for outstanding service to their parishes and Diocese to the following: Mr. Hugh Shearer and Mr. Kenneth Day, of St. Andrew's Cathedral, Mrs. Thomas (Elizabeth) Brodhead, of St. Clement's Parish and outgoing President of the Episcopal Churchwomen, Mr. James W. Doherty, of St. George's Parish, and Mr. Samuel P. K. Liu, of St. Peter's Parish. These were awarded at the Diocesan Banquet.

In Appreciation

The Bishop awarded a seal of the Diocese to Mr. Herman V. von Holt, of St. Andrew's Cathedral, Secretary of the Board of Directors for many years' standing, who has been instrumental in making the investments of the Diocese pay outstanding dividends and to Mr. K. L. Ching, a member of St. Elizabeth's Church and of the Board of Directors for his devotion as a layman to not only his parish, but to the Diocese.

He also gave a seal of the Diocese to Mrs. Ralph (Frances) Adams, who gave many hours of her time to assist in the office with secretarial work and the preparation of Convocation, and for acting as secretary of Convocation, and to Miss Eloise Lawrence, who assisted the Diocesan Office in many ways in preparation for Convocation. Both are members of St. Andrew's Cathedral. The Diocese is greatly indebted to these women for their helpful, voluntary assistance.

Convocation Service

St. Andrew's Cathedral, with its beauty, was where the Convocation Service was held. All the churches on Oahu gathered at 11 a.m. to share in this service. In the procession were the Bishops, clergy and Lay Readers. St. Andrew's Cathedral Choir, under the masterful leadership of Mr. John McCreary, Organist and Choir Director, sang beautifully for the service. The Very Reverend John J. Morrett, Dean, and the Reverend Canon Eugene B. Connell, were in charge of the arrangements for the service. Bishop Wright was the preacher. It was a colorful and outstanding climax for the Convocation activities.

Becomes a Parish

An outstanding part of the Convocation business was the petition of St. Timothy's Mission, Aiea, Oahu, under the leadership of their Vicar, the Reverend Fred G. Minuth, and his Bishop's Committee, to become a self-supporting parish of the Diocese. This is a real achievement for the mission and we congratulate them on the step they have taken. The new vestry elected the Reverend Mr. Minuth, Rector. He will be instituted by the Bishop on May 21st.

Admitted As A Mission

The Venerable William R. Grosh, Archdeacon of Hawaii and Vicar of Holy Apostles' Church, Hilo, presented the Reverend Albert J. Collins to Convocation, since he had started the work in the Naalehu area on Hawaii, to petition admission of St. Jude's Mission as an organized mission in the Diocese. This was accepted with a warm response.

St. Andrew's Priory School has approximately 50 student chair-desks which are excess to needs. These combination chair-desks are used but in serviceable condition.
