### COMMITTEE BEGINS EVALUATION

#### Election of Bishop Targeted for 'Sometime in April'

The Episcopal Diocese of Hawaii is nearing the final stage of its search for a bishop to succeed the Rt. Rev. E. Lani Hanchett, who died in August 1975.

The Election Process Committee, chaired by the Rev. Thomas Yoshida, is charged with the search for candidates as well as the screening of those interested and their final recommendation to the special convention, which will be called to elect Hanchett's successor. Presently, the Committee's target date is for "Sometime in April."

To date, there are 41 potential nominees who have consented to have their names considered by the Committee. Their resumes are being reviewed by each member of the Committee and scores are being given to each candidate. On January 31st, the Committee will meet and evaluate the candidates according to average composite scores given by the Committee. This will complete the so-called "Coarse Screen."

Next the Committee will begin what has been referred to as the "Fine Screen" process. The candidates who survive the first "Thinning Out" will be notified and a more in-depth and personalized process of information gathering will begin. This could include visits to the home parishes of mainland applicants, for instance.

The final stage of the Committee's work will come when the convention date is set and the several candidates chosen by the committee will be publicized in the Hawaiian Church Chronicle and commercial newspapers throughout the State.

According to church law, actual nominations will occur on the convention's first ballot. Any delegate may nominate any clergyman, regardless of whether he has been considered by the committee.

### ELECTION PROCESS COMMITTEE EXPLAINS PROCEDURES

Because of the numerous misconceptions which presently exist relating to the process by which the next Bishop of the Diocese of Hawaii will be elected, it is only appropriate that a full explanation of the procedure and the role of the Election Process Committee with regard to it be made.

The Bishop will be elected by the delegates to a special convention which will be convened some time during the next few months. The delegates to that convention will be the same delegates who represented the various parishes and missions at the annual convention held in October of last year.

As in any election, a person must have his name placed in nomination to be considered for election. Persons are nominated for the office of Bishop on the first ballot cast by the clergy and laity at the special convention. There are no restrictions placed on whose name can be placed in nomination.

Once the nominations have been made, voting commences by order (clergy and laity separately). The voting continues until one of the nominees gets a majority vote in each order on the same ballot. Once this has occurred, it is necessary for the individual who has been elected to accept the position. He must then undergo medical examinations and his election must be approved by a majority of standing committees of the other Dioceses within the Church. Finally, the process is complete upon his ordination and consecration.

The function of the Election Process Committee in relation to the election of our next Bishop is to screen those individuals whose names have been submitted as possible nominees and who are interested in being considered for the position.

The survey that was taken of the Diocese has yielded a profile both for the Diocese and of the characteris-

### MINISTRY TO HAWAIIAN COMMUNITY

Dear Members of the Editorial Board and the Editorial Staff of the Hawaiian Church Chronicle:

I write to commend you on the article entitled "Ministry to the Hawaiian Community" by the Reverend Charles Hopkins which appeared in the Hawaiian Church Chronicle in December, 1975.

It is most gratifying to see the Episcopal Church of Hawaii address itself in an active way to the momentous problems facing the Hawaiian population. The creation of a Ministry to the Hawaiian Community and the appointment of a dedicated person such as Reverend Hopkins is long overdue. It should only represent the first of many such actions in this direction.

While I have been a lifelong Episcopalian and am a member of St. John's Episcopal Church in Kula, Maui, Hawaii, I am reminded that I chose not to attend divinity school because I was most skeptical that the Episcopal Church, particularly a predominately caucasian and very affluent church, would address itself to the problems of the poor, particularly the indigenous poor. Instead I chose law.

I am aware that Reverend Hopkins' ministry may not be a popular one among all of Hawaii's Espiscopalians. Yet the just resolution of the Hawaiian Community's problems may entail even greater efforts by established institutions such as the churches and the government. With this in mind I would re-emphasize my agreement with the concept of the Ministry to the Hawaiian Community and with its implementation through the appointment of Reverend Charles Hopkins. Several fellow Espiscopalians have told me of their strong support ss well.

Should the advisory committee to this ministry be established, I would consider it an honor to serve on it.

You have my best wishes for a vigorous and successful ministry.

tics which a person should have to effectively meet the needs and desires of the Diocese. The Election Process Committee, utilizing that data, will screen the individuals whose names have been submitted to it.

The exact result of this screening process is not known at this time, inasmuch as there are many variables over which the Committee has no control. It is likely, however, that the end result will be the submission of names for consideration as nominees for the office of Bishop, all of whom possess characteristics which would make them qualified and suitable for election to the office of Bishop.

While there is inevitably a certain amount of subjective judgment brought to bear in the process, the primary and principal thrust of the Committee is in applying criteria and standards and priorities developed by the entire Diocese in the survey. The process being followed by the Diocese in its screening of potential candidates is one which has been widely used throughout the Church and has been found to be, notwithstanding its imperfections which any process will inevitably have, to be the most satisfactory of any experimented with to date.

Only in time will we be able to tell whether what we are doing now with the best of intentions was in fact the best route to take.

# WCC REPORT

GREENWICH, Conn. — Addressing the Executive Council immediately following his return from the Fifth Assembly of the World Council of Churches (WCC) in Nairobi, Kenya, the Rt. Rev. John M. Allin, Presiding Bishop of the Episcopal Church, said that he found himself "thanking God for His Church, so varied in membership and expressions, yet seeking to serve one Lord."

Bishop Allin, who headed the Episcopal Church's delegation to the WCC meeting, told the 41-member Executive Council at its December 16-18 session here, that he had "gained a new appreciation for this country (the United States) and its potential." He added that he thanked

"God for the opportunity to repent as well as to give thanks."

"Let me simply say here," he said, "that any doubts I may have had about the necessity for a World Council of Churches were removed as I shared in the course of that Assembly."

Bishop Allin also reported to the Council on his meeting with the primates of the member-churches of the Anglican Communion in Nairobi just prior to the WCC Assembly, and weekend trips during his stay in Africa, to Kampala, Uganda, and to Dar-es-Salaam in Tanzania. He also related that he had called on the Orthodox Archbishop, Seraphim, of

Athens, and made an official call on the Ecumenical Patriarch Demetrios in Istanbul.

Bishop Allin observed to the Council that "the meeting of Christian community in this world or the next is finding our life and meaning together in the one God through Jesus Christ. Where we are at odds with one another let us pray and work to be even with one another — Council, staff, Presiding Bishop and other members of this Church, and with the other folds in His Church."

Dr. Cynthia Wedel, one of six new presidents of the World Council of

Churches, give a report at the recent meeting of the Fifth Assembly in Nairobi, Kenya, at



which she was elected to her post. Dr. Wedel, a U.S. Episcopalian, is a past president of the National Council of Churches, and a psychologist associated with the National Resource Center for Voluntarism in Washington, D.C. In an interview, she predicted that the next seven years until the Sixth Assembly will be marked more by a deepening and strengthening of WCC forces than by turning new corners. ## WHO VOTES FOR BISHOP

1. There has been some confusion about who does the actual voting for the new Bishop. Some of the laity are under the impression that because various kinds of publicity have emphasized that all laity are able to participate in the election process, that therefore all laity will be able to vote for him.

By canon law only delegates to the convention do the actual voting. The participation in the election process open to all has been the Diocesan Survey, submission of candidates and whatever discussion and input they may have with delegates to the convention. Please, please do convey this to your people carefully and clearly. Only Delegates to Convention will vote for the Bishop.

2. There is further confusion as to who shall be delegates to the special Election Convention. Again the Canons are quite specific. In the 1969 Canons of the Diocese, Article VII, Section 3 it is stated: "Lay Delegates elected for an annual convention shall serve as lay delegates for all special conventionss until the next succeeding annual convention." The Chancellor of the Diocese has stated that this means those delegates elected for the October 1975 Annual Convention will serve as Delegates to the special Election Convention.

The confusion perhaps derives from the fact that the revised Canons of the Diocese dated July 1, 1973 inadvertently omitted Section 2 and Section 3 of Article VII. These two sections are a part of the master copy of the revised canons however, and are therefore legally binding.

# KAUAI GETS E.A.S.T. GRANT

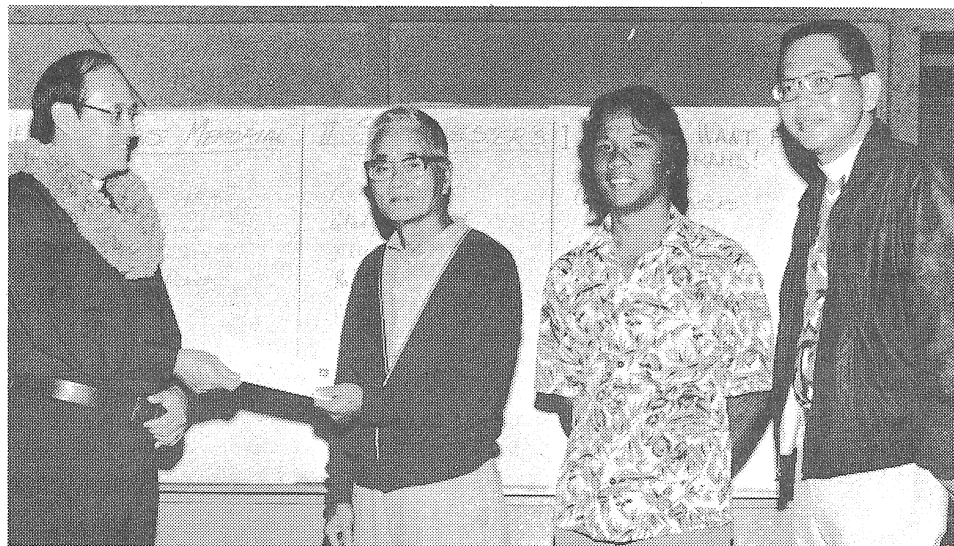
KILAUEA, KAUAI — Christ Memorial Church in Kilauea, in cooperation with St. Sylvester's Roman Catholic Church and the Kilauea Community Association, recently began a program to provide the youth and young adults of the Kilauea Community with structured recreation and education opportunities to help to develop and nurture a rebirth of community integrity and identity for the Kilauea area.

The Kilauea Sugar Plantation closed down in 1971 and most of the sugar lands surrounding this little plantation community were sold to non-residents who purchased the acreage for investment. The community had very mixed reactions to the situation and was not able to reach any consensus on the issues of their future.

In four years the problem has not solved itself. The community has, however, agreed that action needs to be taken to preserve their identity.

The program was set up to be one largely of self-help but even with such a design money is needed. Equipment must be purchased, buildings must be made useable, and program must be established. The two churches did not have sufficient resources so a grant request was sent to HAWAII E.A.S.T.

The grant request, together with the program, was approved and Christ Memorial Church received \$2,500 last November for development of the program.

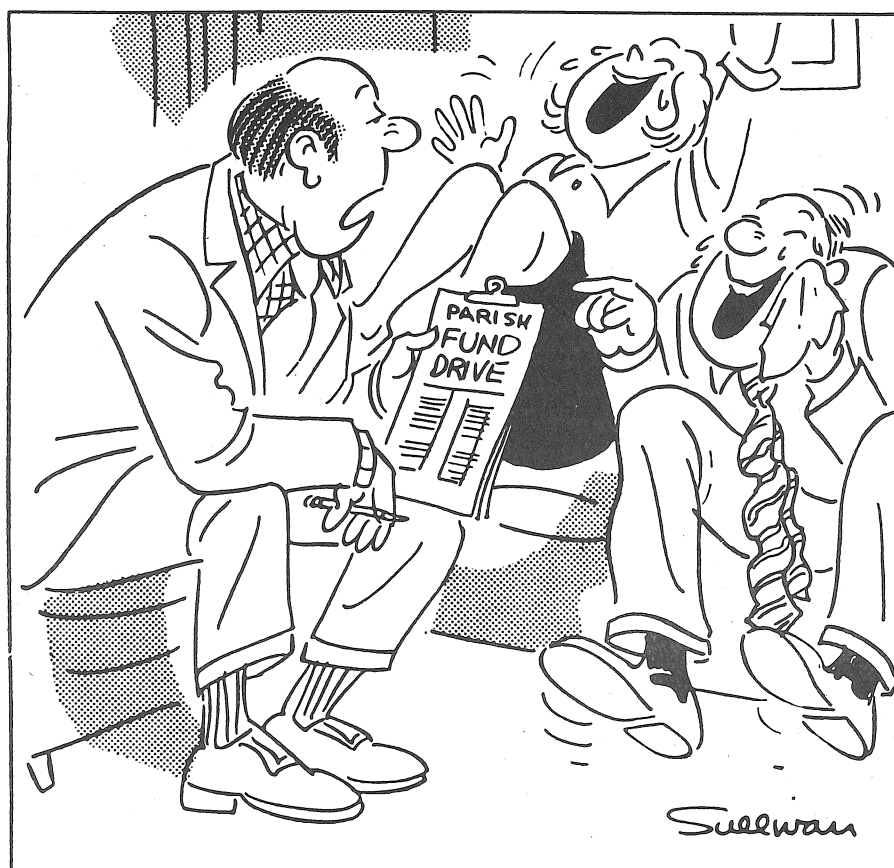

## Holy Nativity On The Move

The Rev. Charles T. Crane, Rector of Holy Nativity Church in Aina Haina, recently announced that the necessary arrangements have been completed for a Sabbatical/Exchange year abroad for himself and his family.

Beginning on Sunday, August 29, 1976, Fr. Crane will assume the duties of the Rev. Barry W. Oakley, Vicar of the Church of the Holy Rood, Crofton Parish, Stubbington, Hampshire, England.
