

FROM THE SEA OF TIME: A Gem

Not far from Ravenna's Plaza of the People stands the mausoleum of the Empress Galla Placidia, a moving expression of Christian faith almost miraculously preserved these 1,500 years in the amber of art.

The Building

It is a modest, almost tiny, building, quite without any hint of the vulgar grandeloquence of the last resting places which the Emperors Augustus and Hadrian built for themselves in Rome. This mausoleum is for one of the Christian faithful, not a temple for a new Pagan god.

The exterior is warm and simple: walls of brick and mortar and a roof of red tile. Only the windows — thin sheets of dun alabaster veined in rich, earth browns and reds - hint the magnificence within.

One must step down to enter. Ravenna is a marshy land into which over the years, old buildings settle comfortably, like graying professors into their favorite chairs.

The floor itself and marble wainscotting are unexceptional. But above and about one's head is an explosion of azure, emerald, ruby, and golden beauty - all in mosaic which makes this one of the finest gems of early Christian art, of theology visualized.

The Cross

Crowning, supporting, and tying all together is the Cross of Christ. The floor-plan is that of a Latin cross. And

above, in the center of the dome, is the triumphant Cross in Glory, golden. on a field of heavenly blue, surrounded by a multitude of golden stars. Over the entrace, Christ the Good Shepherd sits amid his sheep with his Cross-staff in hand. And facing Christ is St. Laurence with the Cross.

In the dome, the four heavenly creatures adore the Cross in Glory, the symbol of the Ascended Lord. Below them, Apostles acclaim Him, like Roman senators at an imperial triumph. And between these Apostles, doves - figures of the Christian soul - rejoice before the eternal Living Water.

Below these scenes of heavenly glory, just above the onlooker and the sarcophagus of Galla Placidia (itself head-high), St. Laurence (d. 258)

martyrdom. Shouldering the Cross and bearing the Gospel, he fears nothing — even death upon a grate and fire.

Gospels beside the flames and gridiron. Such cases stood in the sacristies of ancient churches. And Laurence, a Roman deacon, had responsibility both for that Church's treasures and for the reading and the proclamation of the Gospel.)

Faith

In the mosaics of the mausoleum, St. Laurence has before his eyes a vision of heaven — the realm of the Good Shepherd and the flock for which He most tenderly cares. The mosaics proclaim that, like St. Laurence, through the Cross and by

A fervent desire and holy hope form the sustaining bridge between the troubles of this life (the gridiron) and the glory to be revealed (the abode of the Good Shepherd).

Simultaneous with Convention will be the annual meeting of the Episcopal Church Women and the United Thank Offering Ingathering

Formation of the island-wide Kauai Episcopal Council to further the mission and ministry of the Church on Kauai.

The very favorable reviews of Kauai's Children Come of Age (UH Press, \$12.00), co-authored by Ruth Smith, convener of the Kauai Episcopal Council, member of the Church's Board of Directors, and clinical psychologist at Wilcox Hospital, Lihue.

The Mission Outreach items approved by St. Mary's, Moiliili, for 1977: \$3,950 to 21 beneficiaries, including Good Samaritan, Palolo; Kohala Missions; Moiliili Community Center; McCully Business Association; Bishop's Discretionary Fund; and the Presiding Bishop's Funds for World Relief and for World Hunger.

The largest United Thank Offering ever in 1977 — 94 grants (the greatest number in one year) totalling \$1,675,929, including a grant of \$30,000 to Trinity-by-the-Sea, Kihei.

AROUND THE CHURCH

Ordination of Women

In Geneva, at the end of his spring ecumenical whirl, the Archbishop of Canterbury, Dr. Donald Coggan called on Roman Catholics and the Orthodox — whose leaders he had just visited — "to move out of the realm of the emotional and the sentimental and into the realm of the intelligent" by considering the ordination of women. (See HCC June 1977).

In the U.S.S.R., the Russian Orthodox were blunt. Women's ordination "is not a problem of social or anthropological interpretation, . . . not an experiment in church practice. It is heresy," said Bishop Kyrill, Rector of the Leningrad Theological Academy to visiting Presiding Bishop John Allin in July.

In Etchmiadzin, Soviet Armenia, the Presiding Bishop found the Armenian Apostolic Church in full agreement with their Russian Orthodox co-religionists.

Ordination of women has strained the continuing **Anglican-Orthodox** dialogue to the breaking point.

And plans are under way for "a small conference with the Roman Catholic Church to consider 'to what extent and in what ways Churches with women priests and Churches without women priests can be reconciled in sacramental fellowship," according to the Anglican Consultative Council.

In Armagh, the Primate of the Anglican Church of Ireland, Archbishop George Simms, announced that Church's intention to ordain women in 1979.

Church & State

Unlikely to be mollified by the compromise "In Gold We Trust," Madilyn Murray O'Hair, the John L. Lewis of American Atheism, recently announced plans to eradicate the motto "In God We Trust" from the U.S. currency, where it has been since the Civil War.

California's Attorney-General ruled that the quotation of Genesis 1:2, 3 on the cover of the new State Government telephone book was constitutionally permissable. He likened it to the motto "In God We. Trust" on the currency, ruling that both verses and motto are devoid of religious significance.

Teen Challenge Hawaii, at work in re-habilitating drug users and abusers, has elected to "go it alone" without government financial support, rather than give up the Christian content of its program, which it holds is not optional, but essential to its success.

The town assessor of Hardenburgh, N.Y., has granted 90% of the town's residents tax-exempt status on the basis of mailorder divinity degrees from the California-based Universal Life Church. These citizens became clergy and churches in order to protest the sharp rise in local taxes occasioned by exemptions to non-profit organizations such as the Boy Scouts and Zen Buddhists, among others. Court and legislative action is anticipated.

Sects

The Unification Church of the Korean evangelist Sun Myung Moon "is not a Christian Church," the Commission on Faith and Order of the National Council of Churches has concluded on the basis of that HAWAIIAN CHURCH CHRONICLE

church's official text, Divine Principle.

While in no way questioning the right of the Unification Church to proselytize, the Commission found its teachings non-Christian in seven areas: dualism, secret revelations (gnosticism), materialism, anti-Semitism, treatment of Scripture, teaching on the Trinity, and doctrine of Salvation. Fullness of Salvation, it appears, "is to be achieved by another than Jesus, namely by the Lord of the Second Advent."

Gabhira Das, 25, a convert from Judaism, is apparently the first full-time Hare Krishna University chaplain. He serves about 125 Krishna devotees at the University of Maryland in College Park.

New Hymnal

Work towards a **new Hymnal** has begun, and authorization for a revised Hymnal is to be requested at the Church's **1979 General Convention**.

The Standing Commission on Church Music, responsible for any new Hymnal, has only one member who lives West of the Mississippi — an Iowan. Hymns without Representation!, clearly.

Episcopal Charismatic Conference 1977

Over 1600 persons attended the Episcopal Charismatic Fellowship National Conference held in conjunction with the 1977 Conference on Charismatic Renewal in the Christian Churches (CCRCC), which attracted 60,000 to Kansas City, Missouri, late this July.

The Archbishop of Capetown (B. B. Burnett), the Bishop of Singapore (Ban It Chiu), and the Bishop of Pontefract (T.R. Hare) addressed the Episcopal Conference.

In his letter to the Fellowship, **Presiding Bishop Allin** wrote:


Our Church is in great need of more and more faithful and joyful Christians who are confident in the power of the Spirit, firmly rooted in the Gospel, and unshakably committed to the Body of Christ, people who cannot be dislodged from the hope that is offered to us even by the stormiest winds of controversy which so frequently shake our Church.

I urge you to be part of that group, and to pray for this little part of the Body where the Lord has called us to live out our lives.

Pray that we may be given grace to pay scant attention to the petty prophets of division and smug self-righteousness, and to heed the voice of Him Who died and rose again and calls us to share now in the power of His Resurrection.

The Advisory Committee's three

goals are:

- To establish a Hawaiian Pastorate as an integral part of the Diocese:
- To inform, educate and sensitize the Church to Hawaiian values, issues and concerns; and
- 3. To develop specific programs to meet special needs.

The Advisory Committee meets monthly at St. Andrew's. It was fortunate in being able to meet on Molokai several months ago for an inspection tour of the various communities on the Friendly Island and was able to gather firsthand information on the special needs of Hoolehua Homestead farmers

The committee hopes to make the Church's impact in the community in the best tradition of **kokua** (help) and **laulima** (co-operation) which characterized the lives, work, and witness of Queen Emma, King Kamehameha IV, and Queen Liliuokalani.

Briefly Noted

The election of the Rev. Sumio Takatsu, 50, to succeed resigned Bishop Elliot Sorge of the South Central Diocese of the Episcopal Church in Brazil. A native of Japan, graduate of Union Theological Seminary in New York, Fr. Takatsu was formerly a professor of theology in Brazil.

The visit of **Sister Nobu** of the **Order of Nazareth**, **Tokyo**, to **Hawaii**, on her way to serve with the **Episcopal Church in Brazil**, which has the world's largest population of overseas Japanese.

The new All Saints' Anglican Cathedral in Cairo being built with the assistance of Egypt's Muslim

government in compensation for the destruction of the former cathedral to make way for a new central Cairo — Nile River road.

Heart Sad

The loss of **16,514 members** in the **Diocese of Colorado** in the decade **1966-1976**.

The defection to date of 7 out of the 7,177 parishes and missions in the Episcopal Church, because of disgruntlement at the actions of the 1976 General Convention.

Tels Tell

American and Israeli archaeologists this summer uncovered the probable site of Timnah, home of Samson's wife and the place where he slew the lion (Judges 14, 15), near Beit Shemesh, halfway between the Mediterranean and Jerusalem.

The cave and burial site of St. Euthymius the Great (377-473), one of the most revered and influential of the early Palestinian monks, has apparently been found by the Greek archaeologist Yannis Meimaris in the desolate country between Jerusalem and Jericho.

SUMMER 1977: A REVIEW

For the Church this summer was hardly one entirely of "lazy, hazy days."

Summer 1977 saw:

—Blasphemous libel in London;

—An Archbishop's thumbing his nose at the Pope;

—The best and the silliest theological squall since Altizer and Hamilton, the Tweedledum and Tweedledee of American theology, announced the impossible — the "death" of God;

—War jitters in the Mediterranean on the death of that last of the Byzantines, President and Patriarch Makarios of Cyprus; and

—Near civil war among Latin America's Roman Catholics.

Libel in London

The columns of **The Times** were filled with articles and letters pro and con as the **Gay News** was tried and found guilty in London's Old Bailey of **blasphemous libel** of Christ and Christianity.

Legal action stemmed from "gross indecencies" alleged to have been committed by Christ, the Apostles, and the Centurion who witnessed the Crucifixion in the poem "The Love that Dares to Speak its Name" by the respected poet and writer James Kirkup, which was printed in the News.

In an editorial, **The Times** felt that "other men's gods" should indeed be protected before the law.

However, one Anglican vicar thought that God was sufficiently able to look after Himself without the assistance of Parliament or the

Curiously, the Common Law permits prosecution for blasphemous libel only in Christian matters. British Moslems complained of their lack of legal protection under the law.

And **Stephen Spender** suggested the uncomfortable paradox "that today the blasphemous may be closer to the religious than the conventional and the pietistic." He held that those who brought and sustained the prosecution did ill and arrogance, thinking themselves "in the confidence of God."

But **Dr. Margaret White** had the last word, quoting **William Reel** of the **New York Daily News:** "In highbrow circles, ridiculing Jews is nazism, ridiculing Blacks is racism, ridiculing feminists is sexism, but ridiculing Christians is freedom of speech."

Latin America

At least fourteen priests viewed as "Reds" by conservative "Whites" have been killed in recent months in El Salvador, Honduras, Panama, Argentina, Chile, and Brazil, because of their work in shantytowns, with student groups, in behalf of peasant unions, and with Indians whose ancestral lands are threatened.

In El Salvador, the White Warrior Union, an alliance of the military and the great landwoners, threatened to liquidate all Jesuits remaining in the country after midnight, Wednesday, 20 July. The Jesuits stand fast and, so far, have escaped assassination.

The **Jesuits' crime**: "Slowly the peasants began to abandon their fatalism," a Jesuit report recounted. "Slowly they began to understand that their hunger, their diseases, their infant mortality, their unemployment, their unpaid wages,

were not the will of God but the result of the greed of a few Salvadoreans and of their own passivism."

In **El Salvador** alone, from January to July, two priests were murdered, fifteen deported, and eight others beaten or otherwise publicly insulted.

Living conditions in El Salvador are so wretched that even official government statistics report illiteracy and unemployment exceeding 50%, inhuman living conditions for 350,000 families in a population of four million persons, and a farmworker's day's wage of about 35¢, when it is in fact paid, according to The Times.

Elsewhere in Latin America, more radical priests have joined armed guerilla bands, seeing Christ as a Zealot Marxist and proper patron for armed "liberation movements."

Archbishop Geraldo Sigaud of Diamantina, Brazil — the largest Roman Catholic country in the world — labeled his fellow bishops Marxists recently. The country's 200 other bishops condemned this libel and expressed support for 80 priests now living and working in worker neighborhoods in Sao Paulo, the country's industrial center, the New York Times reported.

Archbishop Lefebvre

Traditionalist Roman Catholic Archbishop Marcel Lefebvre gave Pope Paul no end of trouble this summer and appeared to strengthen conservatives in some other churches as well.

To his dossier he added a provocative rally in Rome itself, the ordination of graduates of his rebel traditionalist seminary in Switzerland, and a junket through the American South-West and Latin America in support of conservative Catholicism.

"I do not want to die a **Protestant**," The Archbishop proclaimed in Rome at the reception in his honor at the palace of the Princess Elvina Pallavicini on 6 June.

"I do not want to die a Protestant, and for this reason I say 'No!" to the reforms of Vatican Council II," said Lefebvre.

"The Pope asked me to accept them. I cannot do so in conscience. It is impossible for me," he continued, living up to his seminary nickname "Die Versteinte Sana Doctrina" — Sound Doctrine Fossilized.

During the Council he had opposed aggorniamento, detested the very idea of religious liberty, doubted episcopal collegiality (for him the cardinals are the pope's senate), and championed unconditional papal supremacy, according to Xavier Rynne.

As Archbishop of Dakar he opposed de-colonialization, convinced of the "natural primacy" of the "white" Church over the "colored" Church.

In Italy, he is supported by Civilta Cristiana, an organization described as "fascist, anti-democratic, and schismatic" by the Italian Ecumenical News Agency (NTC) of Rome.

The **Affair Lefebvre** is thus something more than merely theological conservative vs. theological liberal.

And Pope Paul is faced with the possibility of the schism of Catholic conservatives — political, religious, and economic — both in Europe and the Americas. Hence, he moves slowly.

Instead of the muscular Jesus both God and man, **Dr. John Hick**, one of the authors, envisioned a flabby Christ, "possibly the most wonderful human being who ever lived, and certainly intensely open to God." Whatever that means.

Anglican Bishop Stephen Neill harrumphed, "A God who loved us a little, but not enough to become one of us!"

Thank you, **Dr**. **Hick & Co.**, but no thanks.


In the long interim between rectors, Fr. Justo Andres, assisted by his lovely wife Nancy, has led Good Shepherd with distinction, style, and effectiveness.


