# **BISHOP VISITS NAMIBIA**

Bishop Edmond L. Browning, Bishop of Hawaii and the staff officer for public issues at the Episcopal Church Center were asked by Archbishop Robert K. Runcie of Canterbury to join an Anglican delegation for a two-week pastoral visit to Namibia (also called South West Africa).

The invitation comes at the request of the Bishop of Namibia, the Rt. Rev. James Kauluma, a visitor to Hawaii in 1982, and with the support of the Primate of the Church in Southern Africa, the Most Rev. Phillip Russell.

This is the second time this year that the Archbishop of Canterbury has asked such a delegation to visit Southern Africa for pastoral reasons. The first was the Holy Week visit in support of Bishop Desmond Tutu in the face of a South African government inquisition into the South African Council of Churches.

Bishop Browning and the Rev. Charles A. Cesaretti will be joined in Johannesburg, South Africa, by the Most Rev. John M. Watanabe, Primate of the Nippon Sei Ko Kai (Japan); the Rt. Rev. Yona Okoth, Primate-elect of the Church in Uganda; the Rt. Rev. J. L. Thompson, Bishop of Stepney and Suffragan in the Diocese of London; Mr. Terry Waite, Archbishop Runcie's Anglican

Communion affairs assistant (and also a recent visitor to Hawaii), and the Rev. Winston Ndungane, provincial liaison officer for the Church in the Province of Southern Africa.

This delegation marks a significant change in the way that the Anglican Communion operates. Rather than through single area-to-area relationships, delegation members are acting more in concert to express pastoral concern and collect and disseminate information about troubled areas around the world.

After briefings on October 13, the delegation will travel to Namibia where they will form teams. It is their hope to visit all of the parishes in the country between then and October 25. After their visits, they will meet with Archbishop Russell, make a public report and then report in detail to Archbishop Runcie and to their own communions. Bishop Browning will report to the Executive Council of the American Church at its November meeting in New York.

This will be the second time this year that an American Bishop - and a member of the Executive Council has gone into Namibia. In June, the Rt. Rev. Furman C. Stough, together

with lay and clerical representatives from the Diocese of Alabama, spent three weeks in Namibia with which they have a companion relationship.

Namibia, formerly known as South West Africa, has been under the administration of South Africa since December, 1920, under a League of Nations mandate. Since 1946, various

international initiatives to place the country under United Nations trusteeship have failed. Current negotiations by the United States, Canada, Great Britain, France, and West Germany

acting as a contract group to define the status of the territory have shown little progress due, in part, to the linkage to the political climate in Angola which is on Namibia's north-

ern border, more conservative politics in the United States, a recent retreat from American interest in human rights, and the power of certain megamultinational corporations.

Readers of the Hawaiian Church Chronicle will remember the report on Namibia following Fr. Brian Grieves' visit which appeared in the April 1982 issue.

## IN **MEMORIAM**

Margery Helen McKinney, widow of Fr. George William Frederick McKinney, late Rector of Calvary Church, Kaneohe, died Friday, September 30, the Feast of St. Jerome.

Marge, as those who knew her best called her, followed a superb ministry whilst married with a triumphant ministry in her widowhood.

For many years she ran with great style and success the Queen Emma Gift Shop and Book Stall at St. Andrew's Cathedral, of which Jerome would have approved. And she refreshed all those who knew her as a neighbor on the Cathedral Close, her home, and all she dealt with in the Book Stall, which Jerome could not have done at all.

In their life together, Fr. Fred and Marge served parishes in Puyallup, Washington; Owensboro, Kentucky; Cheyenne, Wyoming; San Antonio, Texas; Richmond, Texas; and other parishes in Texas and Canada.

Fr. Fred and Marge were married July 25, 1940. They had no children and are survived by a sister Ida and a brother-in-law, a priest, Fr. Irwin Mc-Kinney, remembered by many in Hawaii with greatest admiration and affection as the interim-dean of St. Andrew's Cathedral (1970-1971) and the Vicar of Christ Church and St. Jude's on the Island of Hawaii (1967-1970).

Like few Christians—such as Fr. Paul Savanack, Fr. Norman Ault, Maggie Monteiro, Jimmy Kau, and a few others-Marge left each the better for encountering her that day.

Marge's father was in the Church Army. Her husband was a distinguished and effective priest. And she herself was also an heroic soldier of the Lord, who served with distinction in his service and—despite final fatigue-held that last trench with nobility and honor to the end.

"For God is not unrighteous to forget your work and labor of love, which you have showed to his name, in that you have ministered to the saints and do minister (Hebrews 6:10)."

Thompson, Bishop of Stepney, England; Father Charles Cesaretti, Public Issues Officer, ECUSA; and Father W. N. Ndungane, Provincial Liaison

Officer of the Province of South Africa.

Needless to say, I feel very humbled to be asked to be a part of such an important visitation. I have wondered about "why" and the one clue that I do have is the meaningful relationship that Brian Grieves and a good many of you have had with the Diocese of Namibia over the past years. We have been blessed in years past with the visits of the late Bishop Colin Winter, and more recently with the visit of Bishop Kauluma and Dean. In a real sense I will be representing all of you in your love and concern for the sufferings of the people of Namibia.

As I wrote recently to the clergy of the Diocese, I could not be more grateful for their willingness to adjust schedules so I could accept the Archbishop's invitation. Many of you have been encouraging regarding the trip and my participation in this mission. I am most grateful to all and to Dick Chang, Rudy Duncan and our office staff, for I know it places an added burden being out of the Diocese for that period of time.

I would especially ask all of you to remember the laity and clergy of the Diocese of Namibia in your prayers. As the dates of the visitation come closer, I would also ask that you remember us in yours and that the intention and hopes of Archbishop Runcie may be blessed in every way. Faithfully yours,

## Fire Sweeps Kihei Area

This was the headline in the Honolulu Star-Bulletin on the morning after our now famous Kihei Fire!

Although over 1,200 acres were scorched by the several fires on August 29th, our own 3 acres were miraculously left untouched.

The fire came within 30 feet of our storage shed and church school pavilion on the mountain side of the property and right up to the driveway on the Wailuku side! In other words, the 20-30 ft. flames came right up to our fence line and stopped!

It all began for us about 5 p.m. on Monday, August 29th. The fire had originally gotten started about 3:30 p.m. about two miles south of us on Welakahou Street. The winds kept it moving until it reached and passed us, stopping just behind the Maui Lu Resort.

The storage shed was totally emptied of its contents and all we could do was pray that there would be something other than the walls of the old ruins left come daylight.

Our prayers were indeed answered, as not a blade of grass was endangered.

Linda and I were evacuated from our apartment at the Koa Resort when the fire melted the windguard on the tennis court just about 40 feet from our unit. Fortunately, all was well when we returned on Tuesday morning after spending the night at the Junior Warden's home. Just a bit of smoke was all that remained of the excitement the night before!

However, in everything there is a lesson to be learned: and this experience with the fire was no different.

As I stated in my sermon last Sunday after the fire, our lesson was this: "It is true we could have lost everything the night of the fire. As for the

personal effects in our home, their value was not in their financial or monitary worth but in the part they played in our life. The memories of those moments can never be taken away from us by a fire or another person. As for the physical plant, the Church property, we were never in any danger of losing Trinity Church by-the-Sea, because we all survived! The Church is us — not the property."

• To all those who came running when they saw the location of the smoke cloud, especially: Mike Ellingboe (Manager-Koa Resort), Greg Howard, Pam & Kerry Brittain, Sondra & Zane Johnson, Ted & Linda Ion, Jack Crouse, Kirk & Dorcas Munroe. Together these men and women emptied the storage shed of its contents!

• To Terry and Charley, who live across the street at Menehune Shores, for their assistance in watering-down the storage shed to protect it from the flying embers and the heat of the fire!

• To all those who came running the day after the fire, to assist in putting things back together, especially: Jack Crouse, Herb & Marilyn Hynson, Pat Slattery, Dorcas Munroe, Joan Wheeler, and Ted Ion.

• A special mahalo nui loa to Ted & Linda Ion for taking Linda and me in the night of the fire.

• A warm mahalo as well to all the clergy of Maui, especially our good Bishop, for their calls and visits of concern. This love was appreciated by all!

## QUIET TIME IS "IN"

Much of the sharing at the Labor Day weekend camp was prefaced by "During my quiet time . . . " And what was shared was exciting, the product of a real relationship with the Living God.

Many at Calvary, Kaneohe, obviously are reaping the rewards of extended periods of time in communication with our Lord.

If you're not one of them yet, but would like to be, here are some sug-

Set aside a minimum of an hour in a place where you will not be disturbed, preferably a place where you can talk aloud, read Scripture aloud and sing freely. Outdoors in God's creation is best, if you can manage it.

Take your study Bible (with concordance to locate Scripture) and writing materials.

Experiment to find the best way for you to enter into the presence of God—perhaps confession, acceptance of forgiveness, and then praise.

Then, considering that the object of quiet time is spiritual self-renewal and self-edification, search your heart:

How are you being led? Into thanksgiving? Meditation on Scripture? Scripture study? Prayer of petition?

If you are puzzled or troubled, tell God about it, out loud. Whatever direction you take, be sure to allow time to listen for what God has to say to you, perhaps recording this in a notebook.

Jesus, our Mediator and High Priest, who "ever liveth to make intercession" for us, is there with you. So you can be sure God is listening and will respond by speaking to your

"Be still and know that I am God." Quiet time spent with the Lord grows better and richer and fuller and even more exciting with practice (and just wait till you try a two or three day retreat!)

The rewards are a thousand fold the effort invested. Try it. You'll see!


Committee, in accordance with the Rules of Order for the Diocesan Convention.

### **RESOLUTION #1**

#### **SUBJECT: MASTER PLAN AND CAPITAL FUNDS FOR CAMP MOKULEIA**

WHEREAS the Episcopal Church in Hawaii has served many thousands of persons both in the Diocese and the general community through its ministry at Camp Mokuleia since obtaining the property in 1947, and

WHEREAS a feasibility study conducted in 1981 affirmed the importance of this ministry in the life of the Diocese while at the same time pointing out the deteriorating condition of the aging buildings on the site, and

WHEREAS in response to this study the Bishop and Diocesan Council appointed a Task Force to Master Plan the existing site at Mokuleia, and

WHEREAS that plan will be completed in early 1984,

THEREFORE BE IT RESOLVED that this 15th Annual Diocesan Convention of The Episcopal Church in Hawaii directs the Camp Mokuleia Task Force to share the Master Plan with as much of the Diocese as possible prior to the next Convention allowing for modifications if worthy of considerations, and

BE IT FURTHER RESOLVED that this Convention hereby direct the Task Force to prepare a resolution for next year's Convention calling for a capital fund drive to be held in 1985 with the first phase of construction to begin in that same year so as to enable implementation of the Master

### **RESOLUTION #3**

#### **SUBJECT: CANONICAL REVISION - CANON 16**

The following proposed revision to Canon 16 has been drafted by the Chancellor. It will be reviewed by the Committee on Constitution and Canons which will enclose a copy of its report and recommendations in the next Convention mailing.

Sec. 16.1. There shall be a Commission on Episcopal Schools of the Diocese consisting of:

(a) Ex-officio, the Heads of all schools which provide education for young people equivalent to that provided by kindergartens or any of the first 12 grades of the public school system and which have been established by a Mission, Parish, or other institution of the Diocese, and

(b) Four (4) lay members appointed by the Bishop and confirmed by majority vote of members of the Convention. The Lay Members shall be appointed for two (2) year terms which shall be staggered so that two (2) shall be appointed and presented to the Convention for confirmation each year. Elected members may not serve more than two (2) consecutive full terms. The Bishop shall appoint the chairman annually from the ex-officio membership of the Commission.

Sec. 16.2. The Commission shall seek to raise the level of awareness within the Diocese of the educational opportunities presented by the Episcopal Schools and shall seek to enhance the cooperation and mutual support among the Episcopal Schools.

## **RESOLUTION #2**

#### SUBJECT: CLERGY MINIMUM COMPENSATION SCHEDULE FOR 1984

WHEREAS, the Compensation Review Committee of the Diocese has made recommendations to the Diocesan Council regarding Mission and Diocesan staff clergy compensation for 1984, in accordance with Canon 38.5, and

WHEREAS, the Diocesan Council has received the recommendations of the Compensation Review Committee and incorporated said recommendations with amendments into the 1984 Diocesan Budget, it is therefore

RESOLVED, that the minimum compensation schedule for fulltime parochial clergy for 1984 shall be indentical to the compensation schedule attached hereto.







Confirmation at Good Samaritan, Palolo: Sydney Kometani (left), Bishop Browning, and Julie Kometani.




The Rev. Karen Swanson, deacon and teacher at St. Andrew's Priory School, is amongst Hawaii's newest clergy.

Hawaii now has 4 women clergy: the Revs. Alice Babin, Heather Mueller, Lynette Schaefer, and Karen Swanson.





He later spent a few days on Kauai with the Tanakas and came to the Wednesday night prayer/study group. It was a wonderful surprise, and he looks well.





A small crowd gathered to watch, as the man stripped to the waist, occasionally lifted a large chunk of concrete or a wooden staff into the air. He had suspended a flag made from a blue Tshirt from one corner of the tower.

After talking to one police officer for some time, the man suddenly announced that he was coming down. He rang the church bell once, and then descended, joining the police officers in apparent good spirits.

# CHINESE LANGUAGE MINISTRY RENEWED

It has been a very exciting and satisfying year for those of us involved in planning and participating in the new Evangelism Ministry to the Chinesespeaking. This joint project is being sponsored by St. Peter's and St. Elizabeth's Churches and is supported by

funding from the Episcopal Asiamerica Ministry, the Diocese of Hawaii, and the two churches involved.

On November 12, 1982, the Rev. Winston Ching and the Rev. Albany To initiated this project. The Rev. Dr.

Gerald Gifford, Fr. Richard Rowe, Francis Kau, Brian Lee, Gretchen Jong, Patricia Ramos, and Marilyn and Douglas Ho served on the first steering committee.

A second steering committee was organized on January 2, 1983. The members of this committee are Peter and Mimi Wu, Fanny Tsui, Siu Pun Kwock, Gretchen Jong, and the Rectors of St. Peter's and St. Elizabeth's.

Posters and advertisements in the Chinese newspaper publicized the Chinese bilingual services which began on a weekly basis Chinese New Year's (February 13). Previously there were four monthly services. The services are at St. Peter's. The Rev. Richard Rowe leads the service, with assistance from the Rev. George Lo at 11:30 a.m. each Sunday.

A Chinese Friendship Club meets frequently for lunch after the Sunday service. It sponsored a Potluck Dinner Fellowship on March 26, featuring guest speaker Mrs. Yuk Pang Law. Mrs. Law is the Chinese counselor for the Kalihi-Palama Immigrant Service Center. The KPISC office is located on the grounds of St. Elizabeth's Church and is one segment of the services provided by the Palama Interchurch Council.

The Chinese Friendship Club is also conducting English classes at St. Peter's on Friday evenings. Mrs. Fanny Tsui and Mrs. Mimi Wu are the instructors.

The program for this ministry is coordinated by the newly-selected Lay Evangelism Coordinator, Mr. In-sing Leung. Mr. Leung holds a B.A. and a M.A. in philosophy from the University of Hong Kong. He is currently a graduate student at the University of Hawaii, seeking a Ph.D. in Eastern Religions.

# ORDINANDS TO THE DIACONATE

To serve as a deacon is to fulfill in one particular way Christ's command that he came "to minister, not to be ministered unto."

During the last three years, communicants have undertaken studies to enhance their ministries as Christ's serving ministers.

Here are profiles of three of those to be ordained on Nov. 11. Profiles of ordinands Meg Thompson of St. Clement's and John Holmes of Holy Apostles were not available.

• Dorothy Nakatsuji. The mother of two sons, she is a Registered Nurse with a Master's degree in Psychiatric Nursing and a minor in Cultural Anthropology. Her work experience has been clinical, administrative and teaching. She has been a staff nurse and head nurse of a psychiatric unit, clinical specialist on a psychiatric unit, acting Director of Nursing Services of a 250 bed general hospital, instructor in nursing at the University of Hawaii and Consultant on Education and Practice for the Hawaii Nurses' Association. However, she has not been active in nursing for the last few years. More recently, she has worked with kindergarten through third grade children with school adjustment problems.

Currently she is a member of the Health Plan-Hawaii, chairman of the Board of Directors of the Hawaii Medical Services Association (HMSA), and patient care coordinator for Hospice Hawaii.

Over the years Church service has included: Member of the WOSA Board of Directors, Cathedral Chapter, Cathedral Nominating Committee, Cathedral committee to assist our Vietnamese family, and Diocesan Nominating Committee. Chairman of the Cathedral Worship Committee and the Cathedral Profile Committee (subcommittee of the

Dean's Search Committee.) Delegate to the Diocesan Convention.

Mrs. Nakatsuji became a postulant in the Third Order of the Society of St. Francis in May of 1973. "I was noviced in January 1974 and professed on April 30, 1976. I have been newly elected to the Third Order Chapter. At the present time I am convenor of the Hawaii Fellowship and counselor, by mail, to three novices and two postulants. I am listed as spiritual director for one novice and one postulant who reside here. These responsibilities are for the specific purpose of helping Tertiaries grow spiritually in their own unique way, at their own pace, guided by the principles of St. Francis of Assisi. The Franciscan vocation is a call to "take to heart the Gospel and its expression in the Church." It is the particular way and discipline I have undertaken to order my life in "dedication to the ideals of the Gospel."

Franciscans strive to grow spiritually so that our individual lives become more and more an expression of and witness to the incredible mystery of God's love for us. In a sense the Franciscan vocation is a way of preparing us, spiritually, for the "loving service of Christ's brethren in the world." The Distinctive Diaconate may be the ministry within which my present vocation can be exercised in a more visible, disciplined and structured manner. "I am firmly and deeply committed to the servanthood ministry of the Church as described in the Distinctive Diaconate Program proposal. My love for and commitment to our Lord, Jesus Christ, are clear to me. I believe servanthood is the ministry I am being called to. The Distinctive Diaconate may be a fuller and more disciplined expression of such a ministry."

•Linda Akana. I was asked to send you a description of our Lord's ministry through my involvement with cancer patients here on Kauai.

Beginning in November 1982, I was asked to join the G. N. Wilcox Memorial Hospital staff as Cancer Care Coordinator. The job entails patient and family counseling on three levels: physical, emotional, and spiritual.

I help these persons assess their physical symtoms; give them information about alternatives of treatment and side-effects; help with communication and understanding within the family as well as with the doctor; assist them in maintaining control of treatment and care; explore with them their fears, goals, and relationship with others; help with obtaining equipment and financial assistance; encourage their spiritual beliefs and practices which enable them to find comfort and reassurance - to live with

As you can see, it is only by His grace - by Grace alone - that I can do these things.

Due to the fact that many families are choosing the alternative of having loved ones at home during the terminal phase of illness, Kauai Hospice has been organized to make available Hospice care to Kauai people through direct volunteer services. Kauai Hospice focuses on living and places emphasis on quality of life remaining rather than on death itself.

Additionally, each Wednesday evening, a group of people meet at Christ Memorial Church in Kilauea for intercessory prayer. We include individual cancer patients and others by name who come to our attention. We

share and pray and by His grace find comfort and nurture of our own lives as well. This prayer group lately has been doing some interesting study of Jesus' miracles as they pertain to our experiences of answered prayer. I teach acolyte training and help with confirmation classes as well. [Linda is a member of the distinguished Akana Family of Kalihiwai and Kalihikai, who have included that noble lady Julia, distinguished gentleman John, fisherman of immense talent, farmers of great wonder, Puanani Hanchett, and more, including saints who bear their crosses grandly and well.]

• Eleanore Green Akina, M.D. I have been asked to write you a brief description of my ministry at the present time. The following is written in response to that request and reflects the items in our agreement.

My primary ministry is that of a psychiatrist and child psychiatrist. As such I am working with the Windward Children's Services, a function of the Windward Counselling Center which is a part of the Mental Health Division of the State Department of Health. In this work I spend four days a week providing direct services to clients, consulting with other team members, and with others of the center who deal with children's problems, and consulting with the schools of the Windward District.

I also spend the equivalent of one day a week in private practice, dealing with both adults and children as the need arises. In addition I am assisting with the pastoral care of the congregation of Emmanuel, particularly in visiting the sick, and some pastoral counselling. I look forward to the time when my ministrations to the sick will include being able to bring them the Sacrament.

## **CAMPUS MINISTRY NOTES**

Our life at UH-Manoa is beginning to take form.

Early in September we sent out our first newsletter to those students, faculty and staff whose names we have been given, as well as to the clergy. We mailed out 221 of them!

I am meeting with students trying to get a sense of what is happening in their lives and how we can help.

Our strategy to build this community is focused around our commitment to work both with Episcopalians and non-Episcopalians. We are working with University Christian Ministry by participating in the book study on Tuesday noons at the Lutheran Campus Ministry (239 Vancouver Drive) on When Bad Things Happen to Good People, by co-sponsoring Faith, Science, and the Future lectures Thursdays at noon and by participating in fellowship programs with the Lutheran, Methodist, and UCC campus ministries. We look forward to doing some things with Newman Center as well.

Our intention is to have our own programs; as well. We hope to start a Bible study soon on campus. We also will be looking forward to having our own fellowship night. We say the Daily Office, morning and evening prayer, Monday through Friday at Wesley Foundation. The Episcopal Campus Ministry Committee (ECMC) has been meeting faithfully, planning the programs.

On September 16th, ten of us went to the dinner and program sponsored by the Lutheran Campus ministry.

Participation at the Offices has varied from 1 or 2 to as many as 8 or 9 people.

The next ECMC meeting will be on October 7 at Wesley Foundation (6-8 p.m.). We will also say Evening Prayer at 5 p.m. We will eat with the Wesley students and then move upstairs to our office for our meeting. Cost of the dinner is \$1.25. Advance notice is needed
