

Following are profiles of those members appointed to fill this task. Please keep them in your prayers.






Mrs. Annette Jim

participated in the Women to Women outreach to China with Women in Mission and Ministry, Episcopal Church USA. In 1995, she attended ABIL's convention for Women of Color.




Mrs. Bettye-Jo Harris, Co-Chair


The Rev. Canon Timoteo P. Quintero.

THE ANGLICAN CHURCH OF MEXICO

On February 25, 1995, The Anglican Church of Mexico, the newly Autonomous Province of the Anglican Communion held its first General Synod in Mexico City. The Right Reverend Jose G. Saucedo, Bishop of Cuernavaca was elected its first Primate.

On May 13, 1995, Bishop Jose G. Saucedo was installed and enthroned by the Most Rev. Edmond L. Browning, Presiding Bishop of the Episcopal Church in the United States as first Primate of the Anglican Church of Mexico.

The installation and enthronement took place at the beautiful Cathedral of San Jose de Gracia in Mexico City, to a standing room only crowd.

The new Primate of the Anglican Church of Mexico (Inglesia Anglicana de Mexico) stated that it was a great pleasure to have Bishop Browning and the Primate of the Anglican Church of Canada, The Most Rev. Michael Peers, together with many bishops of the Ninth Province, all the bishops of Mexico and clergy and laity take part in this most memorable and historical occasion.

In 1958 Bishop Saucedo was consecrated as the second Mexican bishop of the Missionary District of all Mexico. In the ensuing years Bishop Saucedo lead the Mexican Church to where there are now five diocese.

On January 1, 1995, the Anglican Church of Mexico became an Autonomous Province of the Anglican Communion.

ARTHUR AWAI

1921 -- 1995

Mr. Arthur Awai died in Honolulu April 24, 1995. He was 74. His death was sudden and unexpected.

Arthur attended Iolani School on the old Nuuanu campus where he was Father Bray's all-purpose fellow and confidante. He resided in the good padre's home and, in return, monitored the schedule, productivity, and behavior of all of Father Bray's chargers - a feat only the combination of Father Bray and Arthur Awai could pull off. Till this day those who endured the experience will speak of their blessings as all have grown-on to be productive citizens in the community.

Born on March 6, 1921, in Mahukona, Hawaii, and raised in a family of nine girls and two boys, Art learned the importance of responsibility from his father. Being the eldest son, Art looked after his mother and sisters when his storekeeper father was away at work

A man of God, Arthur was a member of the Episcopal Church for 57 years - he was a member of St. Andrew's Cathedral. He also served in numerous programs of the Episcopal Church - The Standing Committee under Bishop Lani Hanchett, The Search Committee for Bishop Browning, The Search Committee for Dean Bright, and member of The Commission on Ministry until his death.

Mr. Awai graduated from Iolani School and the University of Hawaii. He was a cornerstone of the Iolani Alumni Association and Booster's Club. He is survived by his wife Eileen, a daughter Marj, of Tampa, Florida, and a son Tom, of Arizona.

Services were held at St. Andrew's Cathedral on Saturday, April 29, 1995.

PRESIDING BISHOP CLARIFIES ROLE IN PROSECUTION OF ELLEN COOKE, ADDRESSES PAIN OF HIS STAFF

A week after he shared with his staff the results of an auditor's report on the embezzlement of \$2.2 million by former treasurer Ellen Cooke, Presiding Bishop Edmond Browning met with them again to discuss the implications.

Addressing what he called "the confusion on whether or not we intended to prosecute" in the May 1st statement, Browning told his staff, "Since the whole thing began, there has never been any question whether there should be prosecution. It is unthinkable that this matter would not be prosecuted," he said. The only issue was one of timing because nothing could be done "until the auditors finished their work and the issues became visible to the whole world," he said.

Browning has been receiving many letters and phone calls urging the church to prosecute and expressing frustration over what some perceived as a hesitation to proceed. He revealed, during open forums with the staff, that federal authorities contacted his office within days of his release of the audit report and that the church has been cooperating with them. "We were prepared to go to the government if they had not called us," he said.

"Though federal authorities have taken the first steps toward criminal prosecution, civil prosecution to recover more of Mrs. Cooke's assets would be premature because we do not vet know the amount we will recover" Browning said. He and treasurer Don Burchell told colleagues that "all or most" of the amount. "This figure is in part dependent on the sale prices of the two pieces of property formerly owned by the Cookes for which we now have title," he added. The Virginia farm is on the market for over \$800,000 and the house in Montclair is listed at almost \$700,000, although each has a mortgage of about \$350,000.

Dealing with the pain in a moment of personal candor, Browning told his staff that "this whole matter has occurred on my watch and I take full responsibility for it... It is clear that I should have listened more closely and moved earlier." He said that he had defended Cooke because he had hoped that "by challenging her, she would change. But I was wrong. She did not and could not change."

Browning added that he was "deeply aware of the hurt Mrs. Cooke has inflicted" on members of his staff, especially those who left, and added that he was "dealing with my own hurt and pain - - and that of others." He expressed his determination "to do whatever is necessary to rebuild the trust." He said that he was particularly concerned that the trust levels between the national church and the local church not be

damaged. He expressed optimism,

pointing out that he has received

"expressions of enormous concern

for the staff and for me."

The provincial council of the church's Province II, meeting near New York City May 11 - 13, adopted two resolutions to "convey the deep concern of the assembled bishops and deputies for our church and for the scandal caused by the actions of the former treasurer." Delegates urged church leaders to "reassure the people that all appropriate steps are being taken

to ensure that justice will be served. There is fear that efforts at damage control and desire for reconciliation may overshadow the need for justice. We hope that the leadership will assist fully in any criminal prosecution and will not shy away from civil action to recover funds," said the letter, signed by provincial president Audrey King.


"The deputies also asked that the leadership reassure the church that vigorous steps are being taken to bring church accounting practices into compliance with standard accounting practices and that such assurance be widely distributed," the letter added.

"The embezzlement of funds by Mrs. Cooke is painful to all of us," King concluded. "It holds our church up to ridicule and is a further distraction from the work of mission. Full, public accountability on the part of the leadership is the necessary first step in bringing our church through this crisis."

THE EPISCOPAL THEOLOGICAL SEMINARY OF THE SOUTHWEST

Presiding Bishop Edmond Browning and diocesan seminarian Dan Leatherman met at the recent commencement of the Episcopal Seminary of the Southwest in Austin, Texas. Bishop Browning, head of the Diocese of Hawaii from 1976 to 1986, received an honorary doctoral degree from the seminary. Burchell announces that he is resigning as the church's treasurer

Presiding Bishop Edmond L. Browning announced June 6 that Don Burchell, who was elected treasurer of the church at February's meeting of the Executive Council in Rhode Island, "plans to leave our staff and return to Washington" in early July.

Burchell had been assistant treasurer when Ellen Cooke resigned her post as treasurer in January. Shortly after her resignation the staff discovered financial irregularities and Burchell brought them to the attention of the presiding bishop. Following a complete audit covering Cooke's tenure as treasurer, Browning released a statement May 1 that said Cooke had taken \$2.2 million.

The presiding bishop said that it was clear from discussions he and Pamela Chinnis, president of the House of Deputies, had with Burchell that "this has been an intense and painful time since the embezzlement was first suspected some five months ago. It has been enormously difficult for him personally."

Browning noted that "when we asked Don to take on this responsibility in the wake of our discovery of embezzlement, we knew the next months would be something of a clean-up and holding operation". The strain for Burchell has been even greater than suspected, though.

"The job he came here to do is not the job he now has, "Browning said in an interview. "It would be an understatement to say that having a household in one city and a demanding job in another - - which has meant a total disruption of family life - - has not contributed to wellness."

Burchell's open and cooperative management style has helped provide a "clearly needed time for healing," Browning said, but added that 'Don now believes that a move right now -- as we prepared to appoint a chief operating officer and a new controller -- will be healthy for him and timely for our work.

HIGHLIGHTS FROM THE DIOCESAN COUNCIL MEETING

At the May Diocesan Council Meeting, a motion was made, seconded and carried to approve a Planned Giving Policy, which will be used as a guideline for one year and will be subject to revision at the end of the year. It is noted that the policy allows the diocese to refuse property and that due diligence is necessary. The policy will also codify and clarify current practices, create financial stability for the Diocese, and create a consistent and systemematic implemetation system on accepting gifts.

A motion was made, seconded and carried that the Policies and Procedures Concerning Allegations and Incidents of Sexual Misconduct be accepted and is now in place for the Diocese of Hawaii.

Roman Catholic Church now faces its first divorced priest

Fourteen years after the Roman Catholic Church accepted married Episcopal clergy into the church, it now faces another historic event -- the first divorce of a Roman Catholic priest. A former Episcopal priest serving as a principal of a high school in the Roman Catholic Archdiocese of Mobile will soon divorce his wife of 18 years. According to a Newhouse News Service report, the wife will maintain custody of the couple's five children and the church will not be financially responsible in any way. The divorce is expected to fuel the already contentious debate over married priests. The Vatican approved special "pastoral provisions" in 1981 that allow Episcopal priests to join the Roman Catholic church. It is estimated that about 60 former Episcopal priests are now Catholic priests. - Episcopal News Service.

IRISH ANGLICANS SANCTION REMARRIAGE IN CHURCH

(ENS) The Church of Ireland recently voted to create a formal procedure for the remarriage of divorced people. Priests who choose to conduct second marriages will now have the formal support of the church and a set procedure to follow. The decision to formally allow remarriage was made at the the Church of Ireland General Synod held in Dublin. Priests of the Church of Ireland, as in the Church of England, can remarry divorced people or refuse to do so, at their own discretion.

CHURCH OF HOLY APOSTLES

Hilo, Hawaii



The Rev. Dr. Tom Taylor, the present rector, is the 18th priest at Holy Apostles since its beginning in 1903, when the Rev. Sidney Morgan began first holding services in the dining room of the Hilo Hotel.

Orginally, Holy Apostles was located in downtown Hilo, near the Hawaii County Library. In 1906, Rev. William H. Fenton-Smith from Kohala was asked by Bishop Resterick to begin acquisition of land and buildings. James M. Hind of Kohala provided enough funds for the purchase of 1/2 acre of land at Waianuenue Ave. and Ululani St. in Hilo. Additionally, he donated \$1325.00 for the total cost to build a hall to hold services. In recognition, the hall and mission was named St. James.

In 1908 a gift of \$3500.00 was sent from the Sunday School of Holy Apostles Church in Philadelphia for the erection of a building. By Christmas Day that year, the building was completed and the first service was held. The interior of the church was almost completely lined with koa panels and the Rev. Fenton-Smith carved the altar as a memorial to his father. To fulfill a request, the mission was renamed Holy Apostles as a memorial to the departed officers and members of the Philadelphia Sunday School.

A vicarage was built next to the church soon after 1910. All of these buildings were used for over 50 years. In 1938 and later years, stained glass windows were installed in the church.

By the late 1950's, the congregation considered moving the church from its location, because the land area was inadequate, especially for parking. Additionally, the buildings were infested with termites and the area was becoming quite noisy.

In 1961, 2 acres of land were acquired at 1407 Kapiolani St., just below the University of Hawaii Hilo campus. Plans were initiated for a new church building and parish hall. On December 20, 1962, during the tenure of Rev. Gerald Loweth, the new buildings were consecrated. The koa panels and stained glass windows from the original buildings

were incorparated into the new building.

The first baby to be baptized at Holy Apostles was Thomas Lofty Cook in 1906. Although he is unable to attend church now due to ill health, his 3 grandsons, their mother (his youngest daughter) and wife May are regulars at the church services and Sunday School.

The congregation is multiethnic, just as it was during the early
years. The composition of the
current Vestry members is an
indication of this. Members are
Marge Bergh, Priscilla Hop, Bob
Kovacs, Charlotte Kippen, Charlie
Kippen, Sandra Nakagawa, Denyse
Temple, Charlotte Holmes, Sandy
Troutt, Winnie Lum, Jr. Warden;
and Kikuye Kohashi, Senior
Warden. Members live mainly in
the Volcano, Keaau and Hilo areas.

Besides providing Outreach Funds to several organizations within the community each year, a number of parishioners are regular participants in preparing and serving meals at the twice-a-week Peanut Butter Ministry and Sunday evening Lincoln Park Feeding Program.

Resurrection Mission with Rev. Domingo Calag has had a close relationship with Holy Apostles and presently holds its Sunday services at 5:30 p.m. at the church.

The Children's Center, a lab school for the University of Hawaii Community College students in Early Childhood Education, utilizes the parish hall during the week. In preparation for its use, the Vestry, especially the Jr. Warden, was involved in arranging for retiling, renovating of restrooms and doorways, and painting of the building and parking lot.

Presently, Fr. Tom Taylor is ably assisted at services by lay readers and Deacon John Holms and retired but actively involved Fr. Edwin Bonsey.
