NEW FORMAT FOR CONVENTION

The 1997 Annual Meeting of the Diocesan Convention will take a slightly new format this year. This will be Bishop Chang's first Convention as Bishop of Hawaii. In former years, the Annual Meeting of the Convention started at 5 p.m. on the Friday and continued until Saturday evening. The Convention Banquet was held on the Saturday evening after the business matters were finished. Because of that timing, many of the delegates from the outer islands were unable to attend the banquet, having to return to their parishes for Sunday duties.

This year the Convention will start at 1 p.m. on Friday, October 24, thus allowing much of the business to be completed that day. The banquet will be held on the Friday evening, and it is hoped that this new timing will enable and encourage delegates from the neighbor islands to be present.

It is hoped that this year the business matter will be dealt with in a speedy fashion. At press time, only four resolutions had been submitted for consideration. If there is not too much debate on these, there will be more time for the delegates to unify as a church body.

October 1997 BISHOP EASTMAN TO BE CONVENTION SPECIAL GUEST ON OCTOBER 24

The annual banquet, Friday evening, October 24, will be graced by a special guest. The Right Reverend A. Theodore Eastman, D.D., L.H.D., Bishop of Maryland (Retired) will be speaking on "The Ministry of the Baptized."

Bishop Eastman, originally from California, graduated from Haverford College, Pa. and the Virginia Theological Seminary.

Ordained in California, Bishop Eastman was the Executive Secretary of the Overseas Mission Society of the Episcopal Church (OMS) for many years. During his assignment with OMS, he served short-term pastorates in Tokyo, Mexico City and Vienna. He served as a consultant to the House of Bishops for a year before returning to parish ministry. He was Rector of the Church of the Mediator, Allentown, Pa. for four years and became rector of St. Alban's Church, Washington, DC in 1973. In 1982 he was elected Bishop Coadjutor of the Diocese of Maryland, becoming Diocesan Bishop in 1986. He retired as Bishop of Maryland in 1994.

Bishop Eastman's ministry has been marked by a continuing concern for the mission and unity of the Christian Church. He served as Vice Chair of the Standing Commission on World Mission, Chair of the Presiding Bishop's Fund for World Relief and Chair of the Standing Commission on Ecumenical Relations. His interests in mission and ecumenism have taken him to more than three dozen countries in Africa, Asia, Latin America, Europe and the Middle East.

Bishop Eastman has been active in the field of theological education,

serves as a member of the Board of Trustees of Listening Hearts Ministries, and serves on the Chapter of the Washington National Cathedral.

He is the author of many books including: Christian Responsibility in One World, Chosen and Sent: Calling the Church to Mission, and The Baptizing Community: Christian Initiation and the Local Congregation.

In addition to the Banquet, clergy will have the opportunity to hear Bishop Eastman at the Thursday, October 23rd Clergy Conference. Mrs. Eastman joins her husband on this visit and will be speaking to the Episcopal Church Women at the Annual ECW Luncheon Friday, October 24, 1997.

Sarah Tice Eastman is a woman of God you will certainly want to meet. Women of the diocese will have the opportunity to meet her at the ECW Annual Meeting. All members of the diocese (no gender discrimination) are welcome to participate in the ECW Luncheon planned for Friday, October 24, at 12:15 p.m., just prior to the opening of the Convention's 29th Annual Meeting. Mrs Eastman's theme will be "Enlarge the Site of your Tent".

Sarah Virginia Tice married A. Theodore Eastman after completing her B.S. degree in Chemistry at Mount Holyoke College and began a career in cancer research. She changed her career to that of wife and mother while the couple's three children were young and accompanied her husband as his ministry took the family to many parts of the country.

As their children matured, Ms. Eastman returned to the field of medical research, first at Georgetown University and later at the National Institutes of Health, Bethesda, MD.

During her husband's years as Bishop of Maryland (1982-94), she developed a deep concern for housing for the poor. As a consequence, she became the founding head of Baltimore Housing Ministry, a voluntary agency providing transitional shelter for those in need.

Her interest in horticulture led her to take the initiative in establishing Friends of the Cathedral Gardens, a group responsible for landscaping and maintaining the grounds surrounding the new Diocesan Center in Baltimore.

Currently Ms. Eastman serves on the Board of Listening Hearts Ministries and the Flower Guild of the Washington National Cathedral. In addition to gardening and flower arranging, Ms. Eastman's interests include gourmet cooking, travel and photography.

BISHOP'S LETTER

Dear Sisters and Brothers in Christ,

When was the last time that you paused in quiet prayer? When were you last in that holy place of your spirituality finding renewal and refreshment from experiencing the presence of God? How often do we make the effort to walk slowly or sit quietly in God's presence? As we are deluged by preparations for the new school year, by tensions of time management, and by the demands of family, it is important to pause. For me, the opportunity came recently at the deacons' retreat, an unanticipated blessing in my busy schedule.

Last month the deacons of our diocese had a one-day retreat at a beautiful location on Windward, Oahu. For me it was a time of renewal. After seven hours I came away with new energy and a renewed focus on my ministry. The transition point of the day occurred at mid-morning during the forty-five minutes of silence when we could sit, read, journal, or walk. I chose to walk, but not a walk about the grounds of the retreat center. I chose to walk the driveway. It took me nearly forty-five

minutes to traverse this distance of some fifty yards.

This was the first time since my surgery in 1996 that I used a technique learned first as a youngster in aikido training and again at an Alban Institute Spirituality program. It is an exercise to walk in slow motion with controlled breathing. The ideal is for you to walk with controlled breathing while in deep prayer. As you begin your walk, you begin to unburden yourself of everything that you brought with you to the walk. As your mind begins to clear, you begin a prayer or chant. I have often thought of it as "walking tai chi."

I began my walk with a great deal on my mind: the deaths of Lynette Schaefer's mother, Katharine Kennedy, Princess Di and Mother Teresa, preparations for our diocesan convention, family and guests visiting from California, a desk covered with unfinished tasks, to name a few. It had been a very busy week and there was so much

left undone. I was tired, anxious, and angry as I took my first steps down the driveway. After a few minutes my mind moved from my fatigue and everything that I had brought with me to the retreat. I began to repeat the words of Hymn 310, "O saving Victim, opening

the refrain from Hymn 178, "Alleluia, alleluia! Give thanks to the risen Lord" quietly replaced those words of Hymn 310 and stayed with me until I finished my walk refreshed and renewed.

Living our baptismal covenant is nurtured by disciplined spirituality. Spirituality is an integral part of our Christian lifestyle. There must be intentional "time outs" when we can allow the presence of Christ Jesus to lift the burdens that separate us from God and from people around us. These pauses in prayer can become part of the rhythm of daily schedules: the pause to give thanks before meals....the silence before worship that opens self to God's presence.....the time spent meditating upon Holy Scripture.

Pause and come to know the power of God in Christ to refresh and renew.

Members of HEPAM attended the twenty-fourth Episcopal Asiamerica Ministry (EAM) National Consultation in Tacoma, Washington on August 11-16, 1997.

The Consultation in an important part of the national program to enable congregational development, leadership training, and material resource development.

The Most Rev. Bundo Kim, Primate of the Anglican Church in

Korea, was a special guest. The Rev. Dr. Winston Ching, officer for Asiamerica Ministry at the Episcopal Church Center, was also present.

Participants with key roles included The Rev. Canon Timoteo Quintero, Convener of the Filipino Convocation, Arthur Kusumoto, EAM Representative to

Chalice bearers during the daily worship services included The Rev. Imelda Padasdao, The Rev. Ernest Uno, and Gretchen Jong. Also attending were Barbara Cowell, Louise Quintero and Ellen Ching.

Workshops offered were "Lay Ministries" by The Rev. Canon Edmund Der; "Leadership Development I & II" by nine women; "Stewardship" by Mrs. Pamela Tang, The Rev. Canon Benjamin Pao and Ms. Terry Parsons from

the Episcopal Church Center; and "Parish Administration" by The Venerable Michael Kendall.

There were three evening teaching missions held at St. John's, Olympia; Holy Family, Tacoma and St. Peter's, Seattle. Concrete suggestions, powerfully moving experiences

and challenges to ministering into the next millennium were presented by the speakers: The Rev. Dr. Fran Toy (Hearing), The Rev. Dr. Fred Vergara (Preparing & Commissioning) and The Rev. Joseph Mai (Responding). At the last worship service following the homily on Commissioning, every participant was presented with a wooden cross by a convocation convener.

A very exciting development occurred as "THE EAM WOMEN" was officially formed. Maria Ridgeway served as a facilitator for this movement. The new leaders are Fran Toy, Gretchen Jong and Harriet Kollin. The women are working on a leadership development manual which would be especially helpful in Asian communities. They will send several representatives to the Council for Women's Ministries meeting on October 2-5, 1997 in San Bernadino.

The EAM Youth and Young Adults had a very successful conference the week before the Consultation. Joshua De La Cruz, Caren Walsh and Amy Tamura were participants at the conference.





Four resolutions submitted to **Convention for consideration**

At the time of going to press, four resolutions have been submitted for consideration at the Annual Meeting of the Diocesan Convention later this month.

Resolution #1: "Community Correctional Centers Concerns Committee" (Submitted by the Kauai Deanery).

TEBE IT RESOLVED, That the Diocese form and fund the Community Correctional Centers Concerns Committee.

RATIONALE: Our Lord commanded that we be concerned about those incarcerated in our communities. The needs are great. We should at least be providing Bibles and other religious material to those in jail.

Resolution #2: "Change to Canon 2.8" (Submitted by All Saints' Vestry).

BE IT RESOLVED, That Canon 2.8 be changed to read -"....provided, however, that the lay delegates representing such delinquent Parish or Mission may be admitted to seats and votes upon the payment in full of such existing delinquency, or...."

RATIONALE: Canon 2.8 currently provides that Parishes and Missions are delinquent if assessment is not paid by the end of the fiscal year and as a result can only be given seat and vote when the assessment is paid and the convention votes them in. This year All Saints' issued the check for the year end payment on December 31 and sent the check to the Diocese but it was not received until January 6. The treasurer stated that we are delinquent and do not have seat and voice at convention this year

until voted in. This is wrong! We too have cash flow problem. We made a good faith effort and we are being penalized for it.

Resolution #3: "Compensation Schedules for 1998" (Submitted by Diocesan Compensation Review Committee).

BE IT RESOLVED, that the Clergy Compensation Schedule for parochial clergy for 1998 shall be identical to the 1997 clergy compensation schedule. However, we urge all congregations to consider incremental annual increase within each range.

RATIONALE: The above is the resolution that is required of the Diocesan Compensation Review Committee under Diocesan Canon 38, Sections 1 and 5.

Under the current economic situation in the State of Hawaii, for the fourth year, we cannot in good conscience raise the established salary range, by a mandatory percentage increase across the board. However, Vestries and Bishop's Committees are urged to look at incremental increases based on active years of services in the church within the salary ranges established by Convention.

Resolution #4: "Convention Schedule". (Submitted by the Maui-Molokai Deanery).

BE IT RESOLVED, The Annual Meeting of the Episcopal Church in Hawaii be held on Friday evening and during the day on Saturday on the designated week-end.

RATIONALE: Many people have expressed concern about the need to be away from their work places on Friday. Some people may be eliminated from being present at Convention because of their work schedules; the representation may not be as diverse as it otherwise could be. Some people have to make financial sacrifices from loss of wages which could be avoided with another schedule. The Convention resolution can give the body an opportunity to put the issue to a vote.
