### The Rev. Dr. Sheryl Kujawa to be Keynote Speaker at Diocesan Convention



The keynote speaker at this year's Diocesan Convention will be The Rev. Dr. Sheryl Kujawa. Dr. Kujawa is Associate Professor of Pastoral Theology and the Director of Congregational Studies ( which includes congregational development, transformational leadership, education and ministries with children) at the Episcopal Divinity School.

Before joining the Faculty of the Episcopal Divinity School, Professor Kujawa was Co-Ordinator for Youth Ministries at the Episcopal Church Center from 1988-1998. During this period, she developed adult training and educational resources for young people as well as adults. In addition Dr Kujawa developed intercultural, anti-racism and international strategies and resources. She was also a member of the Presiding Bishop's in-house Pastoral Care Committee.

Dr. Kujawa, who is a native of Wisconsin, holds doctorate degrees from both Boston College and Columbia University. Her most recent book, "Disorganized Religion: The Evangelization of Youth and Young Adults", was published this year by Cowley Publications.

### Anti-Racism Committee to hold workshops

Responding to the National Church's call for serious dialogue on racism, the Anti-Racism Committee of the Diocese of Hawai'i is planning a series of workshops using model for dialogue written for the Episcopal Church.

The first workshop will be "Appreciating Diversity", and will be held at the St. Andrew's Priory School on October 10, 1998 from 9.00a.m. to 1.00p.m. The history and contribu-

tions of different races, ethnic groups and cultures of society will be explored.

The second workshop, "Prejudice Reduction", will be held on January 18, 1999, and will examine the nature of prejudice and stereotyping, as well as the consequences of behaviour. Church members are encouraged to attend. For further information call Cecelia Fordham at 808-599-8628.

## BISHOP'S LETTER

Dear Sisters and Brothers in Christ,

It is Sunday, August 9. I write this as Dee and I fly from London Heathrow Airport to Los Angeles, on a ten hour flight. We are somewhere over the Atlantic Ocean between England and Iceland. I will send the article by Internet to Donor Macneice, in order to meet the publication deadline for The Chronicle. The 1998 Lambeth Conference concluded yesterday with a Eucharist celebrated according to the Rite of The Anglican Church of Australia, an English style barbeque, and a fireworks display. It has been three long and intensive weeks. We have been blessed by our time at Lambeth and want to personally share the richness of our experiences with you as we travel around our diocese after our return to Hawaii.

Undoubtedly, many of you followed the events of the Conference on the Internet. A majority of people were informed of the Lambeth Conference only through brief articles or television clips on sensational issues of the agenda. I believe that the real rich-

ness of the Lambeth Conference was hardly reported by the media beyond the campus boundaries of the University of Kent, Canterbury. For us the Lambeth experience was more than the issues of human sexuality and international debt.

For both of us the essence of the Lambeth Conference was the incarnation of the Anglican Communion. We pray The Anglican Cycle of Prayer. We read about the church in Sudan, in Brazil, in Australia, and other countries around the world. At Lambeth the Anglican Communion was more than peoples' names and places on a world map. The Communion became flesh and blood, real people. In worship, Bible study, meals, standing in lines, riding buses, and even walking the campus of the University of Kent, Dee and I came to know the very real richness of our Communion. We hope to share the experiences with our diocese, so that you can understand how Lambeth was another significant life-changing experience for us.

A copy of the 1999-2000 edition of The Anglican Cycle of Prayer was printed after each bishop submitted their prayer request in the early days of the Conference. On May 1 the Anglican Communion will pray for our diocese and read "He Lanakila Ma Ke Kea". After this Lambeth experience, Dee and I will recall the people of our Communion and see them in prayer. Likewise, we will remember their faces when we pray for them. The Anglican Communion has truly become incarnate for us.

## THE 25TH ANNIVERSARY OF EAM

The Episcopal Asiamerica Ministry (EAM) celebrated its 25th anniversary at the 1998 National Consultation in New York on June 22-27, 1998. EAM was established by the General Convention of 1973 at the national level to assist the development of Asian and Pacific Island ministries in partnership with dioceses. A community of one in the Spirit with thanksgiving prevailed throughout the Consultation reflecting growth from its days of infancy as the Episcopal Asiamerica Strategic Task Force (EAST) to young adulthood after 25 years.

The Rev. Dr. Winston Ching has served as the Executive Officer of EAM for 25 years. He is the son of Mrs. Ellen Ching of St. Peter's. Gretchen Jong, another member of St. Peter's, is Assistant Convenor of

the Women's Convocation and served as a co-presenter of the "Discerning Spiritual Gifts" workshop.

Primates from the Anglican Church of Korea and Nippon Sei Ko Kai and the Primate-Elect of the Pro-vince of Macao (The Rt. Rev. Peter Kwong) were present. Twelve bishops from Asia and the New York area and Virginia also participated.

Among highlights of the consultation would be the visitation to The Episcopal Church Center; the week-day Eucharists celebrated by bishops in the dioceses of Newark, Long Island, and New York; and the magnificent closing Eucharist in the Cathedral of St. John the Divine, celebrated by the Bishop of New York with ten con-celebrants who are primates or bishops. The Rev. Dr. Winston Ching, Director of Congregational Ministries at the Episcopal Church Center, delivered the sermon.

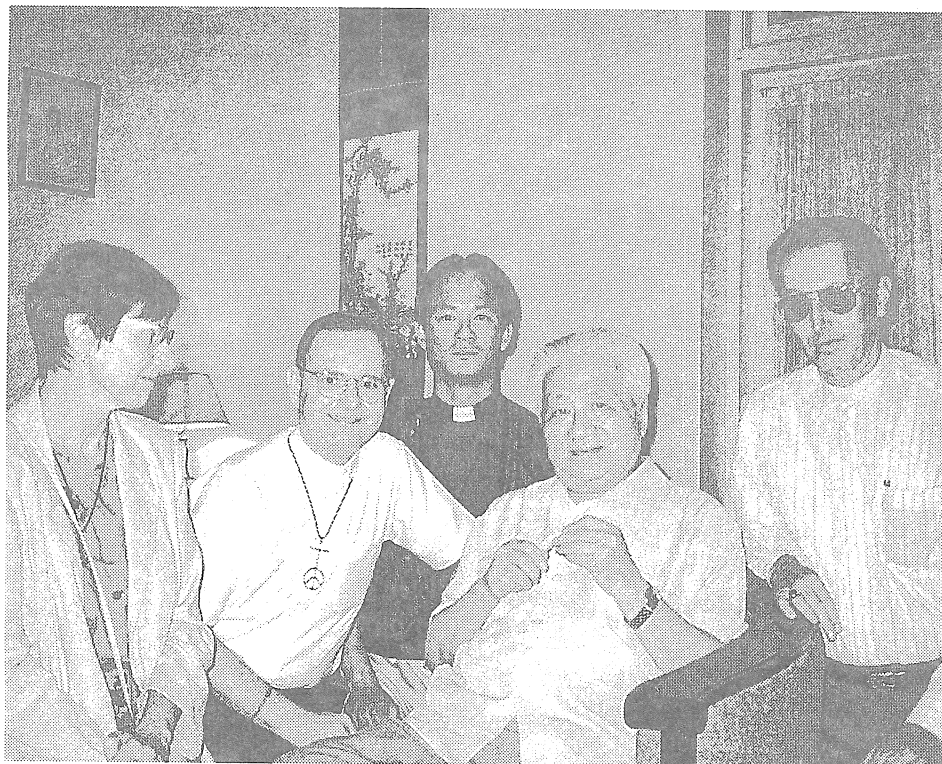
### Episcopal Church Visit to China

In July, the Episcopal Church sent an official delegation of four to Nanjing, China, to open a dialogue with the China Christian Council. Official discussions between the churches had ceased following the Tianenmen Square incident. During this visit the delegation met with Dr. Wescó Han, President of the China Christian Council and the Rev. Bao Jiyang, Secretary General. The subjects of human rights, religious freedom and Tibet were among the many subjects that came up for discussion. It was agreed that the two churches would work closer together on all these issues, as well as work to promoting visits between the churches. During their stay in China, the delegation paid a courtesy call on Bishop K.H. Ting, former President of the China Christian Council, and the only Anglican bishop now in China.

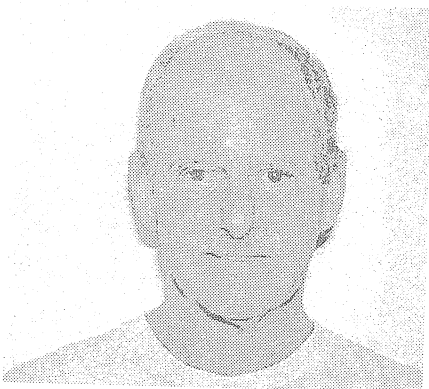
